#### Note 1 – Plan Description

---

The following description of the Gentry Locke Rakes & Moore, LLP Cash or Deferred Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### *General*

The Plan is a defined contribution plan covering all full-time, part-time, and as-needed employees of Gentry Locke Rakes & Moore, LLP and its subsidiary, Gentry Locke Consulting (the “Partnership”), age twenty-one or older. Employees are eligible for elective deferrals on the first day of the month following the date of hire. For purposes of eligibility for Partnership discretionary and employer match contributions, the service requirement is one year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan document was amended effective February 8, 2024, to comply with required legislative and regulatory updates, which are the default provisions under the CARES Act and SECURE 2.0 Act.

##### *Contributions*

Participants may contribute a percentage of their compensation as pretax deferrals and Roth deferrals to the Plan, subject to *Internal Revenue Code (IRC)* limitations. Participants of qualifying age may make additional “catch up” contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Plan includes an automatic enrollment provision. Automatic deferrals begin at 3% pre-tax once reaching eligibility requirements, unless the participant specifies an alternative amount or elects not to contribute to the Plan. This provision only applies to employees whose commencement date or reemployment commencement date is on or following January 1, 2023.

The Partnership matches 50% of the first 2.5% of eligible compensation. Additional amounts may be contributed at the discretion of the Partnership’s Management Committee. For 2024, the Partnership contributed \$1,536,265 in additional discretionary contributions. Participants direct the investment of their contributions, matching, and any discretionary contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

##### *Participant Accounts*

Each participant’s account is credited with the participant’s contribution, allocation of the Partnership’s contributions, and an allocation of earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

##### *Notes from Participants*

Participants may borrow from their accounts an amount greater than \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one year to five years unless the note is for the purchase of a primary residence, in which case the term may exceed five years. Notes are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the Custodians. At December 31, 2024, interest rates ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

#### *Vesting*

Participants are immediately vested in their contributions and the Partnership's matching and discretionary contributions, plus earnings thereon.

#### *Payments of Benefits*

Upon termination of service due to death, disability, or retirement a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account or rollover that amount into a qualified retirement plan or IRA account. In-service distributions are available upon demonstration of financial hardship or after participants reach the age of 55, as defined by the Plan document.

#### *Administrative Costs*

Administrative expenses incurred by the Plan may be paid by either the Plan or the Partnership as provided by the Plan document.

---

## **Note 2 – Significant Accounting Policies**

---

#### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

#### *Interest-Bearing Cash*

The Plan maintains interest-bearing cash. The amount of interest-bearing cash as of December 31, 2024 and 2023, was \$256,823 and \$209,365, respectively. These amounts are included in the self-directed brokerage account and are FDIC insured up to \$250,000 per participant. At times these amounts may have exceeded these limits.

#### *Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Valuation of Investments and Income Recognition*

The Plan's investments are stated at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Notes from Participants*

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

*Benefit Payments*

Benefit payments are recorded when paid.

*Subsequent Events*

Subsequent events have been evaluated through October 6, 2025, the date the financial statements were available to be issued.

**Note 3 – Fair Value Measurements**

---

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

#### *Level 1 Fair Value Measurements*

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end. The self-directed brokerage accounts consist of money market funds, bonds, common stocks, and mutual funds, which are valued at the closing price reported on the active market on which the individual securities are traded.

#### **Note 4 – Investment Contracts**

Participants were able to invest in the Nationwide Fixed Select Contract, which is a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The following represents the total contract value of this investment contract held by the Plan.

With traditional investment contracts, the Plan owns only the contract itself. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers. The average yield for this fund was 2.14% and 2.19% for the years ended December 31, 2024 and 2023, respectively.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but will not fall below zero percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the *IRC* or the failure of the trust to be tax exempt under Section 501(a) of the *IRC*
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Other Plan Sponsor events that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

---

#### Note 5 – Related Party Transactions

---

Certain administrative functions are performed by officers or employees of the Partnership. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan participants may direct their investments into funds issued and managed by the Plan's Custodians. Investments in funds issued by the Custodians are considered related party transactions. Fees paid to the Custodians for investment management and trust services amounted to \$69,341 for the year ended December 31, 2024.

---

#### Note 6 – Plan Termination

---

Although they have not expressed any intent to do so, the Partnership has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA.

---

#### Note 7 – Tax Status

---

The Plan has adopted a non-standardized prototype plan sponsored by Pension Financial Services, Inc. which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, stating the Plan is designed in accordance with applicable sections of the *IRC*. The Plan has been restated since receiving the determination letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC* and therefore believes the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has
