### **Report on the Audit of the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Halozyme Therapeutics, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

### Note 1 – Description of the Plan

The following description of the Halozyme Therapeutics, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General** – The Plan is a 401(k) salary deferral plan covering substantially all employees of Halozyme, Inc. and Antares Pharma, Inc. Herein, Halozyme, Inc., and Antares Pharma, Inc., will be referred to as (the Company). The Company is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Halozyme, Inc. is the Plan's sponsor and serves as Plan administrator.

**Eligibility** – Employees of the Company who are not covered by a collective bargaining agreement for which retirement benefits have been the subject of good faith negotiations or are not non-resident aliens without any U.S. source income, and are at least 21 years of age, are eligible to participate in the Plan.

**Contributions** – Each year, participants may contribute up to the lesser of 90% of eligible compensation, as defined in the Plan, or the statutory limit. The statutory limit for 2024 was \$23,000. Participants age 50 and older (by year end) and meeting one of the Internal Revenue Service (IRS) pre tax contribution limits are eligible to make "catch-up" contributions. The catch-up contribution limit for 2024 was \$7,500. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans. The Company makes matching contributions to the Plan equal to 50% of employee elective deferral contributions up to 100% of eligible compensation deferred to the Plan. Contributions are subject to regulatory limitations.

**Participant accounts** – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, and (b) plan earnings and charged with an allocation of losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants may direct the investment of their account balances into various investment options offered by the Plan.

**Vesting** – Participants are fully vested in their contributions as well as employer contributions, plus earnings thereon.

**Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance of the participant's account and bear fixed, reasonable rates of interest. The interest rate is determined at the time the loan is approved. The maximum loan term is five years unless the loan qualifies as a home loan, in which case 10 years is the maximum term. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, the rate of interest on outstanding loans ranged from 3.25% to 8.50%, with various maturities through December 2033.

**Payment of benefits** – Upon termination of service due to death, disability, or retirement (age 65, or early retirement at age 55 and four years of vesting service), or at attaining age 59½ and still working, a participant may elect to receive a lump-sum amount equal to the value of the participant's account balance, installments based on the life expectancy of the participant or designated beneficiary as an annuity, or a combination of these methods. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Revenue sharing** – The Plan has an agreement with Fidelity Management Trust Company (Fidelity) to fund a revenue credit account in the Plan to the extent that the revenues generated by the Plan exceed annual recordkeeping fees owed to Fidelity. Any revenue credits will be funded to the Plan's revenue credit account on a quarterly basis. Amounts are included in other income in the statement of changes in assets available for benefits.

The revenue credit accounts may only be used either to (1) pay direct, reasonable, and necessary expenses which the Plan is allowed to pay, or (2) allocate to plan participants. Such revenue credits can be allocated to participants' accounts based on the terms of the agreements and at the election of the Company.

**Forfeitures** – The Plan has no forfeitures as employees are fully vested upon becoming eligible to participate in the Plan.

### Note 2 – Summary of Significant Accounting Policies

**Basis of accounting** – The financial statements have been prepared in accordance with generally accepted accounting principles in the United States of America (GAAP) using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – Investments are stated at fair value as certified by the Plan's trustee, Fidelity.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (i.e., the "exit price") in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net depreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

**Contributions** – Contributions from participants and corresponding matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Notes receivable from participants** – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest and are classified as notes receivable.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – Certain administrative plan expenses are paid from the Plan's revenue sharing accounts. All other administrative expenses are paid by the Company. Certain transaction fees are paid out of plan assets.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of assets available for benefits but arose after the statement of assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through September 23, 2025, which is the date the financial statements were available for issuance.

### **Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology that include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Registered investment companies (mutual funds)* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trusts* – Units held in collective trusts (CT) are valued using the net asset value practical expedient (NAV practical expedient) of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities and then divided by the number of units outstanding.

### **Note 4 – Tax Status**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes (ASC 740-10), management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 5 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with the investment securities, that changes in the values of investments in the near term could materially affect a participant's account and the amounts reported in the statements of assets available for benefits.

### **Note 6 – Certified Investment Information**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants reflected on the accompanying statement of changes in assets available for benefits for the year ended December 31, 2024; and
- Investments and notes receivable from participants reflected on the Schedule H, Line 4(i) – Schedule of Assets (held at end of year) as of December 31, 2024.

### **Note 7 – Party-in-Interest Transactions**

Plan investments are managed by Fidelity. Fidelity is the recordkeeper of the Plan, and therefore, transactions with this entity qualify as exempt party-in-interest transactions.

### **Note 8 – Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.
