## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Dealers Warehouse Corporation Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

**NOTE 1 - PLAN DESCRIPTION**

The following description of the Dealers Warehouse Corporation Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan which was adopted on January 1, 1976, to provide retirement benefits for employees of Dealer's Warehouse Corporation and Marvin Concepts, LLC (collectively, the Company). The Plan covers substantially all employees regardless of service or age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Company's Board of Directors is responsible for the oversight of the Plan.

**Contributions** - The Plan is funded by both participant and employer contributions. Participants are permitted to make elective deferrals of eligible compensation up to the maximum amount allowed by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan after an opt-out period, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company may make matching contributions using a discretionary formula. No matching contributions were made in 2024 or 2023. At the discretion of the Board of Directors, the Company may annually make additional profit sharing contributions. The Board of Directors elected to make a discretionary profit sharing contribution of 4.20% and 4.10% of eligible participants' compensation for the years ended December 31, 2024 and 2023, respectively. Employer contributions are made in the subsequent year. Employer contributions are invested as directed by the participant.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of any Company profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit which can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Employer matching contributions and profit sharing contributions plus actual earnings thereon are based on years of continuous service. A participant is 100% vested after six years of credited service.

**Notes Receivable from Participants** - The Plan does not permit participants to borrow from their fund accounts.

**Payment of Benefits** - Upon termination of service due to retirement, death, or disability, a participant (or participant's beneficiary in the event of death) may elect to receive the vested portion of the participant's account. A participant who has attained the Plan's normal retirement age and who has not separated from service may also request a distribution of his or her vested account balance. In addition, hardship distributions are permitted if certain criteria are met. Distributions are made in the form of lump sum payments or installment payments.

**Forfeited Accounts** - Forfeitures are created when participants terminate employment prior to becoming fully vested in the discretionary match and profit sharing contribution portions of their account. Such forfeitures may be used to reduce employer contributions or pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,525 and \$10,471, respectively. Forfeitures of \$21,881 were used to reduce profit sharing contributions in the year 2024.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. See Notes 4 and 5. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by investment advisors and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions** - Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation/ depreciation of fair value of investments.

**Subsequent Events** - The Plan Administrator has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued and has determined that there are no subsequent events that require disclosure.

**NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEES**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained certifications from Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the trustees, that the information in the accompanying financial statements and supplementary schedule, with respect to investments and related investment activity, is complete and accurate as of December 31, 2024 and 2023, and for the year ended December 31, 2024. The investment information certified by the trustees is presented based on their certifications and is summarized below.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### **NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan has a fully benefit-responsive investment contract issued by Empower Annuity Insurance Company of America totaling \$3,144,170 at December 31, 2024 and \$3,034,858 at December 31, 2023. The Empower Investments Fixed Account is a general account product. The fixed interest investment option guarantees principal and a minimum guaranteed interest rate for the life of the contract.

The value of the account is calculated by combining all contributions and deposits to the fixed account option, interest credited to the fixed account, any amounts transferred in and out of the account, and any applicable charges. Interest is credited to the account daily on a portfolio basis. The interest rate credited to the accounts varies based on the contract and is guaranteed by the trustee to exceed 1.00%, but will be no greater than 3.00%. The interest-crediting rate is reset quarterly.

The fixed interest investment meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits, plus accrued interest, less withdrawals. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The Plan's ability to receive amounts due is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (e.g., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreements without the consent of the issuer.

#### **NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, plan participants will become 100% vested in their employer contributions.

#### **NOTE 7 - TAX STATUS**

The Plan Sponsor adopted a non-standardized pre-approved profit sharing plan sponsored by Tennessee Pension Administrators, LLC effective May 31, 2022. Tennessee Pension Administrators received a determination letter dated June 30, 2020 for the restated pre-approved plan. Although the Plan has not applied for its own opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified and that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by Empower, the trustee, and therefore, qualify as party-in-interest transactions (see Note 5). During 2024, the Plan paid \$41,401 of investment management fees to the investment advisor, \$14,918 in administrative fees to the trustee and recordkeeper, and \$20,269 to the third party administrator, which qualify as party-in-interest transactions.

The Plan Sponsor provides the Plan with certain accounting, auditing and administrative services for which no fees are charged to the Plan.
