INDEPENDENT AUDITOR'S REPORT

To the Trustees of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pigott, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1 — PLAN DESCRIPTION

The following brief description of the Pigott, Inc. 401(k) Plan (the Plan) is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers substantially all full-time employees of Pigott, Inc. (the Company) who are age 18 or older. Entry into the Plan occurs on the first day of the calendar quarter following the employee's 90th day of service. In 2023, the Plan was amended to exclude part-time, temporary, or seasonal employees who are regularly scheduled to work less than 1,000 hours during their first 12 months upon being hired. In the event the employee was to exceed 1,000 hours, or their employment status changes to full-time, they would become eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

The Company has contracted with Principal Life Insurance Company and Principal Trust Company (collectively, Principal) to hold the Plan's assets, execute investment transactions, perform allocations of contributions and investment earnings, and make benefit payments.

Contributions

Participants may contribute up to 100% of annual compensation, as defined in the Plan agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically-enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Participants have their deferral rate automatically increased 1% each January 1st, up to 10%, unless changed by the participant. The Company may make discretionary and matching contributions to the Plan. For the years ended December 31, 2024 and 2023, the Company contributed 10% of the first 5% of compensation that a participant contributed to the Plan. Contributions are subject to Internal Revenue Service (IRS) limitations.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and the Company's discretionary and matching contributions, as well as allocations of discretionary contributions and Plan earnings, and charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account balances into various investment options offered by the Plan. Participants may change their investment options daily.

Note Receivable from Participants

The Plan does not allow participants to borrow on their accounts.

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's discretionary and matching contribution to their accounts, plus actual earnings thereon, is based on a rate of 20% for each year of service after one year of service. A participant is 100% vested after six years of credited service. Participants become vested immediately in the Company's contributions and earnings thereon if employed by the Company on the date they qualify for normal retirement (age 65), become totally disabled or die.

Payment of Benefits

On termination of service due to retirement, death, disability or separation from service, a participant may elect to receive benefits in a single lump-sum or in periodic payments over time, if the participant's vested account balance is greater than \$5,000. If the total vested amount which a participant is entitled to receive upon termination is less than \$5,000, the vested balance will be distributed in accordance with the Plan agreement. A participant may also withdraw a portion of his or her vested Plan benefit upon attaining age 59 1/2 while still employed by the Company. In addition, hardship distributions are permitted if certain criteria are met.

Forfeited Accounts

Forfeited nonvested accounts will be used to reduce future Company contributions or to pay Plan expenses. During the year ended December 31, 2024 and 2023, forfeited accounts reduced Plan expenses by \$1,072 and \$2,471, respectively. The Plan had \$5 of unallocated forfeiture balances as of December 31, 2024. As of December 31, 2023, the Plan had no unallocated forfeiture balance.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 2 — SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on an accrual basis, in accordance with accounting principles generally accepted in the United States of America (GAAP).

NOTE 2 — SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in pooled separate accounts and mutual funds are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions

Contributions from the Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain investment-related expenses are included within net appreciation in fair value of investments. Certain expenses related to administration and recordkeeping are paid by the Plan.

NOTE 4 — FAIR VALUE MEASUREMENTS

GAAP establishes a three-tier fair value hierarchy, which categorizes the inputs used in measuring fair value. These categories include (in descending order of priority):

Level 1, defined as unadjusted quoted prices in active markets accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2, defined as quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar instruments in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means; and

Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring an entity to develop its own assumptions.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued based on quoted prices of identical assets in active markets.

- *Pooled separate accounts:* The fair values of units held in pooled separate accounts are valued based on quoted redemption values, also known as net asset value, determined by using available market information and appropriate valuation methods, as provided by the Custodian and represent the value at which the Plan (or the participant) could initiate a transaction with the Custodian. There are no imposed redemption restrictions on participants, except for certain short-term trading restrictions, which prohibit participants from reinvesting into the same account within 30 days.

NOTE 5 — TAX STATUS

The Plan was created from a prototype plan developed by Principal. The IRS has issued an opinion letter, dated June 30, 2020, that the prototype plan is qualified, and the trust established under the Plan is tax-exempt under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the Plan administrator and the Plan's tax counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC under the prototype.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that "more-likely-than-not" would not be sustained upon examination by the IRS. Plan management has not identified any uncertain tax positions.

NOTE 6 — PARTY-IN-INTEREST TRANSACTIONS

During the years ended December 31, 2024 and 2023, the Plan invested in various investments managed by Principal, which qualify as party-in-interest transactions. Fees paid to Principal for administration and recordkeeping were \$10,109 and \$10,780 for the years ending December 31, 2024 and 2023, respectively.
