### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Kliklok Corporation 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### 1. Plan Description

The following description of Kliklok Corporation 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### a. General

The Plan, originally effective January 1, 1991, and restated January 1, 2023, is a defined contribution plan covering all employees of Kliklok Corporation (the Company) who have attained the age of 18, excluding interns and certain classes of employees as set forth in the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### b. Plan Mergers

During June 2024, excess assets totaling \$2,312,230 from the termination of the Kliklok Corporation Employee Retirement Plan (the Kliklok Pension Plan) were transferred into the Plan's unallocated suspense account.

Effective December 31, 2024, the Plan merged into the Syntegon Technology Retirement Savings Plan (the Syntegon Plan). Pursuant to the plan merger, participants in the Plan immediately became participants of the Syntegon Plan, and net assets of \$20,688,659 were transferred into the Syntegon Plan.

Net assets transferred from the Kliklok Pension Plan and to the Syntegon Plan totaled \$18,376,429.

#### c. Contributions

Participants may contribute up to 85 percent of annual compensation in pre-tax or Roth deferrals, as defined in the plan document and allowed by law. Participants may also roll over amounts representing distributions from other qualified plans. The Plan permits catch-up contributions for participants who have attained age 50 by the end of the plan year. The Plan provides for automatic election of deferrals at a rate of 1 percent of compensation for all new participants. Participants may affirmatively elect a different deferral percentage or elect not to defer into the Plan.

The Plan includes provisions under which participants not covered under a collective bargaining agreement (non-union participants) will receive a nonelective contribution of 2.5 percent to 6.5 percent of compensation based on age as of the beginning of each plan year. In addition, non-union participants may receive discretionary matching contributions. Participants covered under a collective bargaining agreement (union participants) receive matching contributions equal to 50 percent of participant deferrals up to 8 percent of compensation. In addition, union participants who, as of December 31, 2017, have either attained age 40 or completed 10 or more years of credited service receive nonelective contributions equal to \$15.50 for each day services are performed for the Company, not to exceed \$77.50 for any week. All other union participants receive nonelective contributions equal to \$9.50 for each day services are performed for the Company, not to exceed \$47.50 for any week.

c. Contributions (Continued)

During 2024, company contributions allocated to participants' accounts totaled \$578,115, of which \$341,652 was contributed by the Company, \$160,334 was allocated from forfeitures, and \$76,129 was allocated from suspense accounts.

d. Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution, if applicable, and the Plan's earnings and losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their accounts into various investment options offered by the Plan.

e. Vesting

Participants are immediately vested in their contributions and balances from prior safe harbor company contributions plus actual earnings thereon. Vesting in other company contribution portions plus actual earnings thereon for participants terminated prior to 2024 is based on years of credited service as follows:

During 2024, following the Company's restructuring that resulted in a significant reduction in workforce, and in connection with the plan merger into the Syntegon Plan as described in Note 1b, the Company resolved to immediately vest company contributions for all affected participants.

f. Distribution of Benefits

Upon termination of employment due to termination of service, death, disability, or retirement, participants may elect to receive the value of their vested account balance in lump-sum or installments. In-service withdrawal options are available to participants under certain circumstances.

g. Forfeited Accounts

At December 31, 2023, forfeited non-vested accounts totaled \$138,197. Forfeited non-vested accounts may be used to reduce future company contributions and pay plan expenses. During 2024, forfeited non-vested accounts were used to pay \$12,045 of plan expenses. As of December 31, 2024, there were no forfeited non-vested accounts as a result of the plan merger discussed in Note 1b.

### h. Notes Receivable from Participants

Participants may borrow the lesser of \$50,000 (reduced by the participant's highest outstanding loan balance during the 12-month period ending on the date of the loan) or 50 percent of their vested account balance. Loan terms range up to five years but may be extended if the proceeds are to be used for the purchase of a primary residence. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, there were no loans held by the Plan as a result of the plan merger discussed in Note 1b.

## 2. Summary of Significant Accounting Policies

### a. Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

### b. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are generally recorded on a trade-date basis. As permitted by Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962-325, *Plan Accounting—Defined Contribution Plans: Investments—Other*, settlement-date basis may be used when (a) the settlement date is after the financial statement date, (b) the fair value of the securities purchased or sold did not change significantly from the trade date to the financial statement date, and (c) the purchases or sales do not significantly affect the composition of the plan's net assets available for benefits.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### d. Payment of Benefits

Benefits are recorded when paid.

e. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. These are referred to as participant loans in the Form 5500 and related supplemental schedules. Delinquent loans are treated as distributions based upon the terms of the plan document.

f. Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Plan expenses include fees for certain participant-initiated transactions that are charged directly to the account of the participant who incurred them. Investment-related expenses are included in net realized and unrealized appreciation in fair value of investments.

g. Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

3. Tax Exempt Status

The Company has adopted a pre-approved plan document that received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, and the plan administrator believes the Plan has been operated in accordance with the applicable provisions of the Internal Revenue Code (IRC). The Company routinely self-reviews the administration of the Plan and self-corrects any compliance issues in accordance with the Employee Plan Compliance Resolution System. Accordingly, the plan administrator believes that the Plan and related trust are designed in accordance with applicable sections of the IRC and, accordingly, are exempt from income taxes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Fair Value Measurement

FASB ASC 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of a different methodology or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2023. As a result of the plan merger discussed in Note 1b, there were no assets held by the Plan as of December 31, 2024.
