1. Description of Plan

The following description of the Strippit, Inc. 401(k) Plan for Salaried Employees (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a salary reduction plan pursuant to Section 401(k) of the Internal Revenue Code, established on August 28, 1998. It covers substantially all non-union employees of Strippit, Inc. (the Company) who meet certain length of service requirements. The Plan is also subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participation

Employees who have completed one calendar quarter of service and are not participants in any other qualified retirement plan pursuant to a collective bargaining agreement shall be entitled to participate in the Plan.

Contributions

The Company shall make qualified pre-tax deferral contributions (elective deferrals) on behalf of each participant who has an executed salary reduction agreement in effect with the Company. The maximum contribution each participant may make each year is subject to federal limits.

Eligible participants may also elect to defer a portion of their total annual eligible compensation into the Plan as elective after-tax Roth contributions. During 2024 and 2023, qualified pre-tax contributions amounted to \$419,535 and \$456,249, respectively. During 2024 and 2023, elective after-tax Roth contributions amounted to \$29,177 and \$61,746, respectively.

Each year, the Company may make discretionary profit sharing contributions on behalf of each participant. Unless otherwise stated by the Company's Board of Directors, a discretionary profit sharing contribution will be made equal to 2% of an employee's eligible compensation for the years ended December 31, 2024 and 2023. During 2024 and 2023, these contributions, net of forfeitures used towards the discretionary profit sharing, amounted to \$119,784 and \$103,872, respectively.

The Company may also decide each plan year to make a matching contribution on behalf of the eligible participants. Matching contributions may vary annually and are determined by the Board of Directors of the Company. Such contributions shall be allocated to the eligible participants who are making deferrals into the plan as follows: for deferrals up to the first 2% of compensation, the Company match is 50%, for deferrals up to the next 6% of compensation, the Company match is 30% and for the next 2% of compensation, the Company match is 10%. During 2024 and 2023, these contributions, net of forfeitures used towards the employer match, amounted to \$103,270 and \$107,873, respectively.

Contributions (Continued)

In addition, participants may transfer funds from other qualified plans with the consent of the Plan administrator via rollover contribution. During 2024 and 2023, participant rollover contributions into the Plan amounted to \$525,000 and \$132,938, respectively. During 2024, there were transfer of assets into this plan totaling \$30,683.

Participant accounts

Each participant shall have an account which will be credited with the participant's contributions, Company contributions, Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances.

Vesting

Participants are immediately 100% vested in their elective deferrals plus earnings thereon. Vesting in the employer matching and discretionary profit sharing contributions is based on years of service.

Vesting on employer matching contributions is determined in accordance with the following schedule:

Notes receivable from participants

The Plan allows participants to borrow funds from their accounts. Loans must be a minimum of \$1,000 and may not exceed the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participants' accounts. Repayments of principal and interest are made through payroll withholding with a term of no greater than five years. Interest on participant loans will be equal to 1% plus the prime rate at the beginning of the monthly period in which the loan withdrawal takes place. At any time, no more than two loans may be outstanding from the Plan to the participant.

Payment of benefits

If the vested portion of a participant's account at termination of employment exceeds \$5,000, the vested portion may be paid as a lump sum distribution or in annual installments. If the vested portion of a participant's account at termination of employment exceeds \$1,000 but not \$5,000, the vested portion is paid as a direct rollover to an individual retirement account.

Forfeitures

Forfeitures arising under the Plan are used at the discretion of the Plan sponsor to reduce future employer contributions. Forfeiture activity during 2024 and 2023 consisted of the following:

2. Summary of Significant Accounting Policies

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) and present the net assets available for plan benefits and changes in those net assets.

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Revenue recognition

Purchases and sales of securities are recorded on the trade date basis. Interest and dividends are recorded on the accrual basis. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Cash and cash equivalents

The Plan considers all highly liquid investments with a maturity of three months or less to be cash equivalents.

Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Cash equivalents and mutual funds: Values are determined based on quoted market prices in active markets.

Common collective trust: Valued at contract value of the underlying investments, which approximates fair value, as reported to the Plan by the custodian, Vanguard Fiduciary Trust Company. Contract value represents contributions made to the fund, plus earnings, less participant withdrawals.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The fair value of these investments is subject to market volatility and may be susceptible to fluctuations.

Payment of benefits

Benefits are recorded when paid.

Income taxes

The Plan evaluates income tax positions for uncertainty to determine any tax positions that may not be fully sustained upon examination by taxing authorities, despite the belief that the underlying tax positions are fully supportable. Tax positions are reviewed on an ongoing basis and are analyzed in light of changing facts and circumstances, including progress of tax audits, developments in case law, and closing of statute of limitations. The Plan administrator has determined that the Plan has no uncertain tax positions. The Plan is no longer subject to examinations by the applicable taxing jurisdictions for periods prior to December 31, 2021.

Plan management's review of subsequent events

The Plan administrator evaluated events occurring between the end of the most recent plan year and October 2, 2025, the date the financial statements were available to be issued.

3. Information Certified by the Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust Company, the custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for plan benefits and the schedule of assets held for investment purposes and the related investment activity reflected in the statements of changes in net assets available for plan benefits.

5. Related Party Transactions

The Plan invests in shares of a common collective trust and mutual funds managed by the trustee, Vanguard Fiduciary Trust Company. Transactions in such investments qualify as party-in-interest transactions which are exempt from prohibited transaction rules. Administrative fees paid to Vanguard Fiduciary Trust Company amounted to \$29,795 and \$29,889 for the years ended December 31, 2024 and 2023, respectively.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Tax Status

The Plan obtained its latest determination letter on February 7, 2017 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan is qualified and is tax-exempt as of the financial statement date.
