Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of The Baron/Essex Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of The Baron/Essex Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 1998; restated on March 1, 2016; and amended effective January 1, 2020. The Plan is available to all employees of Baron Property Services, LLC; Baron Development; Essex Financial Group, LLC; Essex Financial Services, LLC; Essex Financial, LLC; Mountain West Management; Baron Management Services Inc.; or Essex Management Services Inc. age 21 years or older who have completed three months of service. The Plan excludes any individual who is a union employee, nonresident alien, leased employee, resident of Puerto Rico, or temporary or seasonal employee. The entry date for eligible participants is the first day of the quarter following obtaining eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective January 1, 2022, the Plan was restated and amended to adopt the hardship distribution provisions of the Bipartisan Budget Act of 2018.

The management of Baron Management Services Inc. (the "Company") administers the Plan. The Standard Insurance Company (The Standard or the "Custodian") serves as custodian and recordkeeper, manages plan assets, and maintains the Plan's records. The Standard offers plan participants a variety of investment options through various pooled separate accounts and a guaranteed interest contract. Individual accounts are invested in the various investment options at the direction of the participants.

Contributions

Participants may make before-tax contributions and Roth contributions up to 100 percent of their annual eligible compensation, as limited by the IRS, which is adjusted annually by the secretary of the Treasury for inflation. This maximum percentage may be reduced by the plan administrator in certain circumstances. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the IRS. The Plan also permits rollover contributions from other qualified retirement plans. Employee contributions to the Plan are made through regular payroll deductions.

Newly eligible participants are automatically enrolled into the Plan with a deferral percentage of 3 percent. Should the participant not change his or her deferral percentage, it will be increased by 1 percent annually, up to 6 percent. Participants automatically enrolled in the Plan may opt out and receive a refund of their deferrals by notifying the Company within 90 days of the first deferral.

The Plan is operating pursuant to the safe harbor provisions of the Internal Revenue Code Section 401(k)(12). The Company's safe harbor matching contributions will equal 100 percent of elective deferrals up to 2 percent of compensation and 50 percent of elective deferrals between 2 percent and 6 percent of eligible compensation, funded each pay period. The Company has the right to designate all or a portion of the matching safe harbor contributions as qualified. To the extent matching contributions are so designated, they are nonforfeitable and may not be withdrawn from the Plan prior to separation from service or attainment of age 59½. Safe harbor contributions totaled \$426,355, net of forfeitures applied, for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited or debited with the participant's contributions and withdrawals, as applicable, and an allocation of the Company's contributions, plan earnings or losses, forfeitures, and plan expenses. Allocations are based upon plan earnings or losses and account balances, as defined by the Plan. The benefit to which a participant is entitled is the vested portion of the participant's account.

December 31, 2024 and 2023

Note 1 - Plan Description (Continued)

Vesting

Participants are 100 percent vested in their voluntary contributions and allocated earnings or losses thereon.

Any employer safe harbor matching contributions and the earnings or losses thereon will fully vest once a participant has completed two years of service. Effective December 31, 2019, Essex Financial Group, LLC 401(k) Profit Sharing Plan merged into the Plan. Any profit-sharing contributions from the merging plan continue to be on a five-year graded vesting schedule.

A participant's account becomes 100 percent vested upon death, attaining normal retirement age (the age of 65) while an employee, retirement due to disability, or termination of the Plan.

Benefit Payments

Upon death, disability, retirement, or termination of service, a participant or his or her beneficiary may receive, at his or her election, within a reasonable period of time, a lump sum, partial payment, or installment payments in the amount equal to the participant's vested account balance.

The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the plan sponsor. The Plan also provides for hardship withdrawals for defined hardship events. Furthermore, the Plan allows for terminated participant vested account balances of \$5,000 or less to be automatically distributed.

Participant Termination and Forfeitures

If at the time of termination of employment the participant is not 100 percent vested, the nonvested portion (forfeitures) of the participant's account shall be placed in a separate account. Forfeitures can be used to pay plan expenses or reduce employer contributions. Forfeitures in the amount of \$12,961 were applied to employer contributions during the year ended December 31, 2024. The balance of this account at December 31, 2024 and 2023 was \$45,419 and \$21,237, respectively, and is included in the guaranteed investment contract on the statement of net assets available for benefits.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive unallocated contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Benefit Payments

Benefits are recorded when paid.

Note 2 - Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investments that, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the financial statements.

Administrative Expenses

Various administrative costs are paid by the Company.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 3, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

The Standard holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by The Standard.

Note 5 - Investment Contracts

The Plan has a benefit-responsive investment contract with The Standard. The Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a quarterly basis for resetting but may not be less than 2 percent. When establishing interest crediting rates for this product, The Standard considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include termination of the contract, spinoffs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. The plan administrator believes that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is not probable. The Standard may terminate the contract with 30 days' advance written notice to the contract owner for reasonable cause, which may result in a market value adjustment or other withdrawal restrictions.

Note 6 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated for any reason, all participants become 100 percent vested, and the plan administrator is to distribute each participant's interest to the participant or the participant's beneficiary.

Note 8 - Party-in-interest Transactions

Certain plan investments are managed by The Standard. The Standard is the asset custodian, as defined by the Plan; therefore, these transactions qualify as party in interest and are exempt from the prohibited transaction rules.
