We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

DESCRIPTION OF PLAN

The following description of Mesa 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provision.

The Plan appointed committee is responsible for the oversight of the Plan. BOKF, NA (the Trustee) serves as the trustee of the Plan and holds the Plan assets. Trust BOKF, NA also maintains the records of the participant data.

The Plan is a defined contribution plan covering all eligible employees of Mesa Products, Inc. and Bass Corrosion Service, Inc. (the “Companies”) who have completed three months of service. There is no age requirement for eligibility to the plan. Participants auto enroll after three months of service on first day of subsequent month. Participants are auto enrolled at 4% with a subsequent yearly 1% increase each July 1st up to a maximum employee deferral of 8%. Participants can make an affirmative election to a deferral percent of the participant’s choice. The Companies match 50 percent of the first 8 percent of base compensation that a participant contributes to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligible employees may make voluntary contributions through payroll deductions of not less than 1% and up to 100% of compensation on a tax deferred basis pursuant to Internal Revenue Code limitations. The plan allows participants to designate contributions as Roth contributions. The plan also allows rollover contributions from other plans. These employee contributions in any calendar year may not exceed a prescribed dollar amount that is increased from year to year for cost-of-living changes. The employee voluntary contributions are matched by the Companies in an amount determined by the Companies for each plan year. In addition, the Companies provide accounting services to the Plan without charge and absorb some of the Plan’s expenses.

Each participant’s account is credited with the participant’s 401(k) contributions and are allocated the Companies contributions and plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

DESCRIPTION OF PLAN CONTINUED

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in Employer contributions is based upon years of continuous service as follows:

Upon enrollment in the Plan, participants may direct their contributions among the various investment options that are identified in the statement of assets available for plan benefits. Participants may change their investment options at any time.

ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

INVESTMENTS

The plan assets administered by Bank of Oklahoma, N.A. (“BOK”) are part of a separate account established by BOK. This separate account has varying investment divisions that invest in shares of diversified, open-end management investment companies.

The plan represents in the statement of changes in net assets available for plan benefits the net appreciation (depreciation) in the fair value of its security investments. This net appreciation (depreciation) consists of the realized gains and losses and the unrealized appreciation (depreciation) on those investments.

PARTICIPANT LOANS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through semi-weekly payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reported as distributions.

FORFEITED ACCOUNTS

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$0, respectively. These accounts will be used to reduce future employer contributions. Also, in 2024 and 2023, employer contributions were reduced by \$103,595 and \$64,960 from forfeited, non-vested accounts, respectively.

RECOGNITION OF REVENUE

Employer contributions are accrued in the year in which the contributions are determined to be payable. Interest income is recorded when earned. Dividend income is recorded at the ex-dividend date.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES

Administrative expenses of the Plan, including accounting fees, have been paid by the Companies. Certain expenses that are paid directly by the Companies are excluded from the financial statements and no reimbursement is expected. Other expenses related to general administration or investment related expenses are included in the statement of changes in net assets available for plan benefits. No officer or employee of the company receives compensation from the plan.

NOTE 1 - INFORMATION CERTIFIED BY PLAN'S TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by BOKF, NA. (the trustee of the Plan).

NOTE 2 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain administrative expenses were paid by the Plan Sponsor on behalf of the Plan for the years ended December 31, 2024 and 2023, respectively. The Plan Sponsor does not expect reimbursement from the Plan for payment of these expenses. Certain administrative services are performed by officers and employees of the Plan Sponsor. No officer or employee receives compensation from the Plan for these services.

The Plan holds note receivables from participants. These transactions qualify as party-in-interest transactions.

NOTE 3 - PLAN TERMINATION

Although the Companies have not expressed any intent to do so, the Companies have the right under the plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

NOTE 4 - TAX STATUS

The trust established under the Plan to hold the Plan's assets qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net investment income is exempt from federal income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service and the Plan sponsor believes that the Plan continues to qualify and to operate as designed.

NOTE 5 – ACCOUNTING FOR UNCERTAINTY IN INCOME TAXES

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 - FAIR VALUE MEASUREMENTS

Accounting Standards Codification Topic 820, Fair Value Measurements (ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

 - If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: Valued based on the NAV of units of the common collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
