**Note 1 – Description of Plan**

The following description of the Framestore Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution retirement plan established on January 1, 2011 and subsequently amended and restated. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All employees of Framestore, Inc. (the “Organization”) over the age of 21 who have completed 30 days of service are eligible to participate in the Plan. The Plan Administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

Upon eligibility, participants may make pre-tax and Roth contributions to the Plan, subject to certain limitations in the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Organization may make matching contributions equal to a discretionary amount for eligible employees. The Organization did not make any employer contributions in 2024.

Investment options

Each participant may direct their investment account into certain available investment options. The assets of the Plan are allocated to the applicable funds at the direction of the participants.

Participant accounts

Each participant’s account is credited with the (a) participant’s contribution, (b) allocations of the Organization’s discretionary matching contributions, if any, and (c) Plan earnings net of an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization’s discretionary matching contributions portion of their accounts plus actual earnings thereon is based on the number of years of continuous service by the participant. A participant is 100 percent vested after six years of credited service, based on the vesting schedule outlined in the Plan document.

**Note 1 – Description of Plan (continued)**

Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures may be used to reduce future employer contributions or pay administrative expenses.

Notes receivable from participants

Under the terms of the Plan, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lower of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates equal to the prime rate plus 1%. Principal and interest is paid ratably through payroll deductions or payment by check over no longer than a five-year period. The five-year period may be extended to a longer term if the participant is borrowing to purchase a principal residence. Participants are limited to two outstanding loans at a time.

Payment of benefits

On termination of service due to death, disability, retirement, or separation from service, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or periodic payments as further outlined in the Plan document. Participants may also elect in-service withdrawals of their elective deferral account balances in the case of a hardship. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution. Required minimum distributions for participants also apply per Internal Revenue Service regulations.

Plan termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions and terminate the Plan at any time, subject to the provisions of ERISA. Should there be a partial or full termination of the Plan, participants become 100% vested in their accounts.

**Note 2 – Summary of significant accounting policies**

Basis of accounting

The Plan's financial statements are prepared using the accrual basis of accounting, except for benefits which are recorded when paid.

Investment valuations and income recognition

The Plan's investments are reported at fair value except for the stable value fund which is valued at contract value.

Realized and unrealized gains (losses) and interest and dividend income from the assets in each account are credited to or charged against each participant's account. Purchases and sales of securities are recorded on a trade date basis.

Management fees and operating expenses charged to the Plan for investments are deducted from individual investments and are not reflected separately. Consequently, management fees and operating expenses are reflected as a reduction of return for such investments.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses.

Certain administrative functions are performed by employees of the Organization. No such employee receives compensation from the Plan.

Risks and uncertainties

The Plan's investments are exposed to various risks such as interest rate, market, credit and liquidity risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits as of December 31, 2024. The Plan's investments are not insured or protected by the Pension Benefit Guaranty Corporation, or any other governmental agency, accordingly, the Plan is subject to the normal investment risks. Any defaults on notes receivable from participants are treated as taxable distributions to the participants.

Contributions

Contributions from participants are recorded as they are withheld from the participants' wages.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements. Actual results could differ from these estimates.

Payment of benefits

Benefit payments to participants or their beneficiaries are recorded when paid.

Subsequent events

The Plan has evaluated events and transactions for potential recognition or disclosure through September 18, 2025, which is the date the financial statements were available to be issued.

**Note 3 – Investments, at fair value**

Fair value measurements

For assets measured at fair value on a recurring basis, accounting standards require quantitative disclosures about the fair value measurement separately for each major class of assets. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy under this standard are as follows:

- Level 1 – Unadjusted quoted prices in active markets for identical assets.
- Level 2 – Quoted prices for identical assets in markets that are not active, quoted prices for similar assets in active markets, inputs other than quoted market prices, and inputs derived principally from observable market data.
- Level 3 – Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

Fair value measurements (continued)

The Plan's investments in pooled separate accounts are reported at fair value. The pooled separate accounts have been measured at net asset value per share (or its equivalent) and have not been classified in the fair value hierarchy. The fair value of the pooled separate accounts as of December 31, 2024 and December 31, 2023 is \$9,195,110 and \$7,204,220, respectively.

Pooled separate accounts valuation technique

The value of each pooled-separate investment account is determined at the close of each business day based on the fair value of the respective investments. The value of each account is expressed in "units". The "unit value" is the dollar value of one unit and is determined at the close of each business day by dividing the total fair value of each account by the total number of units in the account. The value of each participant's account on any date is determined by multiplying the number of units held by the "unit value" at the close of the business day.

**Note 4 – Investments, at contract value**

The Plan holds a portfolio of investment contracts that comprises a guaranteed stable value fund under a group annuity contract. This investment meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of the guaranteed stable value fund as of December 31, 2024 and December 31, 2023 is \$380,020 and \$254,591, respectively.

**Note 5 – Information certified by the Plan's Custodians**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Lincoln National Life Insurance Company, a Custodian of the Plan, has certified the completeness and accuracy of all investments reflected on the accompanying statement of net assets available for benefits as of December 31, 2023. Lincoln Life and Annuity Company of New York, a Custodian of the Plan, has certified to the completeness and accuracy of all investments reflected on the on the accompanying statement of net assets available for benefits as of December 31, 2024, and the supplemental schedule, Schedule H - Part IV - Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**Note 6 – Party-in-interest transactions**

Plan investments include funds managed by the Custodians as defined by the Plan, and, therefore, those transactions qualify as party-in-interest.

Custodial, advisory and other similar type fees related to the administration of the Plan were paid by the Plan or by the Organization. These transactions also qualify as party-in-interest transactions.

**Note 7 – Tax status**

The Internal Revenue Service has determined and informed the Plan in a letter dated June 30, 2020 that the Plan is designed, in accordance with applicable sections of the Internal Revenue Code (the “Code”). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified.
