Opinion

Note 1 – Plan Description

The following description of the ComSonics, Inc. (the “Company”) Employee Stock Ownership Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Company established the Plan effective July 31, 1975. The Plan operates as a stock ownership plan (ESOP), is designed to comply with Section 4975(e)(7) and the regulations thereunder of the *Internal Revenue Code* of 1986, as amended (*IRC*), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 as amended (ERISA). The Plan is administered by the Plan Administrative Committee, comprised of at least two individuals appointed by the Company’s Board of Directors.

The Plan is a stock bonus plan which covers all employees who have one year of service to the Company (a minimum of 1,000 hours is required to become a Plan participant) and have attained the age of 21 by the end of the Plan year. Plan provisions relating to vesting, allocation of contributions, earnings, and forfeitures are included in the summary plan description.

Plan benefits for each participant are segregated between ComSonics, Inc. stock and cash (including equivalent cash investments). The related income attributable to such investments is also segregated by the source generating the income.

Effective January 1, 2023, each eligible employee of ComSonics of Massachusetts became a participant in the Plan, recognizing all prior service for purposes of eligibility, vesting, and allocation of employer contributions as per plan amendment.

Contributions

The Company’s contributions are determined annually by the Board of Directors of the Company and shall not exceed amounts allowable under *IRC*. Company contributions may be made in cash or in shares of Company stock.

Participant Accounts

Upon the annual adjustment date, the account of a participant who is employed on the last day of the Plan year and completed a year of service during the Plan year, or who retired, died, or became disabled during the Plan year, will be credited with an allocation of Plan earnings, forfeitures, and employer contributions. Employer contributions and forfeited balances of terminated participants’ non-vested accounts are allocated based on the proportion of each participant’s compensation to the total compensation of all participants, as defined in the Plan document. Plan earnings, other than S Corporation dividends, are allocated based on the proportion of each participant’s account balance to the total of all participant account balances, as defined in the Plan document. S Corporation dividends are allocated to participants based on the proportion of the number of Company shares owned by the participant to the total number of Company shares outstanding. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Vesting of a participant's account is based on years of service, as defined in the Plan document. A participant is 100% vested upon the completion of six years of service, the attainment of normal or early retirement age, or the occurrence of death or disability while employed by the Company.

Forfeitures

Plan forfeitures are allocated to each participant's account in the same manner as employer contributions. Forfeitures of terminated non-vested account balances of \$97,530 cash and \$57,122 in stock and \$25,743 cash and \$25,739 in stock were reallocated to participants' accounts for the years ended December 31, 2024 and 2023, respectively.

Payment of Benefits

Distributions from the Plan will be made when a participant retires, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representative), or otherwise terminates employment with the Company. In addition, at any time after seven years of credited service, a participant can request a partial liquidation up to 20% of his total capital accumulation, in an amount no less than \$1,000 and not to exceed the dollar value of the shares of the Company Stock in his account, as defined by the Plan. Retirement, termination, and death distributions are made in lump-sum payments, unless the participant's balance is greater than \$25,000, in which the balance is paid out in installments. Unless otherwise directed, for terminated participants whose vested balance is between \$1,000 and \$7,000, funds may be rolled into an IRA for the participants' benefit. Balances less than \$1,000 are distributed directly to the participant unless otherwise directed. Distributions are made in shares of stock, which are immediately repurchased from the participant and converted into cash.

Voting Rights

Shares of Company stock in the trust shall be voted by the Trustee, in a manner as shall be directed by the Plan Administrative Committee. Participants are entitled to exercise voting rights attributable to the shares allocated to their account in Board of Directors' elections and in certain instances such as a merger, consolidation, and liquidation. Participants are notified by the Trustee prior to the time that such rights are to be exercised. Any allocated Company stock with respect to which voting directions are not received from participants shall be voted in the manner determined by the Plan Administrative Committee.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least ten years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares of Company Stock allocated to their account since inception of the Plan, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a stock distribution, which is immediately converted into cash.

Administrative Costs

Plan administrative expenses are paid by the Company.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. Changes in the fair value of investments are included in the net appreciation of the fair value of investments. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Benefit Payments

Benefit payments are recorded when paid.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities. The significant unobservable inputs used to measure fair value include the Company's projected cash flows, cost of equity and debt, determination of appropriate capital structure, weighted average cost of capital, long-term growth rate, and discounts for lack of marketability of the stock. Significant changes to these inputs could have resulted in a significantly higher or lower fair value measurement for the Company common stock. The following table provides further details of this Level 3 fair value measurement:

The Plan's policy is to recognize transfers into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no significant transfers into or out of Level 3.

Note 4 – Investment

The Plan invests primarily in the stock of the Company. As of December 31, 2024, the Plan owned a total of 198,658 shares of ComSonics, Inc. stock with a fair value as determined by an independent appraisal of \$187.37 per share. As of December 31, 2023, the Plan owned a total of 210,404 shares of ComSonics, Inc. stock with a fair value as determined by an independent appraisal of \$212.12 per share. The cost basis of the ComSonics, Inc. stock was \$32,801,925 and \$33,308,217 at December 31, 2024 and 2023, respectively.

Note 5 – Related Party Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Note 6 – Plan Termination

Although it has expressed no intention to do so, the Company reserves the right to discontinue the Plan at any time, subject to the Plan provisions. Upon termination of the Plan, the participants shall become fully vested in the balance in their accounts and the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time as prescribed by the Plan terms and the *IRC*. Upon termination of the Plan, the Plan Administrative Committee shall direct the Trustee to pay all liabilities and expenses of the trust.

Note 7 – Income Tax Status

The Plan obtained its latest determination letter on April 18, 2013, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the *IRC*. The Plan has been amended since receiving the opinion letter; however, the Plan Sponsor and Administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 8 – Subsequent Events

Evaluation of subsequent events was considered through October 8, 2025, the date the financial statements were available to be issued.
