Notes to Financial Statements

Note 1. Description of the Plan

The following brief description of the Architectural Division 8 Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information.

General

The Plan has an initial effective date of January 1, 2017, and is a defined contribution retirement plan for employees of Architectural Division 8, Inc. (the Company) and its wholly owned subsidiaries, as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During the year ended December 31, 2017, employees of the Company became eligible to participate and enrolled in the Plan if they were age eighteen or older and at the later of the Plan's effective date of January 1, 2017, or completion of one hour of service. Effective January 1, 2018, employees of the Company became eligible to participate in the Plan if they are age eighteen or older and have completed one year of service. Furthermore, eligible employees will be enrolled in the Plan at the start of the quarter after they become eligible.

Effective October 1, 2024, the Company was repurchased at a price of \$11,500,000 and the Plan was liquidated.

Contributions

Basic non-elective employer contributions are granted at the discretion of the Board of Directors of Architectural Division 8, Inc. (the Board) in an amount not to be less than the annual payment required by the note payable plus accrued interest. A participant's share of the basic, non-elective contribution for a Plan year is calculated based on a percentage of the participant's compensation for the year. Contributions can be made in cash or Company common stock. Contributions are vested in the Company's common stock.

Voting Rights

The Plan's trustee exercises voting rights on all shares held in the Plan's trust, except that each participant would be entitled to exercise voting rights attributable to the shares allocated to his or her account with respect to major corporate events, as defined in the Plan Agreement. For any allocated securities for which it has not received direction from a participant (or beneficiary), the Plan's trustee shall vote. Additionally, the trustee shall vote all unallocated employer securities.

Participant Accounts

A separate account is maintained for each participant. A participant's account balance is adjusted annually for a pro rata share of the employer contributions and forfeitures which are determined based on a percentage of compensation (subject to Internal Revenue Service limitation). The Company may, in addition to its contributions to the Plan, pay cash or other property to the Plan in the form of dividends. These dividends may first be used to repay any outstanding indebtedness. Earnings and expenses from the Plan including employer dividends that are not used to reduce debt and appreciation (depreciation) on Plan assets are allocated to individual participants generally based on each participant's account at the end of the year.

Vesting

Vesting in the Company's contribution is based on years of continuous service. One year of service is credited for each calendar year during which a participant completes 1,000 hours of service. A participant will become vested as follows:

Payment of Benefits

Upon termination of employment, a participant has a nonforfeitable right to his/her account to the extent he/she is vested. Individual account balances may be partially or entirely forfeited by an employee if his/her employment is terminated prior to becoming fully vested in the Plan.

Forfeitures are allocated to the account of each individual who was a participant at any time during the Plan year. There were no forfeited shares allocated to participants as of December 31, 2024 and 2023. There were no unallocated forfeitures as of December 31, 2024 and 2023.

If the participant is vested and his/her account balance is \$1,000 or less, or his/her account balance is \$5,000 or less and he/she elects payment, his/her account will be distributed in a lump-sum payment by the end of the Plan year following the Plan year in which he/she terminates employment. Should the participant not elect a payment the vested account balance will be rolled into an individual retirement account on behalf of the participant.

If the participant's vested account balance is more than \$5,000, the time and form of distribution varies, depending on the circumstances. The participant or beneficiary may elect to have his/her account distributed in a lump sum, rollover to an eligible retirement plan, or as annual installments not to exceed 5 years (plus 1 year for each \$250,000) no later than 60 days after the end of the Plan year in which the latest of the following occurs: the participant's attainment of age 65, the tenth anniversary of the participant's participation in the Plan, the participant's termination of employment, or the participant's death.

The Plan provides that distributions be paid in cash or other property and be recorded in the year of distribution.

Diversification

Diversification is offered to participants so that they may have the opportunity to move part of the value of their investment in Company stock. Diversification is offered to each eligible participant over a six year period. In each of the first five years, a participant may diversify up to 25% of the Company shares that were allocated to his or her account on or before the most recent Plan allocation date, less any shares previously diversified, as long as such Company shares equals or exceeds \$500. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a transfer of the applicable portion of his or her account balance to another qualified plan of the Company.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash and Cash Equivalents

The Plan considers all highly liquid investments with a maturity of three months or less when purchased to be cash equivalents.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated) and (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment Valuation and Income Recognition

The shares of Company stock are reported at fair value. See Note 4 for discussion of fair value measurements. Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Management's Review of Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

Note 3. Investments

Principal Life Insurance Company (the Trustee) holds the Plan's investments and executes all investment transactions. All investments are non-participant directed.

Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Acquisition by the Plan

On October 31, 2017, as part of a single integrated transaction, all shares of outstanding common stock of the Company were redeemed by the Company, and the Plan Trust purchased all of the common stock of the Company through issuance of debt with the Company. As a result of the transaction, the Plan owns 100% of the issued and outstanding voting stock of the Company and the Company has debt in aggregate of approximately \$0 and \$2,188,000 at December 31, 2024 and 2023, respectively, to previous stockholders.

Note 6. Income Tax Status

The Plan has never obtained a determination letter ruling on the tax qualification of the Plan from the Internal Revenue Service (IRS) due to the formation of the Plan taking place in 2017. Plan management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Related Party Transactions and Party in Interest Transactions

Certain Plan investments are held by Principal Life Insurance Company, who is the custodian and recordkeeper as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. The Plan's investment in Company common stock and note payable to the Company also qualifies as party-in-interest transactions. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA.

Note 8. Risks and Uncertainties

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 9. Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Company directs the Trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.
