Opinion

We have audited the accompanying financial statements of the Redwood Empire Electrical Workers Individually Allocated Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The Redwood Empire Electrical Workers Individually Allocated Pension Plan (the "Plan") was established on July 1, 1976, as provided by a collective bargaining agreement between the International Brotherhood of Electrical Workers Local 551 (the "Union") and employer associations and individual employers signatory to the agreement.

The Plan is a defined contribution multiemployer pension plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Employer Contributions

Employer contributions as reported are contributions made by employers on behalf of employees for hours worked during the year. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year.

D. Employer Payroll Compliance Program

Remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' payroll records under a separate payroll compliance program.

E. Tax-Exempt Status

The Plan received its latest notice of tax-exempt status on March 11, 2016. The Plan administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for federal or state income tax is made.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

F. Participant Accounts

Each participant's account is credited with employer contributions and an allocation of earnings or losses and expenses. Participants direct the investment of their accounts among a diversified menu of mutual funds, collective investment trusts, a common/collective trust and a stable value fund offered under the Plan.

Participants may also make rollover contributions of amounts received from other tax-qualified retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction.

G. Notes Receivable from Participants

The Plan allows participants to apply to the Board of Trustees for a loan from their individual account for not less than \$1,000 and not to exceed the lesser of \$50,000 or one half of the participant's vested account balance. A loan is secured by a participant's vested account balance, bears interest at the prime rate plus 1% and must be repaid to the Plan within five years from the date of taking the loan, or fifteen years if for the purchase of a principal residence. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50%.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based on terms of the Plan Document.

A note will be in default if any required payment is more than one calendar quarter delinquent.

H. Risks and Uncertainties

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risk. Some estimated values may differ from values that would have been used had a ready market existed for the investment. Due to the level of risk associated with investments and the level of uncertainty with respect to the changes in the value of investments, it is reasonably possible that changes in risks in the near term would materially affect the amounts reported in the financial statements.

I. Vesting

Participants are immediately 100% vested in their entire account balance.

J. Payment of Benefits

Participants are entitled to a distribution of their individual account upon normal or early retirement, or as a result of permanent and total disability. In the event that a participant dies before retirement, their accumulated share shall be paid to their surviving spouse or beneficiary.

NOTE 3 - FUNDING POLICY

The Board of Trustees has established a funding policy and method in order to promote the purpose of the Plan and to ensure compliance with ERISA. Each employer contributes to the Plan such amounts and at such times as required by the applicable provisions of the collective bargaining agreements, or such other agreements as approved by the Board of Trustees. Employer contributions are based on hourly contribution rates and are made on a monthly basis. The annual contributions for the year satisfied the minimum funding requirements of ERISA.

NOTE 4 - INVESTMENT VALUATION AND INCOME RECOGNITION

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023. The Plan did not have any transfers into or out of Levels 1, 2 or 3 for the year ended December 31, 2024. Mutual funds are valued at fair value based on quoted market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The investment strategy for the investments valued at net asset value are as follows:

IBEW-NECA Equity Index Fund ("Fund") is a common/collective trust for qualifying employee benefits plans. The objective of the Fund is to, as nearly practical, replicate the performance of the S&P 500 index.

The Vanguard Target Retirement Funds ("Funds") are collective investment funds for qualifying employee benefit plans. The Funds use an asset allocation strategy designed for investors planning to retire at the target date. The Funds seek to provide growth of capital and current income consistent with their current target allocation by investment in a gradually more conservative mix of investments as the target date nears.

Realized and unrealized gains and losses are computed using investments' cost for financial statement purposes. For Form 5500 reporting, realized and unrealized gains and losses are computed using investments' fair values as of the beginning of the year.

NOTE 5 - STABLE VALUE FUND

The MassMutual Stable Value Diversified Fund ("Fund") is a market value separate account investment option with a general investment account guarantee that provides a stated rate of return and insulates participant activity from daily fluctuations in the market. The Fund is recorded at contract value, which approximates fair value, and represents contributions plus credited interest less participant withdrawals and fees. The Funds' rate of return for the Plan's investment in 2024 and 2023 was 3.14% and 3.58%, respectively.

NOTE 6 - PLAN TERMINATION

Although there has been no expressed intent to do so, the Plan may be terminated in accordance with the provisions of ERISA (as amended) and related regulations. Upon termination each participant and any beneficiary currently entitled to benefits shall receive a nonforfeitable right to the separate account maintained on their behalf.

NOTE 7 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan shares common expenses including salaries, benefits, facilities, general administrative expenses and professional fees with the Redwood Empire Electrical Workers Health and Welfare Trust Fund (the "Health and Welfare Trust"), a related party. The Health and Welfare Trust pays facilities, salaries, and benefit expenses and the Plan reimburses the Health and Welfare Trust 25% of these costs based on an allocation method periodically approved by the Board of Trustees. Certain professional fees and various general administrative expenses are split evenly between the Plan and the Health and Welfare Trust.

The Plan and the Health and Welfare Trust entered into a lease agreement for office space with IBEW Local 551 Building Corporation (the Corporation) commencing August 1, 2021 and ending July 31, 2022 for \$1,620 per month. Effective August 1, 2022, the lease is month to month. The Plan paid \$4,860 in rent expense to the Corporation during the years ended December 31, 2024 and 2023.

During the years ended December 31, 2024 and 2023, the Plan paid \$2,160 and \$4,584 respectively, to two trustees as lost wage reimbursements for attending the board meetings.

NOTE 8 - ADMINISTRATION

Each month an administrative fee is deducted from each participant account and transferred to the Plan to pay for operating expenses. During 2024 and 2023, the monthly administrative fee was \$22.50. The total amount deducted from participants accounts and transferred to the Plan during the years ended December 31, 2024 and 2023 was \$263,073 and \$266,326, respectively.
