- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about First Coast Security Services, Inc. 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

A. Description of Plan:

The following description of the First Coast Security Services, Inc. 401(k) Plan (the "Plan") f/n/a FCS Employee Investment Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan was established to provide retirement benefits for employees of First Coast Security Services, Inc.(the "Company" or "Employer"), excluding government contracted employees. Eligible employees become participants in the Plan following three months of service and attainment of age 18, as defined in the Plan agreement. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Participants may make pre-tax and after-tax contributions to the Plan based on annual compensation and IRS limits. Participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans. Effective April 15, 2024 the Plan was amended to discontinue the auto-enrollment provision. The Company may make discretionary matching and profit-sharing contributions for eligible employees. There were no employer matching or profit-sharing contributions made for the years ending December 31, 2024 and 2023.

Participants direct the investment of their contributions into the various investment options offered by the Plan. Total contributions, both participant and employer, including discretionary, are subject to the limits of the Internal Revenue Code (the "IRC") Section 415(c). Participant contributions and employer matching contributions of certain highly compensated participants may also be limited based on contribution nondiscrimination tests described in IRC Section 401(k) and 401(m).

Participant Accounts:

Each participant's account is credited with the participant's contribution, the Employer's contribution, and an allocation of the Plan's earnings and administrative expenses. The Plan's earnings are allocated according to participants' relative account balances.

Notes Receivable from Participants:

Participants may borrow from their fund accounts a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. Participants may have up to two loans outstanding at any one time.

Vesting:

Participants are immediately vested in their pre-tax and rollover contributions plus actual earnings thereon. That portion of the participants' account that is attributable to employer contributions vests ratably over six years of service. Participants' accounts become fully vested upon attainment of the normal retirement age, early retirement age, upon retirement due to disability, upon death and upon termination of the Plan.

A. Description of Plan (continued):

Vesting (continued):

Amounts forfeited by terminating participants may be used to reduce Employer contributions or pay Plan expenses. Any remaining forfeitures will be added to any employer discretionary matching contributions. Forfeited non-vested accounts were \$-0- for the years ended December 31, 2024 and 2023, respectively. During 2024, \$-0- of forfeitures were used for either purpose.

Payment of Benefits:

Amounts credited to an individual participant's account are distributed at termination of employment as a lump sum, in installments or as an annuity. The full value of an employee's account balance is payable at their normal retirement age, even if the employee continues to work, or the employee may defer payment until April 1 of the calendar year following the later of attainment of age 72 or retirement. There are no amounts allocated to withdrawing participants as of December 31, 2024 and 2023. In certain hardship situations, as described in the Plan agreement, participants may withdraw part of their account balances while actively employed, but such withdrawals are limited to the amount dictated by the hardship.

B. Summary of Accounting Policies:

Basis of Accounting:

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition:

Investments in pooled separate accounts are valued, as a practical expedient, at the net asset value of units held by the Plan at year end. The net asset value of these accounts is based on the market value of the underlying investments. The net asset value is not a publicly-quoted price in an active market.

These pooled separate account investments utilize various investment strategies; they do not have any unfunded commitments and can be redeemed on a daily basis. See Note D. for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits:

Benefits are recorded when paid.

B. Summary of Accounting Policies: (continued)

Notes Receivables from Participants:

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Uses of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Plan Administration Expense:

Recordkeeping, custodial, investment management and audit fees are paid by the Plan, certain other administrative expenses may be paid by the plan sponsor.

Date of Management's Review:

Subsequent events were evaluated through the date of the independent auditor's report which is the date the financial statements were available to be issued.

C. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time. In the event of Plan termination, the respective participant interest, net of any termination fees, will become fully vested.

D. Fair Value Measurements:

FASB ASC topic 820 on *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The hierarchy is measured in three levels based on the reliability of the inputs:

D. Fair Value Measurements (continued):

- Level 1 Valuations based on unadjusted quoted prices in active markets for identical assets that the Plan has the ability to access at the measurement date.
- Level 2 Valuations based on inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly. Observable inputs include quoted prices for similar assets in active or non-active markets.
- Level 3 Valuations derived through the use of valuation models or methodologies using significant unobservable inputs. Level 3 valuations incorporate certain assumptions and projections that are not observable in the market and as a result significant professional judgment may be used in determining the fair values.

E. Investment Contract with Insurance Company:

The Plan has a benefit-responsive guaranteed investment contract with Standard Life Insurance Company (Standard). Standard maintains the contributions in a general account. The account is credited with earnings on underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issue is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

E. Investment Contract with Insurance Company (continued):

Because the guaranteed investment contract is fully benefit- responsive, contract value is the relevant measurement attributed to that portion of the net assets available for benefits attributed to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value.

Contract value, as reported to the Plan by Standard represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment contract.

There are no reserves against contract value for credit risk of the contract or otherwise. The contract value of the investment contract was \$6,808 and \$12,793 at December 31, 2024 and 2023, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Standard. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events that would cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

F. Tax Status:

The Plan has adopted the Non-Standardized Pre-Approved Profit Sharing Plan with CODA. The Internal Revenue Service has determined and informed the provider, by letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained by the relevant taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

G. Information Certified by the Plan's Custodian:

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Transamerica Life Insurance Company, the custodian of the Plan from January 1, 2024 to April 15, 2024 and Ascensus the custodian from April 15, 2024 to December 31, 2024, have certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

H. Risk and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

I. Related Party Transactions:

The Plan held certain investments that were shares of funds managed by Transamerica Life Insurance Company ("Transamerica") Transamerica was the custodian as defined by the Plan and therefore these transactions qualify as party-in-interest transactions. The Plan paid Transamerica \$31,474 for the year ended December 31, 2024 which is included in administrative expenses on the statement of changes in net assets available for benefits.

Effective April 15, 2025 the Plan changed its custodian and recordkeeper to Ascensus, The Plan also holds certain investments that are managed by its subsidiary Vanguard, as such these transactions qualify as party-in-interest transactions. The Plan paid Ascensus/Vanguard \$77,849 for the year ended December 31, 2024 which is included in administrative expenses on the statement of changes in net assets available for benefits. The Plan paid other advisers and service providers a total of \$43,585.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
