The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

### 1. Description Of Plan And Basis Of Presentation

The following description of the JVA, Inc. Employees' Stock Bonus Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a noncontributory, defined contribution plan covering substantially all employees of JVA, Inc. (the Company) who have completed 1 year of service and attained age 21, or if the employee has completed 3 consecutive months of service and has attained age 21, whichever is earlier. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (the Code), as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Periodically, the Plan will purchase shares from the Company through the issuance of a note payable. As the note payable is repaid to the Company, an appropriate percentage of common stock will be collocated to eligible employees' accounts in accordance with the applicable regulations under the Code. The Company has no rights against the shares of common stock once they are allocated to participants in accordance with the terms of the Plan. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024 present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated common stock (allocated) and (b) common stock not yet allocated to employees (unallocated).

Within 60 days after a participant is allocated shares of the Company, the participant has a put option to resell all such shares to the Company at fair market value.

#### Contributions

Contributions to the Plan are made at the discretion of the Board of Directors (the Board) in the form of cash or Company common stock. Contributions may consist of discretionary amounts specified by the Board.

#### **Participant Accounts**

Each participant's account is credited with an allocation of (a) the Company's contributions, (b) Plan earnings and (c) forfeitures of terminated participants' nonvested accounts. Amounts are allocated to each participant's account based upon the ratio of the participant's compensation to aggregate compensation of all participants for the Plan year.

#### **Vesting**

Participants' balances vest at the rate of 20% for each year of vesting service in the Plan beginning after two years, with 100% vesting at the end of six years of vesting service.

#### **Forfeitures**

Forfeited amounts of Company discretionary contributions are reallocated to participants' accounts at the end of the Plan year. Forfeitures of \$3,720 were allocated to participants' accounts during 2024. No forfeitures remained as of December 31, 2024 or 2023.

#### **Payment Of Benefits**

Generally, no distributions from the Plan are paid until a participant retires, dies or otherwise terminates employment with the Company. Distributions are made in cash.

#### **In-Service Withdrawals**

Upon reaching age 59½, a participant may elect to withdrawal all or a portion of their vested account balance.

## **2. Summary Of Significant Accounting Policies**

#### **Basis Of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

#### **Investment Valuation And Income Recognition**

The Plan's investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date.

Net appreciation (depreciation) represents the difference between the aggregate fair value of investments at year end and the values at the beginning of the year and includes any realized gains and losses in securities that were bought and sold during the year.

#### **Contributions Receivable And Credit Loss Policy**

The Plan is required to record an estimate of expected losses on the Plan's company contributions receivable for the remaining estimated life of the asset. This estimate must include consideration of historical experience, current conditions and reasonable and supportable forecasts.

The Company has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

#### **Payment Of Benefits**

Benefit payments are recorded when paid.

#### **Subsequent Events**

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

### 4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets,
- Quoted prices for identical or similar assets or liabilities in inactive markets,
- Inputs other than quoted prices that are observable for the asset or liability and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

#### **Company Common Stock**

The fair value of Company common stock held by the Plan is valued at fair market value based upon an independent appraisal. This appraisal was based upon a combination of the market capitalization and discounted cash flow valuation techniques consistent with prior years.

The valuation process involves the trustee's selection of an independent appraiser (the Appraiser). The Appraiser will make reviews, analyses and inquiries that are deemed necessary and appropriate to express an opinion on the fair market value of the common stock held by the Plan. Among the information obtained by the Appraiser are financial statements, forecasts and projections prepared by Plan management and publicly available financial data for certain companies that are deemed comparable to the Company. The Appraiser prepares a written report which the trustee reviews in detail, discusses with the Appraiser and approves. The results of this process are documented in the minutes of the trustee.

#### Registered Investment Companies

Assets are valued at the daily closing price as reported by the registered investment company. Registered investment companies held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **6. Income Tax Status**

The Plan obtained its latest determination letter on February 27, 2015 in which the Internal Revenue Service (the IRS) stated that the Plan, as designed, met the applicable requirements of the Code. The Plan has been amended since the date of the determination letter. The Plan Administrator believes that the Plan, as amended, is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, the Plan Administrator believes that the Plan, as amended, is qualified, and the related trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

### **7. Related Party And Party In Interest Transactions**

The Plan invests in Company common stock, a related party transaction. The Plan also has agreements with various service providers to provide administrative services to the Plan. These transactions are allowable parties in interest transactions under ERISA.

The Plan entered into a \$191,950 term loan agreement with a shareholder of the Company. The proceeds of the loan were used to purchase Company common stock from shareholders. Unallocated shares are collateral for the loan. The loan bore interest at the Prime Rate (7.5% at December 31, 2024). The borrowing was to be repaid through annual principal payments of \$38,398, plus interest, for five consecutive years, with final payment of all then unpaid principal and interest due in December 2025. For the year ended December 31, 2024, interest expense of \$2,880 is included in administrative expense on the statement of changes in net assets available for benefits. During 2024, the loan was repaid in full.

### **8. Risks And Uncertainties**

The Plan's investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
