**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of IBEW Local Union No. 60 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits - modified cash basis as of December 31, 2024 and 2023 and the related statement of changes in net assets available for plan benefits - modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

The Trustees, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Trustees have obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

**Opinion**

**Basis for Opinion**

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. - Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

### **Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of the Trustees and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion –

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE A      PLAN SUMMARY AND SIGNIFICANT ACCOUNTING POLICIES

Plan Summary – IBEW Local Union No. 60 401(k) Plan (the Plan) is a multi-employer defined contribution retirement plan covering all employees working for employers under the collective bargaining agreement between the South Texas National Electrical Contractors Association and the International Brotherhood of Electrical Workers Local Union No. 60. The Plan was established January 1, 2000. Employers and employees make contributions as described below for the purpose of providing and maintaining retirement benefits. Qualification and eligibility are subject to the determination of the Trustees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Accounting Records – The accounting records of the Plan are maintained on the modified cash basis for financial reporting purposes. Consequently, certain revenues and the related assets are recognized when received rather than when earned and certain expenses and purchases of assets are recognized when cash is disbursed rather than when the obligation is incurred. Purchases and sales of investments are recorded on a trade-date basis. Interest and dividend income are recorded as received. Accordingly, the accompanying financial statements are not intended to present the net assets available for plan benefits and the changes in net assets available for plan benefits in conformity with accounting principles generally accepted in the United States (GAAP). Modification to the cash basis of accounting has been made to adjust investments to fair and contract value.

Employee Contributions – Participants may contribute, in 1% increments, between 3% and 15% of pre-tax compensation as defined by the Plan. These contributions by individual employees were limited to \$23,000 (participants under 50 years of age) and \$30,500 (participants 50 years of age or older) in 2024. This limitation generally is adjusted periodically to reflect cost-of-living increases.

Employers Contributions – Contributions are payable to the Plan by employers of members of affiliated unions based on 6 percent of gross wages from covered employment worked by each member. During 2024, two employers' contributions amounted to approximately \$6,241,000 or 80% of employer contributions.

Valuation of Investments – Investments in registered investment companies and pooled separate account are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In accordance with the policy of stating these investments at fair value, net investment gain or loss is included in the carrying value of related investments in the statements of net assets available for plan benefits - modified cash basis and the changes in the net investment gain or loss are reflected in the statement of changes in net assets available for plan benefits - modified cash basis.

Fully benefit-responsive investments are stated at contract value which is equal to the principal balance plus accrued interest. The investment contracts, which are fully benefit-responsive, are presented at contract value on the statements of net assets available for plan benefits.

NOTE A      PLAN SUMMARY AND SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Benefit-Responsive Fund – The Prudential Guaranteed Income Fund invests primarily in investment contracts that are fully benefit-responsive and provide that Plan participant-initiated withdrawals permitted under the Plan will be paid at contract value. This investment contract has two components: (1) a portfolio of securities or underlying assets and (2) a wrap contract. Pursuant to the contract, the issuer of the contract (wrap provider) undertakes to repay the principal amount deposited plus accrued interest less expenses to fund participant-directed withdrawals, transfers, and loans. The crediting rate of the investment contract is a function of the relationship between the market value, yield, and duration of the underlying assets versus the contract value. If the positive adjustment for the portion of net assets attributable to fully benefit-responsive investment contracts from fair value to contract value increases, the crediting rate at the next reset date will be negatively impacted and vice versa. Interest rate change is a key factor that can influence future crediting rates because it impacts the value, yield, and duration of the underlying securities.

Investment contracts held by the Empower Annuity Insurance Company Guaranteed Income Fund are fully participating contracts. In a fully participating contract, the asset and liability risks may be transferred from the wrap provider to the Empower Annuity Insurance Company Guaranteed Income Fund in the event of a termination or non-participant directed withdrawal, transfer or loan, or the occurrence of certain contract-specific termination provisions. The risk of these events happening is not probable.

Individual (Participant) Accounts – Each participant's account is credited with the participant's contributions and earnings or losses and is charged with an allocation of administrative expenses allocated on a per capita basis. The investments in the participant accounts are self directed.

Vesting – Participants balances are immediately 100% vested and non-forfeitable at all times in their individual account balances.

Participant Loans – Loans are not currently permitted.

Administration – The Board of Trustees of IBEW Local Union No. 60 (the Board) serves as administrator of the Plan, and may at its discretion, pay the Plan's administrative expenses. Any Plan expenses not paid by the Board of Trustees will be paid by the Plan.

Investment Options – Upon enrollment in the Plan, a participant may direct contributions in increments of 1% to various investment options approved by the Plan's Trustees. The investment objectives of the funds offer varying degrees of investment risk.

Forfeitures – Forfeitures of account balances not fully vested, are used to reduce future employer contributions or Plan expenses. During the year ended December 31, 2024, forfeitures totaling \$54,067 were used to reduce Plan expenses. Forfeitures available for use at December 31, 2024 amounted to \$78,529.

Payment of Benefits – Upon termination of service due to death, disability or retirement, a participant is eligible to receive the participant's account balance in the form of a single lump-sum payment or an insurance annuity contract. The Plan allows for withdrawals or rollovers by a participant who is considered a non-bargaining employee after withdrawal from covered employment. Benefits are recorded when paid.

NOTE A      PLAN SUMMARY AND SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Estimates – The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan’s Trustees to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risk and Uncertainties – The Plan holds various investments which are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for plan benefits - modified cash basis and the statement of changes in net assets available for plan benefits - modified cash basis.

Subsequent Events – The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued. No subsequent events occurred, which require adjustment or disclosure to the financial statements at December 31, 2024.

NOTE B      PLAN TERMINATION

Although it has not expressed any intent to do so, the Trustees have the right under the Plan to terminate the Plan subject to the provisions of ERISA.

NOTE C      INVESTMENTS AND CERTIFIED INFORMATION

During 2024, the asset custodian of the Plan was Empower Annuity Insurance Company (Empower).

During January 2024, the asset custodian of the Plan was Prudential Retirement Insurance and Annuity Company (Prudential).

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE D INCOME TAX STATUS

The Internal Revenue Service informed the Trustees, by letter dated September 2, 2015, that the Plan qualifies under Section 401 of the Internal Revenue Code (Code) and is, therefore, not subject to tax under present income tax laws. The Plan has been amended and updated since receipt of the determination letter. However, the Trustees believe that the Plan is designed and being operated in compliance with the applicable requirements of the Code and, therefore, the Plan was qualified and was tax exempt as of the financial statement date.

The Plan believes that all significant tax positions utilized by the Plan will more likely than not be sustained upon examination. As of December 31, 2024, the tax years that remain subject to examination by the major tax jurisdictions under the statute of limitations are from the year 2021 forward (with limited exceptions). Tax penalties and interest, if any, would be reported when paid and would be classified as tax expense in the statement of changes in net assets available for plan benefits - modified cash basis.

NOTE E PARTIES-IN-INTEREST

The Plan invests in various securities offered by Prudential and Empower. These investments are considered party-in-interest transactions because they served as asset custodians for the Plan for the years ended December 31, 2024 and 2023. The Joint Board of Trustees has approved these investment options.

Fees paid during the year for legal, accounting, administrative and other professional services were rendered by parties-in-interest.

NOTE F FAIR VALUE DISCLOSURES

GAAP provides a framework for measuring fair value using a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value based upon whether the inputs to those valuation techniques are observable or unobservable. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical financial instruments and the lowest priority to unobservable inputs. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The financial instrument's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. These inputs are summarized in the three broad levels listed below:

Level 1 - Inputs to the valuation methodology are quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Other significant observable inputs (including quoted prices in active or inactive markets for similar assets or liabilities), or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities. The fair value of Level 3 assets or liabilities are determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

Following is a description of the valuation techniques used for investments measured at fair value. There have been no changes in the methodologies used during 2024 and 2023.

Registered investment companies are valued at quoted market prices of shares held by the Plan at year end.

Pooled separate account is valued at fair value by the asset custodian of the funds based upon the market value of the underlying investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain assets or liabilities could result in a different fair value measurement at the reporting date.
