## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Pulmonary Associates of Richmond, Inc Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

Notes to Financial Statements

**1. Description of Plan:**

The following description of the Pulmonary Associates of Richmond, Inc. Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all eligible employees of Pulmonary Associates of Richmond, Inc. (the "Company") who have attained age 21. To be eligible to receive profit sharing contributions, participants must complete one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions:** The Plan provides for participant contributions of pre-tax and/or after-tax ("Roth") annual compensation, as defined in the Plan. The Plan provides for safe harbor non-elective Company contributions equal to 3% of the employee's compensation. The Company may also make an additional discretionary profit sharing contribution to all eligible employees under the Plan. The Company may make discretionary profit sharing contributions, which are based upon participant compensation and the classification of employees as defined in the Plan. Participants of qualifying age may make additional "catch-up" contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain limitations.

**Participant Accounts:** Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options:** Upon enrollment in the Plan, participants may direct their contributions and the Company's contributions in any percentage increments from 1% to 100% in any of the Plan's investment options. Contributions are subject to annual limitations established by the Internal Revenue Service ("IRS"). Some of the investments are managed by Schwab affiliates. A self-directed brokerage account option is also available to allow participants to select investment options not specifically offered by the Plan. Participants may change their investment options at any time.

**Vesting:** Participants are immediately vested in their contributions, plus actual earnings thereon. The Plan operates as a safe harbor 401(k) plan; thus, a participant is immediately 100% vested in the Company's contributions, plus actual earnings thereon. The discretionary profit sharing contribution funded by the Company for the benefit of each participant plus actual earnings thereon become 100% vested after six years of credited service.

**1. Description of Plan, Continued:**

**Notes Receivable from Participants:** Participants may borrow from their Plan accounts a minimum of \$2,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms cannot exceed five years, unless the proceeds are used to acquire a principal residence. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Management has evaluated notes receivable from participants for collectability and has determined that no allowance is considered necessary. Delinquent notes, that are deemed to be in default by the Plan administrator, are reclassified as distributions based on upon the terms of the Plan document.

**Plan Administration:** Overall responsibility for administering the Plan rests with the Company. Participant accounts are administered by Charles Schwab Trust Bank, the trustee of the Plan.

**Payment of Benefits:** Distribution of a participant's account will occur upon the participant's termination of service, retirement, death, disability, or hardship withdrawal, as defined in the Plan. A participant is entitled to receive a lump-sum payment or substantially equal installment payments over a specified period of time in an amount equal to the value of his or her account.

**Forfeitures:** Plan forfeitures may be used to pay administrative expenses, reduce employer contributions, or added to other employer contributions. Plan forfeitures that are used as other employer contributions are allocated to each participant's account based on the ratio of the participant's eligible compensation to total eligible compensation for the Plan year. No forfeitures were used to reduce employer contributions for 2024. Forfeitures used to reduce employer contributions were \$73,244 for 2023. Forfeitures of terminated nonvested accounts totaled \$49,862 for 2024 and \$72,134 for 2023. Earnings on forfeitures totaled \$4,599 for 2024 and \$1,003 for 2023. Forfeited balances available for reduction of future employer contributions or to pay Plan expenses were \$54,461 at December 31, 2024. There were no forfeited balances available at December 31, 2023.

**2. Summary of Significant Accounting Policies:**

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual method of accounting.

**Investment Valuation and Income Recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

**2. Summary of Significant Accounting Policies, Continued:**

**Investment Valuation and Income Recognition, Continued:** Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits:** Benefits are recorded when paid.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Subsequent Events:** Management has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued, and has determined that there are no subsequent events to be reported in the accompanying financial statements.

**3. Fair Value Measurements:**

The Financial Accounting Standards Board ("FASB") has issued guidance for measurement and disclosure of fair value and established a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Quoted prices for similar instruments in active and inactive markets; and model driven valuations with significant inputs and drivers derived from observable active markets. There were no Level 2 assets or liabilities at December 31, 2024 and 2023.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement. There were no Level 3 assets or liabilities at December 31, 2024 and 2023.

Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

**3. Fair Value Measurements, Continued:**

The following is a description of the valuation methodologies used for investments carried or disclosed at fair value:

**Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common/Collective Trusts:** Valued daily at the NAV of shares or units held by the Plan. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. This practical expedient is not used when it is determinable to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Administrative Expenses:**

The Plan paid administration fees in the amount of \$61,613 during 2024 and \$60,452 during 2023. Although not required by the Plan, some of the costs of plan administration are absorbed by the Company.

**5. Related Party Transactions:**

The Plan invests in mutual funds, a common/collective trust, money market deposit accounts, and self-directed brokerage accounts funds sponsored by affiliates of the trustee. These are related party transactions and are identified as parties in-interest in the accompanying schedule of assets (held at end of year). The Plan paid administrative fees to Charles Schwab Trust Bank as described in Note 4.

**6. Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its discretionary profit sharing contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become fully vested in their accounts.

**7. Tax Status:**

The Internal Revenue Service has determined and informed the prototype sponsor by a letter dated September 21, 2020 that the adopted prototype plan is designed in accordance with the applicable sections of the Internal Revenue Code (the "Code"). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is designed and operated in accordance with ERISA.

Management has evaluated the effects of accounting guidance related to uncertain income tax positions and concluded that the Plan has no significant financial statement exposure to uncertain income tax positions at December 31, 2024 and 2023. The Plan is not currently under audit by any tax jurisdiction.

**8. Risks and Uncertainties:**

The Plan provides for investments in various securities. Investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the financial statements.
