As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(1) Description of the Plan

The following description of the VELCO 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan’s provisions.

(a) General

The Plan is a defined contribution 401(k) plan established by Vermont Electric Power Company, Inc. (the “Company”) as of January 1, 1981. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Board of Directors oversees governance of the Plan. The Plan’s 401(k) Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Board of Directors.

Effective May 1, 2024, the Plan name changed from the Employee Savings and Investment Plan for Employees of Vermont Electric Power Company, Inc. to the VELCO 401(k) Plan.

(b) Eligibility

Prior to May 1, 2024 employees of the Company were eligible to participate in the Plan on the first day of each month following hire. Effective May 1, 2024, employees are eligible to participate in the Plan immediately upon hire. All employees of the Company are eligible with the exception of employees covered by a collective bargaining agreement, leased employees, and nonresident aliens.

(c) Employee Contributions

Eligible employees are allowed to contribute, through payroll deductions, up to 60% of pre-tax annual compensation not to exceed the Internal Revenue Service’s (“IRS”) established limits. The Plan has an auto enroll feature where eligible employees are auto-enrolled into the Plan with a 6% deferral rate unless the employee makes a contrary election or elects to opt out. Employees can also make after-tax roth contributions. Employees attaining 50 years of age or older before the end of the year are allowed to make catch-up contributions not to exceed IRS established limits. Participants are also permitted to make rollover contributions to the Plan.

(d) Employer Contributions

The Plan provides for employer matching contributions in an amount equal to 100% of employee deferral contributions, which is subject to a maximum of 4.25% of eligible compensation.

For employees hired on or after January 1, 2008, the Plan provides for a profit-sharing contribution in the amount of 3.5% of eligible base salary. These participants are not eligible to participate in the Vermont Electric Power Company Pension Plan.

Prior to May 1, 2024 employees were eligible for the employer matching and profit-sharing contributions on the first day of each month following hire. Effective May 1, 2024, employees are eligible to receive employer contributions immediately upon hire.

(e) Participant Accounts

Each participant's account is credited with the participant's allocation of (a) the participant's contribution; (b) the Company's matching and profit-sharing contribution; and (c) Plan earnings. The allocation of the Plan's earnings is based on participants' account balances. The benefit to which a participant is entitled is that which can be provided from the vested balance in the participant's account. Each participant directs the investment of the contributions into various investment options offered by the Plan.

(f) Vesting

Employees are immediately fully vested in all employee contributions and earnings thereon. An employee is 100% vested in Company matching and profit-sharing contributions after the employee has completed three years of service.

(g) Forfeitures

Forfeitures represent amounts which could not be paid to terminated participants due to failure to meet vesting requirements. Forfeitures are used to reduce future employer contributions or Plan expenses. In 2024 and 2023, forfeitures used to offset expenses were \$53,424 and \$13,741, respectively. At December 31, 2024 and 2023, there were amounts totaling \$179 and \$41,575, respectively, in forfeited nonvested accounts.

(h) Payment of Vested Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount equivalent to their vested benefits, partial withdrawals, or installment distributions. Unless otherwise elected, participants with balances greater than \$1,000 and less than \$7,000 will be rolled over to an IRA established by the Plan administrator. Effective January 1, 2024, the threshold changed from \$5,000 to \$7,000.

Hardship distributions are permitted subject to a \$500 minimum amount and up to an amount not to exceed the total participant's elective deferral amount. Participants who have attained the age of 59-½ may make in-service withdrawals.

(i) Notes Receivable

A participant is permitted to borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant can have no more than two loans outstanding at any time. Loans can be for no longer than a 5-year term, except for the purchase of a primary residence, which can be as long as a 10-year term. Loans are repaid through payroll deductions. The interest rate on a loan is based on the prevailing interest rate charged by persons in the business to lend money for loans, which would be made under similar circumstances. The interest rate is fixed throughout the duration of the loan.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

(c) Risks and Uncertainties

The Plan invests in securities, which in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

(d) Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be paid to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Unrealized gains and losses are based on the differences of beginning of the year fair values or cost if purchased during the current year, and year-end fair values. Interest and dividend income is accrued as earned.

(e) Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

(f) Payment of Benefits

Benefits are recorded when paid.

(g) Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Fees for the administration of notes receivable from participants and distributions are included in administrative expenses and are charged directly to the participant's account. Additionally, the Plan receives revenue sharing credits from mutual funds and other investments in which the Plan's assets are invested. These credits are typically a portion of the fees charged by the investment provider that are returned to the Plan. The credits offset administrative expenses.

(h) Subsequent Events

For purposes of determining the effects of subsequent events on these financial statements, management has evaluated events through September 29, 2025, the date the Plan's financial statements were available to be issued.

(3) Information Certified by the Plan's Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified as complete and accurate by the Plan's trustee, Fidelity Management Trust Company, all investments reflected on the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, the schedule of assets held for investment purposes as of December 31, 2024, and the related investment activity reflected in the statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023.

(4) Fair Value Measurements

Generally accepted accounting principles in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the closing price reported on the active market on which the individual securities are traded. These investments totaled \$66,349,287 and \$54,965,892 as of December 31, 2024 and 2023, respectively, and are classified as Level 1.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Investment Contract

The Plan entered into a fully benefit-responsive guaranteed investment contract. The trustee maintains the contributions in a general account. The account is credited with earnings on the underlying investments and changed for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment income contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for plan benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment option or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

(6) Related Party Transactions

The Plan uses a number of service providers. These providers are considered parties-in-interest under ERISA.

(7) Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. Additionally, the Company may amend the Plan at any time without the consent of any participant or beneficiary, provided that no amendment deprives any participant of the participant non-forfeitable accrued benefit.

(8) Withdrawing Participants

All participants who have withdrawn from the Plan and requested their benefits have been paid as of December 31, 2024.

(9) Tax Status

The Plan is based on a prototype plan sponsored by Fidelity Management Trust Company. Fidelity Management Trust Company has obtained an opinion letter dated June 30, 2020 stating that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code. Generally, the Plan administrator and the Plan may rely on the opinion letter received by Fidelity Management Trust Company as to the form of the plan qualifying under the Internal Revenue Code (except as otherwise noted in the opinion letter). Additionally, the Plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and remains tax-exempt. Therefore, no provisions for income taxes have been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
