Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Plan de Ahorro, Inversiones y Retiro de Empleados de Holsum de Puerto Rico, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

The following description of Plan de Ahorro, Inversiones y Retiro de Empleados de Holsum de Puerto Rico, Inc. (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

(a) *General*

The Plan is a savings and investment profit-sharing plan covering substantially all permanent employees of Holsum de Puerto Rico, Inc. (the Company or Sponsor). All employees of the Company that have completed nine months of service and are at least 21 years of age, as defined, are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and Section 1081.01 (a) and (d) of the Puerto Rico Internal Revenue Code of 2011, as amended (the PRIRC or the Code).

(b) *Participant Contributions*

Each year participants may contribute an amount not to exceed the maximum deferral amount specified by the Puerto Rico tax law. Annual deferral limit under the PRIRC is \$15,000 for the years ended December 31, 2024 and 2023, respectively. The Company makes a weekly contribution to the Plan on behalf of each participant. The contribution equals 100% for the first 1% of the participants' contribution and 40% for participant contributions from 2% to 6%. Effective January 1, 2013, the Plan was amended to limit the Company's matching contributions as applied only to the first \$20,000 of a participant's compensation for the Plan year. Additional amounts may be contributed at the option of the Company's Board of Directors. During the years ended December 31, 2024 and 2023, no additional amounts were contributed to the Plan.

In addition, participants who are age 50 or older at the end of a calendar year may make additional pre-tax contributions (catch-up contributions) of up to \$1,500 per calendar year.

(c) *Participant Accounts*

Each participant account is credited with the participant's contribution and credited/charged with the allocations of (a) the Company's contribution and (b) Plan earnings/losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are made in proportion to the participant's investment in each fund. Participants are entitled to the benefit that can be provided from their vested account.

(d) *Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after three years of credited service.

(e) Payment of Benefits

Participants are entitled to withdraw the total value of their accounts at the time of retirement, termination of employment, disability or death. A lump-sum payment is made in the case of termination of employment and death.

(f) Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts were approximately \$5,200 and \$800, respectively. This account is used to pay Plan expenses and any remaining part to reduce employer matching contributions, or within the employer discretion, distribute such amounts among the remaining participants matching contributions accounts in the same proportion originally allocated.

(g) Rollovers Contributions

Rollovers contributions to the Plan consist of monies received by a Participant from another plan qualified under the Puerto Rico Internal Revenue Code.

(h) Investment Options

Participants may direct their contributions to various mutual funds offered as investment options as described in Note 3.

(i) Administrative Expenses

The Plan's expenses are paid either by the Plan or the Sponsor, as provided by the plan document. Expenses that are paid directly by the Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying Statement of Changes in Net Assets Available for Benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying Statement of Changes in Net Assets Available for Benefits.

(j) Hardship Withdrawals

Under certain conditions, participants, while still employed by the Company, are permitted to withdraw, in a single sum, the employee contribution portion of their account balance. These conditions include un-reimbursed medical expenses, the purchase of a principal residence, the payment of postsecondary education tuition, to prevent eviction from or foreclosure on a principal residence, funeral expenses or any other cause that, in the administration determination, has produced an immediate financial need. A participant's right to make deferrals to the Plan will be suspended for 12 months after the receipt of the hardship withdrawal.

(2) Summary of Significant Accounting Policies

(a) *Basis of Accounting*

The Plan's financial statements are prepared on the accrual basis of accounting.

(b) *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at measurement date. The Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 5 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recognized as earned, on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gain and losses on investments bought and sold as well as held during the year.

(c) *Payment of Benefits*

Benefits are recorded when paid.

(d) *Contributions*

Employee contributions are recorded in the period during which the Company makes payroll deductions from the Plan participants' earnings. The Company's contributions are recorded in the same period.

(e) *Risks and Uncertainties*

The Plan invests in mutual funds, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with these instruments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits. Individual participants' accounts bear the risk of loss resulting from fluctuations in investment values.

(f) *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(3) Investment Options

Participants may direct their contributions to any of the funds offered as investment options. The account is credited with earnings on the underlying investments and charged for participant withdrawals and investment management expenses. Fair value represents contributions made, plus earnings (including realized and unrealized gains/(losses) on the underlying funds), less participant withdrawals and investment management expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at fair value.

(4) Information Prepared and Certified by Trustee

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by Banco Popular de Puerto Rico, the trustee of the Plan:

(5) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follow:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds: Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open - end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. These securities are classified as Level 1.

Interest Bearing Deposits: The carrying amounts of interest-bearing deposits are reasonable estimates of the fair value due to their short-term maturity. These interest-bearing deposits are available upon demand, hence, classified as Level 1.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(6) Bank Deposit Open Account

At December 31, 2024 and 2023 consists of amounts deposited in a savings account with the trustee of the Plan. This account bears interest at 3.784% and 4.903% at December 31, 2024 and 2023, respectively. This deposit is in excess of the federally insured limit of \$250,000 at December 31, 2024 and 2023. The carrying amounts of interest-bearing deposits are reasonable estimates of the fair value due to their short-term maturity. At December 31, 2024 and 2023, the balance of interest-bearing deposits amounted to \$3,905,816 and \$3,476,119 respectively.

(7) Excess Contributions Payable

During the prior plan year, the Plan failed the Actual Deferral Percentage (ADP) nondiscrimination test, which compares the average deferral rates of highly compensated employees (HCEs) to those of non-highly compensated employees (NHCEs). As a result, excess contributions totaling \$16,675 were identified and recorded as payable to the affected HCEs.

These excess contributions were corrected in accordance with IRS guidelines through distribution and were fully resolved within the required correction period.

For the current plan year, the Plan successfully passed all required nondiscrimination tests, and no excess contributions are payable.

(8) Nonexempt Prohibited Transactions

In accordance with the Department of Labor's Regulation 2510.3-102, an employer is required to remit amounts paid by a participant or beneficiary to an employer for contribution to an employee benefit plan or repayment of a participant loan to the Plan as soon as they can reasonably segregate from the employer's general assets, but in no event later than the 15th business day following the end of the month in which amounts are contributed by participants or withheld from their wages. The Plan Sponsor complies with the timely remittance regulation.

(9) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

(10) Party-In-Interest Transactions

The Plan has a bank deposit open account managed by Banco Popular de Puerto Rico (BPPR). BPPR is the trustee as defined by the Plan and, therefore, this transaction qualifies as party-in-interest transaction permitted under the provisions of ERISA.

(11) Tax Status

The Plan is designed and intended to be qualified under Section 1165 of the Puerto Rico Internal Revenue Code of 1994, as amended (the 1994 PR Code), and Section 1081.01(a) of the Internal Revenue Code for a New Puerto Rico, Act No. 1 of January 31, 2011, as amended from time to time (the 2011 PR Code). The Plan received a favorable determination letter from the Puerto Rico Treasury Department (PRTD) on January 1, 1995 as to its qualified status under the 1994 PR Code. The Plan filed for a favorable determination letter with the PRTD under the 2011 PR Code. On May 6, 2016, the Plan received a favorable determination letter from the PRTD as to its qualified status under the 2011 PR Code. On May 26, 2019, the Plan was amended to increase the participants eligibility service requirement from three to nine months. On July 28, 2020, related to this amendment the Plan received a favorable determination letter from the PRTD as to its qualified status under the 2011 PR Code. No events have occurred with respect to the Plan or the associated Trust that, in substantial likelihood, would result in the Plan being disqualified by the PRTD. The Trust associated with the Plan is intended to be exempt from Puerto Rico income taxation pursuant to the provisions of Section 1165(a) of the 1994 PR Code and Section 1081.01(a) of the 2011 PR Code, and pursuant to Section 1022(i)(I) of ERISA. Accordingly, no provision for income taxes has been made.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the

Puerto Rico Treasury Department. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that at December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(12) Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, the date at which the financial statements were available to be issued.
