INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
Contractors Plan Trust Health Reimbursement Arrangement

Opinion

We have audited the accompanying financial statements of Contractors Plan Trust Health Reimbursement Arrangement (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Contractors Plan Trust Health Reimbursement Arrangement as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

1. DESCRIPTION OF THE PLAN

The following description of Contractors Plan Trust Health Reimbursement Arrangement (the "Plan") provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions.

The Plan has been established as a health reimbursement arrangement, as defined in the Internal Revenue Code (the "Code") and the Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

The Plan is part of The Contractors Plan Trust II ("Trust"). The Plan's custodian is American Bank of Commerce (the "Custodian"). Fringe Benefit Group, Inc. ("FBG") serves as the third party administrator and recordkeeper to the Plan. FBG is responsible for determining whether claimed benefits are provided for by the Plan, processing claim payments, ensuring the claim payments are correct and within the payment limits stipulated by the Plan, and maintaining all documentation in support of claim payments. NFI California Cartage Holding Company, LLC (the "Sponsor" or "Employer") serves as Plan sponsor.

Eligibility

All employees who provide services on a project or contract that is subject to prevailing wage laws, and if the project and the job performed are covered under the Plan, then for purposes of receiving any prevailing wage contribution made to the Plan employees are eligible. The date of eligibility begins on the date they first perform services on the project or their date of hire on the covered prevailing wage project. They will become a participant in the Plan on that date. Former employees are eligible to use up their remaining Plan funds until their account has been depleted.

Benefits

The Plan provides for reimbursement of qualifying medical expenses and covers eligible employees of the Sponsor from the participant's Health Reimbursement Account ("HRA"). Each participant's benefits are limited to the amount contributed by the Sponsor annually. Remaining funds stay in the participant's HRA until used.

Employer contributions

Employer contributions are based on government determined prevailing wages. The Sponsor provides an hourly rate contribution which covers the cost of participant benefits. Any funds remaining after paying the employees benefits are allocated to a premium reserve account. The premium reserve account accumulates up to one month of employee only premiums for all benefits. Any excess funds are deposited into the HRA and made available for use in reimbursing the participant's eligible medical, prescription drug, dental, or vision claims, or any Medicare premiums.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and financial statement presentation

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

Use of estimates

The preparation of the financial statements in conformity with US GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Actual results could differ from these estimates.

Contributions

The Plan is funded exclusively through Employer contributions. Employer contributions are recognized when received and allocated to participant accounts based on eligibility and plan provisions. Unused balances may be carried forward.

Payment of benefits

Claim payments are recorded when paid by FBG.

Expenses

Administrative expenses are recorded to the Plan up to \$12 per month per participant or the remaining funds within the participant's account.

Subsequent events

The Plan has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued.

3. INTEREST TRUST

The Plan utilizes The Contractors Trust Plan II (the "Trust"), which is a trust arrangement maintained FBG for the benefit of multiple employee benefit plans. The Trust holds all employer contributions made to the Plan. As of the date of this financial statement, the Trust assets solely consisted of non-interest bearing cash, which represents readily available funds to reimburse participants for qualified medical expenses incurred under the Plan.

The value of the Plan's interest in the Trust is based on the beginning of year value of the Plan's interest in the Trust plus actual contributions less payments and administrative expenses. As of December 31, 2024 and 2023, the Plan's interest in the net assets of the Trust was approximately 4.4% and 3.2%, respectively.

4. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan paid expenses that consist primarily of administrative fees paid to FBG. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses.

5. TAX STATUS

The trust established under the Plan to hold the Plan's net assets is a welfare benefit fund as defined in Section 419 of the Internal Revenue Code. As such, contributions to this welfare benefit fund by the Sponsor is subjected to certain limitations. The Trust is subject to federal income tax on unrelated income. For the years ended December 31, 2024 and 2023, the Trust paid no income taxes because there was no unrelated income earned by the Trust.

In accordance with guidance on accounting for uncertainty in income taxes, management has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. RISKS AND UNCERTAINTIES

The Trust includes cash held within a financial institution. At times, such deposits may be in excess of the Federal Deposit Insurance Corporation ("FDIC") insurance limit. Plan management does not believe the Plan is exposed to any significant credit risk.
