**NOTE 1 - DESCRIPTION OF THE PLAN**

***General***

The King Street Capital Management, L.P. 401(k) Plan (the “Plan”) is a defined contribution plan subject to the requirements of the Employee Retirement Income Security Act of 1974 (“ERISA”) and is sponsored by King Street Capital Management L.P. (“King Street” or the “Sponsor”). Fidelity Management Trust Company (“FMTC”) is the trustee and custodian of the Plan. Fidelity Workplace Services LLC (“FWS”) is the record keeper of the Plan. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

***Eligibility Requirements***

An employee becomes eligible to participate in the Plan on the entry date that coincides with the employee’s date of hire as long as the employee contemplates the completion of 1,000 hours of service. Otherwise, an employee will be eligible to become a participant on the entry date that coincides with the completion of one service year as defined in the Plan document.

***Contributions***

Eligible employees may contribute up to an annual maximum contribution permitted by the Internal Revenue Code (the “Code”) of \$23,000 in 2024 and \$22,500 in 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers) and additional contributions from participants who reach age 50 or older in accordance with the Code.

Eligible employees may designate some or all of their deferral contribution as a Roth Deferral Contribution at the time they make their deferral election. Once made, this election will be irrevocable (that is, Roth Deferral Contributions cannot later be re-characterized as pre-tax deferral contributions). If eligible employees elect to make a Roth Deferral Contribution, the amount of their contribution will be included in their income for tax purposes.

In addition, the Sponsor may contribute a discretionary profit-sharing contribution in an amount to be determined at year end. There was discretionary profit-sharing contribution of \$419,119 declared for the year ended December 31, 2024, including \$14,046 that was funded through forfeitures. The remaining balance of \$405,073 is presented as contributions from employer receivable on the statement of net assets available for benefits at December 31, 2024.

***Participant Accounts***

Each participant account is credited with the participant’s contribution, profit-sharing contribution and allocations of plan earnings. Allocations are based on participant earnings on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Participants’ Investment Options***

Upon enrollment in the Plan, participant contributions are invested, and all dividends and interest income are reinvested by the trustee as directed by the participant. Earnings on amounts held in the investment funds are allocated to individual accounts daily.

***Benefits***

Benefit payments are determined and disbursed by the trustee after receiving notice from the Sponsor that a participant’s beneficial interest has matured due to death, disability, retirement or separation. Participants

can elect to receive a lump-sum distribution, in cash or in the form of a rollover to another qualified plan, monthly installments or some combination of lump sum and monthly installments. In addition, participants may elect in-service withdrawals of their vested account balances after reaching age 59½ or for hardship purposes.

***Vesting***

Participants are 100% vested in pre-tax employee contributions, Roth Deferral Contributions, rollover account and earnings thereon.

Participants with account balances derived from sponsor discretionary profit-sharing contributions and earnings are vested in accordance with the following schedule:

<u>Years of Vesting Service</u>	<u>Percentage Vested</u>
One	33⅓%
Two	66⅔%
Three or more	100%

Forfeited amounts are retained in the Plan and used to reduce future sponsor contributions or to pay administrative expenses. Forfeitures were not used to pay for administrative expenses but were used to reduce discretionary profit-sharing contribution in 2024 that was paid in 2025, refer to Note 1 - Contributions. Forfeiture balances were \$13,996 and \$41,199 for the Plan years ended December 31, 2024 and 2023, respectively.

***Notes Receivable from Participants***

Participants may make a written application to the Plan Administrator to borrow from the Plan an amount ranging from \$1,000 to the lesser of \$50,000 or 50% of their vested balance. As of December 31, 2024, the interest rate on outstanding loans ranged between 4.25% and 9.5%, depending on date of origination. All loans shall be evidenced by a written note, shall bear a reasonable rate of interest, shall be secured by the participant's account, shall be amortized in level payments made at least quarterly over the term of the loan and shall be repaid by the participant over a five-year period. Loans used in connection with the purchase of a participant's principal residence may be repaid over a term of up to 15 years.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The Plan's financial statements are prepared on the accrual basis of accounting.

***Investment Valuation and Income Recognition***

The Plan's investments in mutual funds are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Participant loans are valued at cost, which approximates fair value. Purchases and sales are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Participant loan interest income is recorded on the accrual basis.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

***Benefit Distributions***

Benefits are recorded when paid.

***Administrative Expenses***

Administrative expenses reported on the financial statements represent fees charged by Fidelity to the participants. All other administrative expenses, with the exception of those related to participant's loans, are paid by the Sponsor.

***Use of Estimates***

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**NOTE 3 - CERTIFIED INFORMATION**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Plan Administrator has obtained and agreed to or derived from the FMTC, a qualified institution who has certified that the following information in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024.

*Mutual funds:* These funds, which include money market funds, are valued at the daily closing price as reported by each fund. The funds are deemed to be actively traded and are required to publish their daily net asset value ("NAV") and to transact at that price.

*Self-directed brokerage account (BrokerageLink):* These accounts include participant-directed investments in mutual funds, common stocks and money market fund accounts, which are classified within Level 1. Refer to valuation methodologies above. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded.

*Collective trust fund:* Valued using the NAV provided by the administrator of the fund. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The collective trust fund generally provide for daily redemptions by the Plan at reported NAV per unit, without restriction. There are no unfunded commitments for the collective trust fund as of December 31, 2024.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. During 2024 and 2023, there was no transfer between the three levels of the fair value hierarchy.

**NOTE 5 - TAX STATUS OF THE PLAN**

The Plan uses a volume submitter plan and received an opinion letter dated June 30, 2020 from the Internal Revenue Service ("IRS"), that the Plan is designed in accordance with the applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Investment transactions with FTMC and its affiliates qualify as party-in-interest transactions.

**NOTE 7 - PLAN TERMINATION**

While King Street has not expressed any intent to discontinue its contributions or to terminate the Plan, it may do so at any time. In the event of termination, the Plan Administrator will facilitate the distribution of account balances under the provisions of the Plan and trust agreement until all assets have been distributed by the trustee. Each participant in the Plan, upon plan termination, will automatically become 100% vested in their account balance.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in any combination of mutual funds, collective trust fund and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**NOTE 9 - SUBSEQUENT EVENTS**

The Plan administrator has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued, and determined that there were no circumstances that warranted recognition or disclosure of those events or transactions in the financial statements as of December 31, 2024.
