Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Davenport Energy/First Piedmont 401k Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103 (a)(3)(c) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Davenport Energy/First Piedmont 401k Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

Note 1. Significant Accounting Policies

Basis of accounting:

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results could vary from these estimates.

Contributions:

Participants' contributions are collected by the Company through payroll deductions and forwarded to the Trustee. Contributions withheld from salaries and not yet forwarded to the Trustee are reflected as participant contributions receivable.

Benefits paid to participants:

Distributions from the Plan are recorded in the period in which they are paid to participants in accordance with the terms of the Plan.

Investment valuation and income recognitions:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized/unrealized appreciation/(depreciation) in fair value of investments includes the Plan's gains and losses on investments bought, sold, and held during the year. Investment income and appreciation/(depreciation) for each participant-directed investment fund is allocated to each participant in the same ratio that the participant's account balance in that fund bears to the total account balances for all participants in that fund.

Notes receivable from participants:

Loans issued to participants in the form of promissory notes are measured at their unpaid principal balance plus any accrued but unpaid interest.

Administrative expenses:

Investment-related and recordkeeping expenses are paid from the Plan's assets. Certain investment-related expenses are recorded as a reduction of net investment income and are not identifiable on the financial statements.

NOTES TO FINANCIAL STATEMENTS

Note 1. Significant Accounting Policies (Continued)

Risks and uncertainties:

The Plan invests in registered investment companies and a common collective trust which invests in various securities including U.S. Government securities, corporate debt instruments, and corporate stocks, which in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with these securities, it is reasonably possible that changes in the values of investments will occur in the near-term and that such changes could materially affect the amounts reported in the financial statements.

Note 2. Plan Description

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering substantially all employees of the Company who have completed two months of service and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Each year, the Company contributes to the Plan the elective contributions made by the participant and a matching contribution equal to a percentage, which shall be determined by the employer, of the participants' elective contributions. Matching contributions begin the first day of the month following six months of employment. Additional amounts may be contributed at the option of the Company's board of directors. Participants may contribute up to 25% of their annual wages, including bonuses and overtime. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Plan includes an automatic deferral feature where 3% is automatically withheld unless an alternative amount is elected or elect not to defer.

Participant accounts:

Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contribution, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES TO FINANCIAL STATEMENTS

Note 2. Plan Description (Continued)

Vesting:

Vesting is based on years of continuous service. A participant is 100% vested after six years of credited service.

Investment options:

All participant contributions and Company contributions are participant directed among investment funds

Participant notes receivable:

Participants may borrow from their fund accounts an amount equal to the lesser of \$50,000 or 50% of the value of the nonforfeitable amount of their account balance. Loan transactions are treated as a transfer to (from) the investment fund and from (to) the Participant Notes fund. Loan terms may not exceed five years except for loans used to acquire a principal residence, which shall provide for repayment over a reasonable period. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Principal and interest are paid ratably through monthly payroll deductions.

Payment of benefits:

Distributions and withdrawals are generally payable upon termination, total disability, death or the attainment of the normal retirement age of 65. Upon termination of service, a participant who has an account balance of \$5,000 or less can withdraw the funds in a lump-sum settlement. A participant who has an account balance of more than \$5,000 may elect to receive either a lump-sum amount equal to the vested value of his or her account, receive installment payments, or leave the funds in the account until normal retirement age. Participants are eligible to begin receiving in-service distributions of all vested account balances upon reaching 59 1/2 years of age.

Participant-directed investments in funds:

Each participant may direct how his/her account balance and future contributions are invested by choosing between the available investment funds offered by the Plan. Any such investment direction remains effective until changed by a new election. The right to direct the investment continues at termination or retirement of the participant until the distribution of the entire account balance.

Forfeited accounts:

The amount of forfeited non-vested accounts was \$15,926 and \$12,065 for the years ended December 31, 2024 and 2023, respectively.

Note 2. Plan Description (Continued)

Administrative expenses:

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include recordkeeping and trustee fees. Expenses relating to purchases, sales or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. All other administrative expenses of the Plan are paid by the Company.

Note 3. Tax Status

The Plan adopted the trustee's volume submitter profit sharing plan document, which received a favorable opinion letter from the Internal Revenue Service, dated April 2, 2018, stating that is qualified under the applicable requirements of the Internal Revenue Code and is, therefore, not subject to tax under present income tax laws. Although the Plan has been amended since receiving the determination letter, the Plan administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Note 4. Funding Policy

Contributions are determined annually by the Company's board of directors. The Plan may also accept rollover contributions from other qualified plans.

The Employer may reimburse the Plan for any administrative expenses incurred. Administrative expense reimbursements are not considered as Employer contributions.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 6. Information Prepared and Certified by Trustee

Note 7. Fair Value Measurements

Fair value is based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The established framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 -Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for the Plan's instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Stable Value Collective Trust Fund: The Plan invests in the Federated Hermes Capital Preservation Fund (FHCPF); a collective investment trust. The investment objective of FHCPF is stability of principal and high current income.

The fair value of the Plan's interest in the Stable Value fund is valued at Net Asset Value (NAV) based on information reported by the issuer of the fund at year-end. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

Mutual Funds: The investments in mutual funds are valued utilizing a market approach wherein the Plan uses the quoted prices in the active market for identical assets. All of these investments are traded in active markets at their NAV per share and are primarily categorized as Level 1.
