Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the 403(b) Thrift Plan of Family Service Association of Greater Fall River, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

Notes to Financial Statements

December 31, 2024 and 2023

1. Description of Plan

The following description of the 403(b) Thrift Plan of Family Service Association of Greater Fall River, Inc. (the Plan) provides only general information. Participants should refer to the summary plan description or the plan document for more complete information of the Plan's provisions.

General

The Plan is a defined contribution retirement plan covering all employees of Family Service Association of Greater Fall River, Inc. (the Organization). Employees are immediately eligible to participate in the Plan upon hire. Employees are eligible for the Organization's contributions upon attaining the age of twenty-one and completion of one year (1,000 hours) of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Organization is responsible for oversight of the Plan. The Organization determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute a percentage of their annual compensation, as defined in the plan document. Participants may make pretax 403(b) contributions and post-tax Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. The Organization makes discretionary contributions to the participants that are eligible for employer contributions. Once eligible, the participant must work 1,000 hours each year to qualify for the Organization's contributions and remain employed at the Organization as of the last day of the plan year.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of (a) the Organization's contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting Provisions

Participants are immediately vested in their contributions plus actual earnings thereon. A vested benefit cannot be taken away from the participants or forfeited. Participants vest in the Organization's contributions and earnings based on years of service, with a minimum of 1,000 hours per year. A participant is fully vested in the Organization's contributions upon completion of three years of service.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or the participant will be able to purchase a uniform monthly annuity.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may generally not be longer than five years, however, loans made for the purchase of a primary residence may be for a longer term. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest. Interest rates on outstanding loans, as of December 31, 2024 and 2023, range from 3.25% to 5.85%. Principal and interest payments are made ratably through payroll deductions.

Forfeited Accounts

Forfeitures are created when participants terminate participation in the Plan before becoming fully vested in the Organization's contribution under the Plan.

2. *Significant Accounting Policies*

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles general accepted in the United States of America (GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Uses of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

The Organization pays substantially all administrative expenses of the Plan. Administrative expenses, which relate to servicing of participant loans and certain investment fees, are paid via a reduction of participant account balances.

2. *Significant Accounting Policies - continued*

Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual balance. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determine the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. *Information Prepared and Certified by Custodian (Unaudited)*

Certain information in the accompanying financial statements and ERISA-required supplement schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation of fair value of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company, a qualified institution.

4. *Party-in-Interest and Related Party Transactions*

Certain plan investments are shares of mutual funds managed by Mutual of America Life Insurance Company, the custodian, as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services during 2024 and 2023, amounted to \$7,731 and \$3,086, respectively.

5. *Plan Termination*

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

6. *Fair Value Measurements*

FASB ASC 820, Fair Value Measurements and Disclosures, provides the framework for measuring at fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurement).

The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

6. Fair Value Measurements – continued

The following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of difference methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. *Income Tax Status*

The Plan, as a 403(b) plan, currently is not required to be submitted to the IRS for determination. The Plan is required to operate in conformity with the Internal Revenue Code (IRC) to maintain its tax-exempt status. Plan management believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2021.

8. *Risks and Uncertainties*

The Plan and its participants invest in various investment securities. Investment securities are exposed to various risk such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the value of investment securities will occur in the near term, and that such changes could materially affect participant's account balances and the amounts reported in the statements of net asset available for benefits.

9. *The General Account*

The Plan invests in the General Account (the Fund), a traditional fully benefit-responsive guaranteed investment, managed exclusively for the Plan by Mutual of America Life Insurance Company. Mutual of America Life Insurance Company maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Fund's issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the Fund meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Fund. The Fund is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported by Mutual of America Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

9. *The General Account - continued*

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the Fund at December 31, 2024 and 2023, was \$1,609,248 and \$2,605,768, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

There are certain events that limit the ability of the Plan to transact at contract value with the issuer immediately. Such events include termination of the contract, layoffs, termination of the plan, plant closings, bankruptcy, mergers or early retirement incentives. Plan management does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The investment contract does not permit the issuer to terminate the agreement prior to the scheduled maturity date.

10. *Subsequent Events*

The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued. No material subsequent events have occurred since December 31, 2024, that require recognition or disclosure in these financial statements.
