### **Report on the Audit of the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Northwest Permanente, P.C. Retirement Plan and Trust Profit Sharing Aspect, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Northwest Permanente, P.C. Retirement Plan and Trust Profit Sharing Aspect's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ### ***Responsibilities of Management for the Financial Statements***

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## **Note 1 – Description of Plan**

The following description of the Northwest Permanente, P.C. Retirement Plan and Trust Profit Sharing Aspect (the Plan) provides only general information. Participants should refer to the Plan Document, as amended, for a more complete description of Plan provisions.

**General** – The Plan is a profit sharing plan with elective 401(k) contributions, profit sharing contributions, and employee after-tax contributions, covering substantially all non-clerical employees of Northwest Permanente, P.C., and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Northwest Permanente, P.C. (the Company) is the Plan’s sponsor and serves as Plan Administrator.

**Eligibility** – All qualified employees of the Company are eligible to participate in the Plan after six months of employment. Participation in the profit sharing portion of the Plan for eligible employees begins after an employee has completed one year of service with Plan entry dates in January and July. A qualified employee is defined as an employee who receives an Internal Revenue Service Form W-2 from the Company and who is not excluded from eligibility below. The following employees are excluded from eligibility:

- An employee covered by a collective bargaining agreement that does not provide for participation in this Plan.
- A leased employee on the payroll of an outside firm.
- An irregular-service or on-call physician or Certified Registered Nurse Anesthetist (CRNA), and any physician or CRNA who is covered by an employment agreement that does not provide for participation in this Plan.
- A worker classified by the Company as an independent contractor or as an employee of a nonaffiliated entity.
- The employee is a non-exempt hourly employee of the Company whose primary job responsibilities are to perform clerical functions for the Company.
- Any employee to whom all of the following apply:
  - The employee is hired after December 31, 2013.
  - The employee is a non-clinician administrative staff member.
  - The employee is not the CFO, COO, CAO, Executive Medical Director, or any vice president of the Company.

#### **Contributions**

*Participant contributions* – Each year, participants may contribute up to 100% of eligible pre-tax, Roth or after-tax compensation, up to allowable limits, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible qualified defined contribution plans.

*Employer contributions* – The Plan requires a 2% employer contribution for all non-highly compensated eligible participants' compensation on an annual basis.

Contributions are subject to regulatory limitations.

**Participant accounts** – Each participant's account is credited with the participant's contribution, the employer's contribution, and allocations of Plan earnings and expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their accounts into various investment options offered by the Plan.

**Vesting** – Participants are 100% vested in their account at all times.

**Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the aggregate balance of other loans within the previous 12 months at the time of the loan. The loans are issued by the Plan and are secured by the balance in the participant's account. All loans must be repaid within a period of five years. Under the terms of the Plan Document, plan loans will bear a reasonable rate of interest determined by the Plan Administrator. Principal and interest are paid ratably through periodic payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 5.25% to 10.50% with various maturities through December 2029.

**Revenue sharing account** – The Plan participates in a revenue sharing agreement with the Plan's trustee, Fidelity Management Trust Company (Fidelity). As such, Fidelity shall make payments (the revenue credit) calculated each quarter and transferred to a suspense account held within Plan assets. The Company may use the revenue credit to pay for fees and expenses associated with services provided to the Plan. Amounts unused for fees and expenses may be allocated to participant accounts provided that such allocation does not occur more frequently than quarterly. Fees paid by the Plan for recordkeeping and administrative services totaling \$155,457 were netted against the income from the Plan's revenue sharing account with Fidelity Management Trust Company for the year ended December 31, 2024.

**Payment of benefits** – On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive their payments as follows:

- a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a partial lump sum;
- purchase a single premium annuity and/or receive equal payments over a period of time limited to five years;

- receive payment in installments, except that the installment period is limited to five years unless termination is due to disability or the participant is age 60 or more;
- purchase and delivery of a single premium nontransferable annuity with payments to the participant for life; or
- purchase and delivery of a single premium nontransferable contingent annuity with payments to participant for life and, upon participant's death, half or full payments to the surviving spouse for life.

**Transfers** – Certain employees customarily change positions within the Company. The change in positions may cause changes in which plan the employee is eligible. When the eligibility changes, plan assets are transferred between the plans.

### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – The investments are reported at fair value. The Plan's trustee, Fidelity Management Trust Company, certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the "exit price") in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The Plan's share of the Northwest Permanente, P.C. Master Trust income consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

**Contributions** – Contributions from participants and corresponding matching contributions are recorded in the year in which the related participant compensation is paid.

**Notes receivable from participants** – Notes receivable from participants are measured at amortized cost, which represents the unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions upon the occurrence of a distributable event, based on the terms of the Plan Document.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – Certain administrative expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Transaction fees and contract administration fees paid by the Plan are netted with the revenue sharing account. Investment related expenses are included in Plan’s share of the Northwest Permanente, P.C. Master Trust income. Fees related to administration of notes receivable from participants are charged directly to the participant’s account and are netted against revenue sharing account.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

#### Note 3 – Investments in Northwest Permanente, P.C. Master Trust

The Plan’s investments are held in the Northwest Permanente, P.C. Master Trust (Master Trust), which was established for the investment of assets of the Plan and several other retirement plans sponsored by Northwest Permanente, P.C. Each participating retirement plan has a divided interest within the Master Trust. The assets of the Master Trust are held by Fidelity Management Trust Company (the Trustee). Investment income and administrative expenses relating to the Master Trust are allocated to the individual plans based upon earnings on account balances of the participants in the Plan.

**Note 4 – Fair Value Measurements of Northwest Permanente, P.C. Master Trust**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies (mutual funds) and exchange traded funds (ETF's)* – Valued at the daily closing price as reported by the fund. Mutual funds and ETF's held by the Plan are open-end and are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds and ETF's held by the Plan are deemed to be actively traded.

*Self-directed brokerage account* – Accounts primarily consist of mutual funds, common stocks, collective trusts, and other investments that are valued on a basis of readily determinable market prices.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5 – Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated May 30, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable sections of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan Administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. It is reasonably possible, given the level of risk associated with investment securities, that changes in the near term could materially affect a participant's account balance and the amounts reported in the financial statements.

#### **Note 7 – Information Certified by the Trustee**

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Plan's share of the Northwest Permanente, P.C. Master Trust income, revenue sharing account income, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Participant loans reflected on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### **Note 8 – Party-in-Interest Transactions**

Master Trust investments include shares of registered investment company funds managed by Fidelity Investments, Inc. Fidelity Management Trust Company is the trustee of the Plan and an affiliate of Fidelity Investments, Inc. and, therefore, transactions with these entities qualify as exempt party-in-interest transactions.

#### **Note 9 – Plan Termination**

Although it has not expressed any intention to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time subject to the terms of ERISA. The Company may request a ruling from the Internal Revenue Service on the effect of termination or discontinuance on the qualification of the Plan. Fidelity Management Trust Company, the trustee of the Master Trust, may decline to distribute the trust fund until the ruling has been issued.
