## Independent Auditor's Report

### ***Opinion***

We have audited the financial statements of Best-One Tire I-I-M Employee Benefit Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), which comprise the statements of net assets available for benefits (cash basis) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (cash basis) for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan (cash basis) as of December 31, 2024 and 2023, and the changes in net assets available for benefits (cash basis) for the years then ended, in accordance with the cash basis of accounting described in Note 2.

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the cash basis of accounting described in Note 2, and for determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances.

Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Note 1. Description of the Plan**

The following description of Best-One Tire I-I-M Employee Benefit Plan (Plan), provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

**General**

The Plan, which became effective January 1, 2008, provides health, life, disability, and other benefits covering certain employees of Best One Tire and Service Employees Association, LLC (Association) and eligible dependents. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. Best One Tire and Service Employees Association, LLC Benefits Committee is the trustee of the Plan.

Effective September 1, 2009, in accordance with guidance from the Internal Revenue Service, the Association elected to spin-off a second voluntary employee beneficiary association (VEBA) trust pursuant to a Plan of Spin-Off and Reallocation. The Plan, now known as the Best-One Tire I-I-M Employee Benefit Plan, was modified to provide certain welfare plan benefits for those employees of the employers who own the Association and who are located within, or related to a controlled group based within, Illinois, Indiana, or Michigan who become participants in the Plan. A second VEBA trust, known as Best-One Tire O-K-T Employee Benefit Plan, was adopted to provide certain welfare plan benefits for those employees of the employers who own the Association and who are located within, or related to a controlled group based within, Ohio, Kentucky, or Tennessee who become participants in the Plan.

**Stop-Loss Coverage**

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). The Plan carries a stop-loss coverage (paid by the Plan) of \$400,000 per eligible participant.

**Payment of Benefits and Premiums**

The Plan provides health benefits for both basic and major medical expenses and prescription drugs to eligible full-time employees (who satisfy an eligibility period of 90 consecutive days of full-time employment) and to covered dependents. The Plan also provides continuation of certain benefits upon termination of employment through the *Consolidated Omnibus Budget Reconciliation Act* (COBRA). The Plan collects and remits health savings account deposits for eligible participants.

Elevance Health (Elevance), formerly Anthem Insurance Companies, Inc., processes claims of participants and dependents. Elevance is also responsible for payments to participants and providers.

Premiums paid by the Plan for dental, vision, and life insurance benefits are recorded as premium payments in the accompanying statements of changes in net assets available for benefits (cash basis).

**Contributions**

The Association makes contributions to the Plan as required to provide for payment of claims and administrative expenses. Active employees are required to make weekly or biweekly contributions to the Plan through payroll deductions.

***Plan Termination***

Although it has not expressed an intention to do so, the Association has the right under the Plan to modify the benefits provided to active employees, discontinue its contributions at any time, and to terminate the Plan, subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Association or be used for purposes other than for the exclusive benefit of the Plan's participants.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The Plan maintains its accounts on the cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Consequently, certain revenue and the related assets are recognized when received rather than when earned, and certain expenses are recognized when paid rather than when the obligation is incurred.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, claims incurred but not reported (IBNR), and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Plan obligations for health claims incurred but not reported are estimated based upon historic claims experience and actual claims reported subsequent to the Plan year-end.

***Cash***

At December 31, 2024, the Plan's cash accounts did not exceed federally insured limits.

At December 31, 2024, the Plan had approximately \$1,784,000 on deposit in an overnight cash sweep account which is collateralized by fixed income securities, but is not subject to FDIC insurance.

***Payment of Benefits***

Premiums paid by either the Association or the VEBA trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. The third-party claims processor processes health benefits for both basic and major medical expenses and prescription drugs of active participants, dependents, and beneficiaries, but the responsibility for payments to participants and providers is retained by the Plan. Short-term disability payments are processed through the Association's payroll system and paid from the general assets of the Association. These payments are recorded as claims paid in the accompanying statements of changes in net assets available for benefits.

**Stop-Loss**

Premiums for stop-loss insurance are included in administrative expenses in the accompanying statements of changes in net assets available for benefits. Stop-loss refunds have been netted with claims paid in the accompanying statements of changes in net assets available for benefits.

**Refunds**

Refunds due from the Plan’s PBM are recorded when earned. Pharmacy rebates totaling \$1,205,663 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

**Administrative Expenses**

Administrative expenses may be paid by the Association or the Plan, at the Association’s discretion.

**Note 3. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Fees for general administration, record keeping, and premiums paid by the Plan to third-party administrators were \$3,774,448 and \$3,720,660 respectively, for the years ended 2024 and 2023. Fees for certain administrative services paid to the Association were \$296,475 and \$215,561 for the years ended 2024 and 2023, respectively.

**Note 4. Benefit Obligations**

**Note 5. Tax Status**

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service dated September 8, 2009, stating that the trust, as then designed, was tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code. However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in the financial statements. The Plan Administrator believes that the Plan and related trust are currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

**Note 6. Subsequent Events**

Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued.
