## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Bartels Lutheran Home Retirement Community 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Bartels Lutheran Home Retirement Community 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Principal Trust Company as of December 31, 2024 and for the period from April 25, 2024 to December 31, 2024 and American Trust Company as of December 31, 2023 and for the period from January 1, 2024 to April 24, 2024 stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Bartels Lutheran Home Retirement Community 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Bartels Lutheran Home Retirement Community 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a single-employer defined contribution plan covering all eligible employees of Bartels Lutheran Retirement Community (a nonprofit organization). Prior to April 1, 2024, all employees of the Organization, excluding Pro Re Nata employees, who have reached the age of eighteen are eligible to participate. Employees hired on or after April 1, 2024, excluding Pro Re Nata employees, who have reached the age of eighteen and have worked two consecutive months are eligible to participate. The Organization will match a portion of their deferral once they have completed one year of service and work 1,000 hours or more during the year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Amendments**

Effective January 1, 2024, there was a restatement of the previously adopted plan.

**Administration**

Effective January 1, 2024, Qualified Plan Consultants, LLC replaced American Trust Retirement Services, LLC as third party administrator of the Plan.

The Plan’s net assets were held by American Trust Company as trustee. On April 25, 2024, the Plan’s assets were transferred to Principal Trust Company, the new custodian.

**Contributions**

Eligible employees may make elective deferral contributions from pretax compensation as defined by the Plan or Roth deferrals, subject to certain limitations under the Internal Revenue Code. At the discretion of the plan administrator, a participant may be permitted to deposit (rollover contributions) in the Plan, distributions from other plans, and certain IRA’s.

For each eligible participant, the employer will contribute a basic safe harbor matching contribution equal to 100% of each participant’s deferral contributions not exceeding 3% of the participant’s compensation, plus 50% of each participant’s deferral contributions in excess of 3% but not in excess of 5%.

**Participant Accounts**

Individual accounts are maintained for each of the Plan’s participants to reflect the participant’s contributions and related employer contributions, as well as the participant’s share of the Plan’s income and any related administrative expenses. Allocations of income and expenses are based on the proportion that each participant’s account balance bears to the total of all participant account balances.

**Vesting**

Participants are immediately vested in their elective deferral contributions, rollover contributions, and basic safe harbor matching contributions, plus actual earnings thereon.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant’s account and bear interest at the prime rate plus 1%, which is commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through bi-weekly payroll deductions.

**Payment of Benefits**

On retirement, death, disability or termination of service, a participant (or a participant's beneficiary in the event of death) may elect to receive a lump sum payment equal to the value of the participant's vested interest in his or her account.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting and Use of Estimates**

The financial statements of the Plan are prepared on the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis of accounting.

**Net Appreciation (Depreciation) in Fair Value of Investments**

Net realized and unrealized appreciation (depreciation) is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain administrative functions are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan. Fees and expenses for the management of collective trust funds by external service providers are paid from plan assets.

NOTE 3 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 and Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

**Level 1 Fair Value Measurements**

Fair values of mutual funds, certain collective trust funds, and pooled separate accounts are determined by reference to quoted market prices and other relevant information generated by market transactions.

**Level 2 Fair Value Measurements**

The fair value of certain collective trust funds for which quoted net asset values are not available are valued using readily available prices on the underlying securities held in the funds. The market values of the underlying securities are totaled and divided by the number of units outstanding to arrive at a unit value.

**NOTE 4 - INVESTMENT CONTRACT WITH FINANCIAL INSTITUTION**

The Plan has entered into an investment contract with Principal Trust Company to maintain the contributions in mutual fund, collective trust fund, and pooled separate accounts. The accounts are credited with earnings on the underlying investments, appreciation or depreciation in fair value, and charged for Plan withdrawals and administrative expenses.

**NOTE 5 - INVESTMENT CONTRACT WITH INVESTOR TRUST COMPANY**

The Plan had a benefit-responsive investment contract with Invesco Trust Company. Invesco Trust Company maintained the contributions in a collective trust fund known as the Invesco Stable Value Trust (Trust). The fund was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract was included in the financial statements at contract value as reported to the Plan by Invesco Trust Company. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

Investment contracts are valued at contract value principally because unitholders are able to transact at contract value when initiating benefit-responsive withdrawals, taking loans or making investment option transfers permitted by the participating plan. A benefit-responsive withdrawal includes a payment to a unitholder arising from retirement, termination of employment, disability or death. In the normal course, unitholder events are predictable (for unitholders as a group) such that the economic integrity of investment contracts is largely unaffected by unitholder withdrawals.

Employer initiated events, if material, may affect the underlying economics of investment contracts. These events include plant closings, layoffs, plan termination, bankruptcy or reorganization, merger, early retirement incentive programs, tax disqualification of a trust or other events. The occurrence of one or more employer initiated events could limit the Trust's ability to transact at contract value with plan unitholders.

For example, retirement benefit payments which occur because an employer has offered a subsidized early retirement program will not transact at contract value unless the scope of the program is not material or the investment contract includes a "contract value corridor". Whether an employer initiated event is probable is foremost within the knowledge of the employer, but in the normal course may be communicated to the investment manager of the Trust. While the investment manager may take action to minimize or eliminate the impact of the employer initiated event, there is no assurance that the issuer will continue to transact at contract value once the corridor is used. In that case, the Trust would be unable to maintain the ability to transact at contract value.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The average yield was approximately 4.984% for 2024 and crediting interest rate was approximately 3.299% for 2024. The crediting interest rate was based on a formula agreed upon with the issuer, but may not be less than zero percent. Such interest rates were reviewed on a quarterly basis for resetting. The balance of the benefit-responsive investments was none and \$551,506 at December 31, 2024 and 2023, respectively, and is included in investments at contract value on the statements of net assets available for benefits.

**NOTE 6 - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain administrative functions are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan. Fees and expenses for the management of collective trust funds by external service providers are paid from Plan assets.

Certain Plan investments are shares of collective trust funds managed by American Trust Company, the previous trustee and Principal Trust Company, the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for investment management services were \$10,837 paid to American Trust Company and \$20,121 paid to Principal Life Insurance Company for the year ended December 31, 2024.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 8 - INCOME TAX STATUS

The Organization has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon an examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 10 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 11 - SUBSEQUENT EVENTS**

The date to which events occurring after December 31, 2024, the date of the most recent statement of net assets available for benefits, have been evaluated for possible adjustment to the financial statements or disclosure is October 8, 2025, which is the date the financial statements were available to be issued.

**NOTE 12 - NONEXEMPT TRANSACTIONS**

During the year ended December 31, 2024, the Organization made late participant contributions totaling \$59,916, which the Plan reported in Schedule H, Part 4 of the Form 5500. The Organization is required to remit to the Plan lost earnings in the amount of \$307. As a result of the late contributions, the Organization is required to pay a 15% excise tax on the lost earnings in the amount of \$46.
