INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the Davis Tool, Inc. Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Davis Tool, Inc. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Davis Tool, Inc. Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section—

- the amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of Davis Tool, Inc. Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Davis Tool, Inc. NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following description of the Davis Tool, Inc. Profit Sharing Plan (the “Plan”) provides general information only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – Established in 1986, the Plan is a defined contribution plan covering all eligible employees meeting certain length of service requirements of Davis Tool, Inc., (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Company functions as the Plan sponsor and serves as plan administrator. The Company is responsible for the control and management of Plan operations and administration. The Plan Retirement Committee is responsible for oversight of the Plan including monitoring investment performance and reviewing investment offerings.

Participation – Employees of the Company are eligible to participate for purposes of salary deferrals and employer contributions upon completing three consecutive months and at least 450 hours of service from the date of hire. Employees that do not meet the 450-hour minimum service requirement during the first three consecutive months of employment, are subject to a minimum one year and 1,000 hours of service requirement. Union, temporary, seasonal and leased employees are not eligible to participate in the Plan.

Participants may enter the Plan on the first day of the quarter following once they have met the eligibility requirements.

Participant contributions – Generally, participants may make deferral elective contributions of up to 100% of their pretax annual compensation, as defined in the Plan, subject to Internal Revenue Code (“IRC”) limitations of \$23,000 for the year ended December 31, 2024, and non-discrimination tests required by the Internal Revenue Service. Participants age 50 and older may make additional catch-up contributions not to exceed \$7,500 during the year ended December 31, 2024. Participants may also rollover pre-tax monies representing distributions from other qualified defined benefit or contribution plans into the Plan.

Employer contributions – The Company will make employer safe harbor matching contributions of up to 4% of employee contributions. The Company may also make discretionary profit sharing contributions which are allocated to participants in the same proportion as a participant’s compensation bears to the total of all participants’ compensation. Participants must complete at least 1,000 hours of service during the Plan year and be employed as of the last day of the Plan year to be eligible to receive employer discretionary contributions. Participants who have terminated employment prior to the last day of the Plan year due to death, total and permanent disability or normal retirement are eligible to receive employer discretionary contributions. There were no profit sharing contributions for the year ended December 31, 2024. Employer contributions are subject to regulatory limitations.

NOTES TO FINANCIAL STATEMENTS

1. Description of Plan (continued)

Participant accounts – A separate account is maintained for each participant which records the participant’s contributions, the safe harbor matching employer contributions, the discretionary employer profit sharing contributions, account earnings and an allocation of Plan administrative expenses. Allocation of Plan earnings is based upon participant account balances. Employer safe harbor matching contributions are allocated based on the participant’s eligible compensation deferred into the Plan. Employer discretionary profit sharing contributions are allocated based on the participant’s eligible compensation. The benefit to which a participant is entitled is the vested amount in their individual account. Participants may invest in various mutual funds.

Vesting – Participants are immediately vested in their voluntary contributions and safe harbor matching employer contributions plus actual earnings thereon. Discretionary employer profit sharing contributions and actual earnings thereon vest as follows, as defined by the Plan:

Participants that are employed by the Company upon death or total and permanent disability become immediately 100% vested.

Notes receivable from participants – Participants may borrow funds from their accounts up to a maximum of 50% of the participant’s vested account balance or \$50,000. A minimum loan of \$1,000 is required. The loans are secured by the balance in the participant’s account and earn interest at a fixed rate as determined by the plan administrator. Current interest rates range from 4.25% to 9.50%. Loan repayments are made ratably through payroll deductions over a period not to exceed five years, unless the loan is to purchase a primary residence.

Payments of benefits – Upon termination of employment, retirement, death or disability, a participant may receive a lump-sum amount equal to the value of the participant’s vested interest in their account. To meet minimum distribution requirements under IRC 401(a)(9), a participant may elect to receive substantially equal installments or a partial withdrawal of not less than \$50,000. Participants may also elect to keep their account in the Plan until a future date. The Plan does not provide for hardship distributions.

1. Description of Plan (continued)

Forfeited accounts – Upon a participant’s termination, the unvested portion of the participant’s discretionary employer contributions is forfeited. Forfeitures may be used to reduce employer contributions or pay plan expenses. During the year ended December 31, 2024, \$5,903 in forfeited non-vested account balances were used to reduce safe harbor matching employer contributions. Non-allocated forfeited non-vested account balances amounted to \$0 as of December 31, 2024 and 2023, respectively.

Investment options – Upon enrollment in the Plan, a participant may direct employee and employer contributions to any of 30 investment options offered through T. Rowe Price Group, Inc. Participants may change their investment options or reallocate their account balances on a daily basis.

2. Summary of significant accounting policies

Basis of accounting – The Plan financial statements and accompanying notes are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of estimates – The preparation of the financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see *Note 3*).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The change in value of investments is recorded by the Plan as appreciation or depreciation in the fair value of investments. Unrealized appreciation or (depreciation) of the investments is included in current operations and in the change in net assets available for benefits. Net appreciation (depreciation) in the fair value of investments includes management and operating expenses associated with the Plan’s investments in mutual funds.

2. Summary of significant accounting policies (continued)

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Loan fees charged to participant accounts are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments, and if it is not cured timely, eventually the loan is deemed to be in default and a deemed distribution may be recorded.

Contributions – Employer and participant contributions are accrued by the Plan in the year in which they are withheld from compensation or become obligations of the Company. It is the Company's policy to fund currently all amounts due to the Plan.

Payment of benefits – Benefits are recorded when paid.

Administrative fees and investment expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from the financial statements.

Fees and expenses charged to the Plan fall into three basic categories:

- Investment fees are generally assessed as a percentage of assets invested, and are deducted directly from participant investment returns.
- Plan administration fees covering the day-to-day expenses of the Plan for services such as recordkeeping and trustee services are deducted directly from investment returns.
- Transaction-based fees associated with optional services offered under the Plan are charged directly to the participant utilizing the optional service.

Investment fees are included in net appreciation or depreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits.

3. Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Accounting Standards Codification (“ASC”) Topic No. 820, *Fair Value Measurements*, are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 inputs must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in methodology used as of December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related party transactions

Certain Plan investments are shares of mutual funds managed by T. Rowe Price Group, Inc., which is an affiliate of T. Rowe Price Retirement Plan Services, Inc., the transfer agent and custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in net appreciation in fair value of mutual funds.

The Company pays directly for certain expenses related to the Plan's operations.

The Company's majority shareholder is an officer of the Company and participates in the Plan.

6. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect the amounts reported in the Plan's statements of net assets available for benefits.

7. Tax status

The Internal Revenue Service (“IRS”) has determined and informed DST Retirement Solutions, LLC, by an Opinion Letter dated June 30, 2020, that the Plan, a volume submitter profit sharing plan, and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended and restated since receiving the letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there was no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the Plan’s financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process. As of December 31, 2024, the Plan’s tax years ended December 31, 2021 and forward remain subject to examination by the IRS.

8. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants will become 100% vested in the employer contributions.

9. Subsequent events

The Plan has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued.

In accordance with the Secure 2.0 Act, effective January 1, 2025, the catch-up limit for participants aged 60 to 63 is \$11,250.
