### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of BARD Materials 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of BARD Materials 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).



**NOTE 1 DESCRIPTION OF THE PLAN**

The following description of the BARD Materials Retirement Plan (the Plan) provides only general information. The Plan is a defined contribution plan established on January 1, 2001 (restated July 1, 2020) sponsored by Dyersville Ready Mix, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**Participation**

All employees are eligible to participate in the Plan after completion of 500 hours of service within a six-month time period and having attained 19 years of age. To receive the Company match and nonelective Company contribution (the discretionary contribution), a participant must be 19 years of age and have one year of service. A year of services is defined by the Plan document as 1,000 hours of service per Plan year.

**Contributions**

Participants may contribute up to 100% of their annual compensation as defined by the Plan under a salary reduction agreement or through a Roth 401(k) after tax option. Participant contributions cannot exceed the federal statutory limits of \$23,000 and \$22,500 in 2024 and 2023, respectively. Upon a qualifying distribution, Roth after-tax accounts earnings are tax free.

A discretionary contribution is determined by the Board of Directors of the Company on an annual basis. For the years ended December 31, 2024 and 2023, the Company's discretionary contribution was 3% of the employee's gross wages.

For the years ended December 31, 2024 and 2023, the Company matching contribution was 50% of the first 6% of eligible compensation deferred that a participant contributed to the Plan.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as indexed by the Internal Revenue Service. Participants direct all contributions into investments of their choice based upon options offered by the Plan.

**Participant Accounts**

Each participant's account is credited with participant contributions, an allocation of the Company's contribution, Plan earnings and Plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan.

**Vesting and Forfeitures**

Voluntary employee contributions and earnings thereon are immediately vested. Employees are vested in Company contributions and earnings thereon based on their years of service and become fully vested upon six years of service. Participants can also become fully vested in the Company's contributions upon death, total disability, normal retirement of the participant at age 65, or the termination of the Plan. For the years ended December 31, 2024 and 2023, forfeited nonvested accounts totaling \$7,264 and \$13,574, respectively, were used to reduce Company contributions. As of December 31, 2024 and 2023, the forfeiture balance was \$27,039 and \$19,037, respectively.

**Notes Receivable from Participants**

The Plan allows participants to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance only for permitted purposes. A participant may only have one note with an outstanding balance at a time with repayment within five years, or, if a qualifying home loan, 10 years. The notes are secured by the balance in the participant's account and bear interest at a rate equal to 2% above the USA Today prime rate. Principal and interest is paid ratably through payroll deductions.

**Payments of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or installments. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. The net appreciation in fair value of investments includes investments purchased, sold and held during the year plus dividends reinvested. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Capital Bank and Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of investments and notes receivable from participants as of December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, in the accompanying financial statements and ERISA-required supplemental schedule.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs other than quoted prices included within Level 1 that are observable for the asset or liability either directly or indirectly such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund:* Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

**NOTE 5 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. Upon termination, all participants will become fully vested in their accounts.

**NOTE 6 INCOME TAX STATUS**

The Plan is placing reliance on an opinion letter received from the IRS on the prototype plan indicating that the Plan is qualified under section 401 of the IRC and is therefore not subject to tax under current income tax law. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 TRANSACTIONS WITH PARTIES-IN-INTEREST**

Administrative fees were paid out of the general assets of the Company for maintenance of investment, contribution and distribution records and for the processing of related transactions.

Plan investments are managed by American Funds. American Funds in the third-party administrator, therefore, these transactions qualify as party-in-interest transactions.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
