We have performed audits of the financial statements of the Missouri Aggregates 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of the Missouri Aggregates 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General: The Plan is a safe harbor defined contribution plan covering employees of Farmer Holding Company, Inc. and other companies related through common ownership (the Company). The Plan was established January 1, 2004, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was amended and restated in November 2023 to transfer the assets and participants of Folsom Ready Mix, Inc. and Silver Strike Nevada, LLC from the Emplicity 401(k) Retirement Savings Plan into the Plan. As a result of the amendment, \$139,999 in assets were transferred into the Plan during 2023, and \$4,238,262 in assets were transferred into the Plan during 2024. In addition, Folsom Ready Mix, Inc. and Silver Strike Nevada, LLC became adopting employers of the Plan effective November 6, 2023.

During the year ended December 31, 2023, the Company acquired Sierra Ready Mix, LLC. However, the transfer of assets and participants of Sierra Ready Mix, LLC from the Summit Materials 401(k) Retirement Plan did not occur until 2024. Participants from Sierra Ready Mix, LLC were added to the Plan in January 2024 and \$1,849,368 in assets were transferred into the Plan in March 2024. In addition, Sierra Ready Mix, LLC became an adopting employer of the Plan effective January 1, 2024.

The Plan was amended and restated in July 2024 to transfer the assets and participants of P&L Concrete, Inc. from the P&L Concrete Products, Inc. 401(k) Profit Sharing Plan & Trust into the Plan. As a result of the amendment, \$1,919,425 in total assets were transferred into the Plan. In addition, P&L Concrete, Inc. became an adopting employer of the Plan effective July 1, 2024.

Eligibility: Employees who have completed three months of consecutive service and have attained the age of 18 are eligible to participate in the Plan.

Contributions: Participants may contribute a portion of pre-tax and post-tax annual compensation, as defined in the Plan, not to exceed maximum amounts specified by the IRS, in accordance with a participant salary deferral agreement. Participants who are at least 50 years of age may make an additional contribution to the Plan not to exceed \$7,500 in 2024 and 2023, under certain conditions. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Company is required to make an enhanced match equal to 100% of each participant's deferral contributions, not to exceed 4% of participant salary. The Company met the required funding minimum. Participants direct the investment of contributions into various investment options offered by the Plan.

Participant accounts: Each participant's account is credited with the participant's contributions, Company contributions, Plan earnings, the participant's rollover contributions from other qualified benefit plans, if any, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are automatically 100% vested in both their elective salary deferrals and the Company's safe harbor contributions.

Notes receivable from participants: Notes receivable from participants were transferred into the Plan upon the merger of the Capital Quarries Company, Inc. 401(k) Profit Sharing Plan effective January 1, 2018, from participants of Razorback Concrete Company from the Summit Materials 401(k) Retirement Plan effective January 1, 2022, from participants of Folsom Ready Mix from the Emplicity 401(k) Retirement Savings Plan effective November 6, 2023, and from participants of P&L Concrete, Inc. from the P&L Concrete Products, Inc. 401(k) Profit Sharing Plan & Trust effective July 1, 2024. No other loans are permitted by the Plan. The loans are secured by the balance in the participant's account and bear interest at a rate that is commensurate with local prevailing rates. Principal and interest are payable ratably through payroll deductions.

Payment of benefits: Upon termination of service, a participant or his/her beneficiary may receive benefit distributions in the form of a single lump sum payment (required for vested balances less than \$7,000), which may be in the form of a cash payout or rolled over into another qualified pension plan.

Administration: TPP Retirement Plan Specialists, LLC (TPP) is the Plan's third-party administrator and record-keeper for participant accounts. Matrix Trust Company is the Plan's custodian. The custodian holds the Plan's assets, administers investment activity, and invests contributions into funds designated by each participant. The record-keeper provides general professional and administrative services related to the Plan and reports to the Plan administrator and the participants. Certain administrative and record-keeping costs are being paid by the Company. The Company's Board of Directors is responsible for the oversight of the Plan.

The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors the investment performance, and reports to the Company's Board of Directors.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Valuation of investments: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade date basis. Realized investment gains and losses are determined on the specific identification basis. Dividends are recorded on the declaration date. Interest is recorded when earned. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities of the Plan are exposed to various risks, such as interest rates, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Contributions: Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services. Investment related expenses are included in net appreciation in fair value of investments.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent events: Events that have occurred subsequent to December 31, 2024, have been evaluated through October 2, 2025, which represents the date the Plan's financial statements were approved by management and, therefore, available to be issued.

3. TERMINATED PARTICIPANTS

Net assets available for benefits at December 31, 2024 and 2023 included \$6,395,187 and \$4,360,702 respectively, allocated to the accounts of individuals who, as of or prior to that date, had withdrawn from actively participating in the operations of the Plan, generally as a result of terminating employment. These amounts are available to be paid, upon request of the terminated participant, after the end of the fiscal year. These participants receive no further contributions but do receive allocations of investment income and Plan expenses.

4. TAX STATUS

The Plan adopted a Cycle 3 Restatement effective January 1, 2022, as an amendment and restatement of the existing plan to bring the Plan into compliance with legislative and regulatory changes. There were no significant changes to plan provisions as a result of the restatement. The Internal Revenue Service (IRS) has determined and informed TPP by a letter dated June 30, 2020, that the non-standardized pre-approved profit sharing plan is designed in accordance with applicable sections of the IRC.

The Company may rely on the opinion letter issued by the IRS as evidence that the Plan is qualified under the applicable sections of the IRC. The Plan is relying on the opinion letter.

The Plan was amended effective November 6, 2023 and July 1, 2024, to include additional adopting employers to the Plan. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

6. CERTIFICATION OF INVESTMENT INFORMATION

Certain information in the accompanying financial statements and the ERISA-required supplemental schedule of assets held at year-end related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and dividend income for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company, a qualified institution.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

7. FAIR VALUE OF INVESTMENTS

Plan investments are held in a trust and managed by the Plan's custodian and are unsecured. All investments are participant-directed and held by parties-in-interest.

A fair value hierarchy is used that prioritizes the inputs to valuation techniques used to measure fair value of balances that are required or permitted to be measured at fair value for reporting in financial statements. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to the unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1	Valuation is based upon quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access.
Level 2	Valuation is based upon quoted prices for similar assets or liabilities in active markets, quoted market prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. Observable inputs may include interest rates, foreign exchange rates, and yield curves that are observable at commonly quoted intervals.
Level 3	Valuation is based on methodologies that are unobservable and significant to the fair value measure. These may be generated from model-based techniques that use at least one significant assumption based on unobservable inputs for the asset or liability, which are typically based on an entity's own assumptions, as there is little, if any, related market activity.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the asset or liability. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of valuation methodology used for assets recorded at fair value.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund on an active market, which is based on the underlying net asset value (NAV) of the shares held by the Plan at year-end. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the NAV of the units of a bank or trust company collective trust held by the Plan at year-end. The Matrix Trust Multi-Manager Stable Value Fund invests primarily in high quality stable value investment contracts issued by insurance companies. The fund publishes its daily NAV in an active market and transacts at that price.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include transactions with fiduciaries or employees of the Plan, any person providing services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of such an employer, and relatives of parties-in-interest. The Plan has various parties-in-interest. Investments are held with parties-in-interest and certain fees are paid to parties-in-interest.

9. PROHIBITED TRANSACTIONS

The DOL considers late deposits of employee contributions to be nonexempt prohibited transactions. During the year ended December 31, 2024, the Company inadvertently failed to remit certain January 2024, February 2024, and October 2024 employee deferrals totaling \$27,085 and participant loan repayments totaling \$2,943 to the Plan. The Company remitted the employee deferrals and participant loan repayments to the Plan in January 2024, February 2024, October 2024, and November 2024, respectively. The Company paid \$140 in missed earnings to the Plan related to the late employee deferrals in May 2025. The Company paid \$13 in missed earnings to the Plan related to the late participant loan repayments in September 2025.

During the year ended December 31, 2023, the Company inadvertently failed to remit certain February 2023 and April 2023 employee deferrals totaling \$47,869 within the time frame required by the DOL under plan asset rules. The Company remitted the employee deferrals to the Plan in March 2023 and April 2023, respectively. The Company paid \$131 in missed earnings to the Plan in June 2024.
