- the information in the accompanying financial statements related to assets held by and certified to by the qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to the participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audits* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. - conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters we identified during the audit.

#### **Other Matter—Supplemental Schedule Required by ERISA**

The supplemental schedule included in the accompanying table of contents is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Description of the Plan

PDF Solutions, Inc. (the Company) established the PDF Solutions, Inc. 401(k) Plan (the Plan), effective January 1, 1999, to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan, as amended and restated, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General:*

The Plan is a defined contribution plan under appropriate provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and the Plan administrator. A 401(k) committee, consisting of Company employees, has been appointed by the Company's Board of Directors to oversee the Plan's investments and their performance. Fidelity Management Trust Company (Fidelity) is the Plan trustee and record keeper. Fidelity is authorized to invest, manage, and reinvest Plan assets, pay benefits and ensure proper accounting records are maintained. The Company has engaged Captrust as an investment advisor. Captrust assists the Plan Committee in selecting investment options offered under the Plan and monitoring investment performance.

#### *Eligible Participants:*

Company employees, as defined by the Plan agreement, age 21 or older, may participate in the Plan immediately following their date of hire.

#### *Contributions:*

Participants may make voluntary pre-tax salary deferrals, Roth post-tax, or after-tax contributions up to 60% of annual compensation, as defined by the Plan agreement. In addition, participants who have reached the age of 50 can elect to withhold additional catch-up contributions under the Code. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Company may make discretionary matching contributions, as determined by the Company's Board of Directors. The Company made matching contributions of \$1,743,199 to the Plan in 2024, of which \$140,490 was receivable at December 31, 2024. The match represents up to 100% of each eligible participant's contribution on the first 3% of the participant's eligible compensation, plus 50% of each eligible participant's contribution, for the participant's eligible compensation above 3% but not to exceed 5%.

### 1. Description of the Plan (continued)

#### *Contributions:* (continued)

Contributions are subject to certain limitations under the Code.

#### *Participant Accounts:*

Participant accounts are credited with participant contributions and rollovers, and an allocation of Company contributions, plus earnings (less any losses) thereon. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant vested account balances.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

#### *Vesting:*

Participants are immediately vested in their contributions, plus earnings (less any losses) thereon. Vesting in Company discretionary contributions, plus earnings (less any losses) thereon, begins after one year of service. Participants become fully vested after four years of service or upon retirement, disability or death.

#### *Notes Receivable from Participants:*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

Participants may borrow up to one-half of their vested account balance, a minimum of \$1,000 and not to exceed \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which a term of up to ten years may be granted. Participant notes are evidenced by a written note, secured by the balance in the participant account, and bear interest at a rate commensurate with local prevailing rates, as determined by the 401(k) committee under the Plan's note policy. A participant may have only two notes outstanding at any time. Interest rates on notes outstanding at December 31, 2024 range from 4.25% to 9.50%. Repayment of principal and interest is generally made through payroll deductions.

### 1. Description of the Plan (continued)

#### *Payment of Benefits:*

On termination of service, benefits are paid to participants in a lump-sum cash distribution equal to the value of the participant vested interest in their accounts or, if elected by the participants, in installments. All distributions are subject to the applicable provisions of the Plan agreement. Benefits are recorded when paid.

Accounts between \$1,000 and \$7,000 may be automatically distributed to individual retirement accounts on behalf of the participants, without participant approval.

#### *Administrative Expenses:*

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the Plan's financial statements. Certain account maintenance and participant note fees are paid by the Plan and charged directly to participant accounts. The Company pays all other expenses related to the Plan, which are not reflected in the Plan's financial statements.

The Company participates in a revenue credit program offered by Fidelity. Under this program, a plan is eligible to receive a fixed annual credit based on Fidelity's revenue target for the Plan and on certain plan characteristics. The revenue credit is allocated quarterly into a plan-level suspense account, which can be used to reimburse administrative expenses paid to Fidelity or other third-party providers. At the Plan sponsor's discretion, unused credits can be allocated ratably to participant accounts or used to offset future plan expenses. The amount of the revenue credit the Plan received in 2024 was not material to the financial statements.

#### *Risks and Uncertainties:*

The Plan offers a variety of investment options to participants. Investments are exposed to various risks, such as interest rate, market fluctuation and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the financial statements.

#### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts and distributions would be made to participants as described in the Plan agreement.

#### *Forfeitures:*

Forfeitures of non-vested Company contributions may be used to reduce future Company contributions or to pay Plan expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$93 and \$1,431, respectively. During 2024, forfeitures of \$1,510 were used to reduce employer contributions.

### 2. Summary of Accounting Policies

#### *Basis of Accounting:*

The Plan prepares its financial statements on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates:*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

#### *Investments:*

Investments are comprised of mutual funds and money market funds valued at the net asset value (NAV) of shares held by the Plan at year end based on quoted prices in active markets.

#### *Fair Value Measurement:*

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability at the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

*Fair Value Measurement:* (continued)

The three-level hierarchy for fair value measurement is defined as follows:

**Level I:** Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

**Level II:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

**Level III:** Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

The Plan's investments are classified as Level I within the fair value hierarchy at December 31, 2024 and 2023.

*Income Recognition:*

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on the Plan's investments bought, sold or held during the year.

### 3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net appreciation in fair value of investments, dividends and interest, and interest on notes receivable from participants on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

### 4. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan has been amended and restated since receipt of the letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires Plan management to evaluate income tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain income tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain income tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes Plan years after 2021 remain open to income tax examinations.

5. Party-In-Interest Transactions

Certain Plan investments are offered by Fidelity, the Plan’s trustee. Purchases and sales of these investments qualify as party-in-interest transactions. Notes receivable transactions with participants also qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules under ERISA.
