## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Kiva Microfunds 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Kiva Microfunds 401(k) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Ascensus Trust Company, the trustee and custodian of the Plan, which is a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

### Note 1 - Description of Plan

#### General

Effective January 1, 2007, Kiva Microfunds (the "Organization", "Plan Administrator", and "Plan Sponsor") adopted a defined contribution profit sharing 401(k) plan, Kiva Microfunds 401(k) Profit Sharing Plan and Trust (the "Plan"), covering all eligible employees of the Organization. The Plan has no service requirement for eligibility.

The Plan was amended and restated on June 15, 2021.

The following description of the Plan provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Administration

The Plan Sponsor has appointed the Organization's Director of Accounting Operations as a limited trustee to manage the operations and administration of the Plan. The Organization contracted with Ascensus Trust Company ("Ascensus Trust") as the Plan trustee and custodian during 2024 and 2023. Ascensus, LLC ("Ascensus") and the Vanguard Group, Inc. ("Vanguard") together acted as third-party administrators to process and maintain the records of participant data and monitor compliance with governmental regulatory requirements for the years ended December 31, 2024 and 2023.

#### Contributions

Each year, participants may elect to defer up to 100% of their annual gross compensation as defined in the Plan Document. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan Document also permits Roth 401(k) contributions into the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers investments in mutual funds to its participants. The Organization provides a matching contribution of 100% of the participant's deferral up to \$2,500 per year. The Organization is also allowed to make discretionary profit sharing contributions as defined in the Plan Document. There were no discretionary profit sharing contributions for the years ended December 31, 2024 and 2023. For the years ended December 31, 2024 and 2023, the Organization made matching contributions totaling \$260,458 and \$272,548, respectively. All contributions are subject to certain IRS limitations.

#### Participant accounts

Each participant's account is credited with the participant's contributions, Plan Sponsor discretionary profit sharing and matching contributions, as well as allocations of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

### Note 1 - Description of Plan (continued)

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants also vest immediately in the Organization's matching and discretionary profit sharing contributions, plus actual earnings thereon.

#### Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of the following: (i) \$50,000, or (ii) one-half of the vested account balance. For loans qualifying under the Coronavirus Aid, Relief, and Economic Security (CARES) Act, the dollar limit is \$100,000 or 100% of the participant's account balance. The loans are secured by the balance in the participant's account and bear interest at prime plus 1%. The interest rate for loans outstanding as of December 31, 2024 ranged from 9.25% to 9.50%, which is commensurate with local prevailing rates as determined by the Plan Sponsor. Loan terms range up to five years and may exceed five years for the purchase of a primary residence. A participant may only have one loan outstanding at any given time. Principal and interest are paid ratably through payroll deductions.

#### Payment of benefits

Upon reaching the age of 59½ and at the discretion of the participant or upon termination of service due to death, disability, or retirement, a participant or the designated beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Upon termination, if the participant's or beneficiary's vested account balance is \$5,000 or less, the Plan allows the trustee to distribute the vested account balance to an Individual Retirement Account ("IRA") for the participant's benefit. Effective March 19, 2024, this limit was increased to \$7,000.

Vested balances of \$1,000 or less will be distributed as a lump-sum amount without the participant's consent.

### Note 2 - Summary of accounting policies

#### Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

### Note 2 - Summary of accounting policies (continued)

#### Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded on the basis of the terms specified in the Plan Document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### Payment of benefits

Benefits are recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and issuance of distributions are charged directly to the participant's account and are reflected in administrative expenses of \$4,066 and \$2,200 for the years ended December 31, 2024 and 2023, respectively. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each investment fund and charged ratably to participant accounts.

Pursuant to a revenue sharing arrangement under the Plan, Vanguard receives asset-based fees calculated at 10-50 basis points of the invested assets, a portion of which is credited to the Plan to pay expenses.

#### Subsequent events

In preparing its financial statements, the Plan has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified investments

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust, a qualified institution.

The Plan's investments in mutual funds and money market funds (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$2,620,307 and \$2,593,887 during 2024 and 2023, respectively.

### Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. The Plan's investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The Plan's investment in the Vanguard Cash Reserves Federal Money Market Fund is valued at quoted prices in active exchanges.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

No assets were noted at Levels 2 and 3 as of December 31, 2024 and 2023. There have been no changes in the methodologies used at December 31, 2024 and 2023.

### Note 5 - Rollover contributions

During 2024, rollover contributions of \$509,379 from other plans were from six active participants. During 2023, rollover contributions of \$162,888 from other plan were from four active participants.

### Note 6 - Related party transactions and party-in-interest transactions

Ascensus Trust is the trustee and custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan has contracted with Ascensus and Vanguard as the recordkeepers and Vita Planning Group as the investment advisor for 2024 and 2023. Refer to **Note 2 - Expenses** for expenses of the Plan paid by the Plan Sponsor and plan participants to these parties-in-interest. All these transactions are considered party-in-interest transactions under ERISA regulations but are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

### Note 7 - Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

## Notes to Financial Statements

December 31, 2024 and 2023

### Note 8 - Tax status

The Internal Revenue Service has determined and informed Ascensus by letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Trustees and the Plan's tax counsel believe that the Plan is designed in compliance with the applicable requirements of the IRC. The Organization will correct the errors related to the underfunding of employee deferrals and employer matching contributions (see Note 10). The Organization does not expect these inconsistencies to affect the Plan's tax-exempt status.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position not likely to be sustained upon examination by taxing authorities and government agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### Note 9 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks related to geopolitical tensions, economic instability, and changes in international trade policies, including the imposition of new tariffs, could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### Note 10 - Plan compliance matter

During the year ended December 31, 2023, it was discovered that the definition of eligible compensation was not consistently applied for calculating employee deferrals. The corresponding qualified non-elective contribution of \$1,168 was funded on December 29, 2023.

During the year ended December 31, 2024, it was discovered that the employer matching contribution of one participant was underfunded. In addition, it was discovered that there was an error in the deferral calculation for another participant, which resulted in the underfunding of employee deferrals. The effect of these errors will be recognized in the period the corresponding qualified non-elective contributions are funded by the Plan.

### Note 11 - Prohibited transaction

During the years ended December 31, 2024, 2023, and 2022, the Organization failed to remit participant contributions to the Plan in a timely manner. The Organization identified several instances of employee deferrals, including loan repayments, totaling \$268,656, which was remitted late to the Plan in violation of Department of Labor regulations. The Organization will reimburse the Plan participants for lost investment earnings.
