### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

- the amounts and disclosures in the accompanying Financial Statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("US GAAP").
- the information in the accompanying Financial Statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### ***Supplemental Schedules Required by ERISA***

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

#### NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Veritas Investments 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### *GENERAL*

The Plan, established on January 1, 2018, is a defined-contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Employees of Veritas Investments, Inc, (the “Employer”, “Company”, or “Plan Sponsor”), are eligible to participate in the Plan on the first day of the month following three months of service, except for part-time, temporary or seasonal employees whose regularly scheduled service is less than 1,000 hours for the year.

Effective on December 29, 2022, the Setting Every Community Up for Retirement Enhancement (“SECURE”) 2.0 Act of 2022 was signed into law. The SECURE 2.0 Act is inclusive of approximately 90 provisions which offer many new benefits to employers and Plan participants. Certain provision changes are related to the following, but not limited to: changes to auto-enrollment and auto-escalation, age of required minimum distributions, catchup contributions, and increased dollar threshold for mandatory distributions. Depending on the specific provision, some will take effect immediately, while others begin in a future year. During 2023, the Plan adopted certain provisions of the SECURE 2.0 Act. During 2024 the Plan is in the process of formally amending the Plan.

#### *CONTRIBUTIONS*

Each year, participants may elect to contribute up to 90% of their eligible compensation on a pretax or post tax basis (“Roth”), not to exceed annual limits established in the Internal Revenue Code (“IRC”). For the year ended December 31, 2024, participant contributions were subject to an overall annual limitation of \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions up to \$7,500 (“Catchup Contributions”). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“Rollovers”). Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2024, the Plan was amended to make the Sponsor matching contribution discretionary, except for catch up contributions. Through March 31, 2024, the Plan Sponsor made matching contributions to eligible participants equal to 100% of the participant’s elective deferrals up to 4% of a participant’s compensation. Effective April 1, 2024, the Plan Sponsor suspended all Employer matching contributions until further notice. Matching contributions were calculated every pay period and trued up at the end of the year for participants that are still employed by the Company at that time. Employer matching contributions to the Plan amounted to approximately \$89,000 for the year ended December 31, 2024.

#### NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

##### *PARTICIPANT ACCOUNTS*

Each participant's account is credited with the participant's contributions, Rollovers, and the Employer's matching contributions and earnings or losses from participant-directed investments, net of administrative expenses incurred by the participant, if any. Allocations are based on participant earnings or account balances, as defined by the Plan document. The benefit to which a participant is entitled at termination or retirement is the benefit that can be provided from the vested portion of the participant's account.

##### *VESTING*

Participants are vested immediately in their voluntary contributions, including Rollovers, plus actual earnings thereon. Vesting in the Employer's matching contributions and earnings thereon vest in accordance with the following schedule:

The Plan provides for 100% vesting of Employer's matching contributions and earnings thereon upon death, disability, or attainment of retirement age, as defined.

##### *NOTES RECEIVABLE FROM PARTICIPANTS*

The Plan allows participants to borrow against their vested balances (minimum loan of \$1,000). The interest rate charged is based on the prime rate plus 1%, as determined at the time of the loan. As of December 31, 2024, the interest rates on outstanding loans ranged from 6.50% to 9.50%. The maximum amount available for loans is the lesser of 50% of the participant's vested account balance or \$50,000. Participants may only have one loan outstanding at any time. Loan repayment periods are for a maximum of five years, unless the loan is used to purchase a participant's principal residence, in which case repayment must be made within thirty years. Loans are secured by the participant's account balance. Loan repayments are made through payroll deductions.

#### NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

##### *PAYMENT OF BENEFITS*

Upon termination of service, death, disability, retirement, or upon attainment of age 59 1/2, the participant or the named beneficiary may elect to receive a lump sum equal to the vested value of his or her account or elect among various options to receive monthly installments over a specified amount of years. If the Participant's vested account balance is less than \$5,000 at the termination date, then the balance may be distributed in a single lump-sum payment.

##### *HARDSHIP WITHDRAWALS*

A participant who is experiencing a financial hardship, as defined in the plan document, may request a withdrawal of all or any portion of such participant's vested account. For the year ended December 31, 2024, hardship withdrawals amounted to approximately \$69,000, which is included in benefits paid to participants in the accompanying statement of changes in net assets available for benefits.

##### *FORFEITURES*

Forfeitures are those amounts for which a participant is not fully vested at the time of termination. Forfeitures may be used to offset future Plan Sponsor contributions or pay administrative expenses of the Plan. There were approximately \$21,000 of forfeitures applied to offset Plan Sponsor matching contributions during the year ended December 31, 2024. Forfeited accounts available at December 31, 2024 and 2023 amounted to approximately \$9,000 and \$7,000, respectively.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### *BASIS OF ACCOUNTING*

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### *USE OF ESTIMATES*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes herein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *INVESTMENT VALUATION AND INCOME RECOGNITION*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan valuation policies utilizing information provided by the investment advisor and trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *NOTES RECEIVABLE FROM PARTICIPANTS*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses have been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are treated as distributions based upon the terms of the plan document.

##### *EXCESS CONTRIBUTIONS PAYABLE*

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Services ("IRS") are recorded as a liability with a corresponding reduction to contributions. As of December 31, 2024 and 2023, the Plan had excess contributions payable of approximately \$97,000 and \$156,000, respectively, which was distributed subsequent to each respective year-end.

##### *PAYMENT OF BENEFITS*

Benefits are recorded when paid.

##### *PLAN EXPENSES*

Certain expenses incurred in relation to the maintenance of the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payment transactions are charged directly to the related participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments and are not separately identified.

##### *SUBSEQUENT EVENTS*

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

#### NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank ("CSTB"), the trustee of the Plan. This information has not been audited by the Plan's independent auditors.

#### NOTE 4 – RISKS AND UNCERTAINTIES

The Plan provides for various investment options in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the participant account balances and the amounts reported in the statements of net assets available for benefits. The Plan, through its investment advisor, determines the appropriateness of the Plan's investment offerings and monitors investment performance and the risks associated therewith on a regular basis, which the Plan believes minimizes these risks.

#### NOTE 5 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC Topic 820, Fair Value Measurements and Disclosures are described as follows:

##### *Level 1*

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

#### *Level 2*

Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

#### *Level 3*

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

#### *Mutual Funds*

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### *Money Market Deposit Account*

The fair value of the money market deposit account is estimated to approximate the deposit account balances, plus accrued interest, at yearend.

#### *Self-directed Brokerage Account*

The self-directed brokerage account is comprised of interest-bearing cash, common stock, mutual funds, exchange-traded funds and unit investment trusts, all of which are valued at the closing price reported in the active market in which the securities are traded.

#### NOTE 6 - TAX STATUS

The Plan uses a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan, which received an opinion letter from the Internal Revenue Service ("IRS") dated September 21, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 7 – PARTIAL PLAN TERMINATION

As a result of significant involuntary reductions in the Plan Sponsor’s workforce, the Plan experienced a partial plan termination, as defined by ERISA, during 2023. As required by ERISA, participants impacted by a partial plan termination shall become fully vested in their account balances.

#### NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

#### NOTE 9 –PARTY-IN-INTEREST TRANSACTIONS

During the years ended December 31, 2024 and 2023, CSTB served as trustee of the Plan, as defined in the Plan document, and therefore, any fees paid by the Plan to CSTB qualify as party-in-interest transactions. Fees paid by the Plan to CSTB during the year ended December 31, 2024 were approximately \$12,000.
