Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 and Schedule H, Line 4j - Schedule of Reportable Transactions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified



investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

(1) Description of Plan

The following brief description of Provident Bank Pension Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

a. General

The Plan is a noncontributory defined benefit plan sponsored by Provident Bank (the Bank). Effective April 1, 2003, benefits under this plan were frozen, and participation in the Plan is no longer available to new employees.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

b. Pension Benefits

All participants in the Plan are 100% vested. Under the terms of the Plan, participants are eligible for monthly benefit payments upon reaching age 65 (normal retirement age) and the completion of participation, as defined. The Plan permits disability retirement based on the date of disability, as defined. The Plan permits both pre-retirement and post-retirement death benefits payable to a surviving spouse, as defined. The Plan permits early retirement at age 55 with five years of service with a reduced benefit, as defined. However, if the employee retires on or after age 60 and has at least 25 years of service, the early retirement benefit is not subject to the early retirement benefit reduction. If an employee terminates employment before he or she is eligible for normal or early retirement, he or she will be entitled to 100% of the accrued benefit, provided he or she has completed five or more years of service. Annual retirement benefits prior to the freeze date of April 1, 2003 were determined by taking 1.35% of the final average salary, as defined, up to covered compensation, as defined, plus 2% of the final average salary over covered compensation, multiplied by the years of service, as defined, up to a maximum of 30 years. Annual retirement benefits subsequent to the freeze date are determined by using service credits accrued through April 1, 2003.

c. Plan Amendments

Effective January 1, 2024, the Plan was amended to comply with the benefit provisions under the Setting Every Community Up for Retirement Enhancement ("Secure") Act and the SECURE 2.0 Act. The applicable age of distribution of benefits payable to a participant must commence at age 73. Total value distribution of benefits payable to a participant was increased from \$5,000 or less to \$7,000 or less.

(2) Summary of Significant Accounting Policies

a. Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

b. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date (an exit price). See Note 10 for a

discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

c. Benefits

Benefits are recorded when paid.

d. Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.

e. Risks and Uncertainties

The assets of the Plan are various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks as well as the individual investment fund objectives. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for pension benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in estimates and disclosures would be material to the financial statements.

(3) Actuarial Present Value of Accumulated Plan Benefits

The actuarial present value of accumulated plan benefits is the present value of the expected future payments, including lump-sum distributions that are attributable under the Plan's provisions to the service participants have rendered. Accumulated plan benefits include benefits expected to be paid to: (a) retired or terminated participants or their beneficiaries, (b) beneficiaries of participants who have died, and (c) participants or their beneficiaries. Benefits under the Plan are based on participants' compensation, as defined, for each year employed since the effective date of the Plan through April 1, 2003. Benefits payable under all circumstances (retirement, death, disability, and termination of employment) are included to the extent they are deemed attributable to participant service rendered to the valuation date. The value of annuity contracts and the benefits to be provided to participants who have retired and for whom annuity contracts were purchased are excluded from plan assets and accumulated plan benefits, respectively. Any benefits less than \$7,000 are paid in a lump-sum distribution rather than an annuity.

The actuarial present value of accumulated plan benefits is determined by an actuary from CSB Associates and it is that amount that results from applying actuarial assumptions to value the accumulated plan benefits to reflect the time value of money (through discounts for interest and expected mortality) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation

date and the assumed retirement dates. The significant actuarial assumptions used in the valuation as of January 1, 2024 and January 1, 2023 were: (a) assumed mortality rates based on the Pri-2012 Table with fully generational Projection Scale MP-2021 and Pri-2012 Table with fully generational Projection Scale MP-2021, respectively (b) assumed average rate of return of 6.0%, and (c) assumed retirement ages ranging from 60 to 70. The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits. The actuary estimated the accumulated plan benefits as of January 1, 2024 and 2023. There were no significant changes to the plan that would have changed the valuations had they been performed as of December 31, 2023 and 2022. The Plan is not considered an "at-risk plan" for the 2024 Plan year.

(4) Funding Policy

The Bank has voluntarily agreed to make contributions to the Plan sufficient to provide the Plan with assets with which to pay retirement benefits to Plan participants. The valuation process to determine the level of contributions made over a period of years to fund benefits under the Plan involves an actuarial funding method. The actuarial cost method used in this valuation to determine the contribution alternatives is the Unit Credit Actuarial Cost Method. The Bank met the minimum funding requirements of ERISA for 2024 and 2023.

(5) Plan Termination

Although it has not expressed any intention to do so, the Bank has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA.

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA, generally to provide the following benefits in the order indicated:

- a. Annuity benefits that former participants or their beneficiaries have been receiving for at least three years, or that participants eligible to retire in that three-year period would have been receiving if they had retired

with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under plan provisions in effect at any time during the five years preceding plan termination.

- b. Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. government agency) up to the applicable limitations discussed below.
- c. All other vested benefits (that is, vested benefits not insured by the PBGC).
- d. All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits and certain disability and survivor benefits. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination; however, there is a statutory ceiling on the amount of an individual's monthly benefit that the PBGC guarantees. For Plan terminations during 2025 that ceiling, which is adjusted periodically, is \$7,107.95 per month per the PBGC website. The ceiling applies to those pensioners who elect to receive the benefits in the form of a single-life annuity and are 65 years old at the time of retirement or plan termination (whichever comes later). For younger or older annuitants or for those who elect to receive their benefits in some form other than a single-life annuity, the corresponding ceilings are actuarially adjusted.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide those benefits and may also depend on the financial condition of the plan sponsor and the level of benefits guaranteed by the PBGC.

(6) Federal Income Taxes

The Internal Revenue Service (IRS) issued its latest determination letter dated September 19, 2017, which stated that the Plan and the related trust qualifies under the applicable provisions of the Internal Revenue Code and therefore is exempt from federal income taxes. The Plan has been amended since receiving the determination letter in accordance with the IRS requirements. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Related Party and Party-in-Interest Transactions

Delaware Charter Guarantee and Trust Company d/b/a/ Principal Trust Company (Principal) and First Allmerica Financial Life Insurance Company (First Allmerica) serve as trustees of the funds held under the Plan. For the years ended December 31, 2024 and 2023, there were transactions involving the investment of Plan assets in pooled separate accounts maintained by, Principal Life Insurance Company, an affiliate of Principal and group annuity contracts maintained by First Allmerica. Principal Life Insurance Company and First Allmerica are managers of these funds as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions.

(8) Administrative Expenses

Certain costs of administrative services rendered on behalf of the Plan including accounting, tax, legal, audit and other administrative support were borne by the Bank. The cost of administrative services paid by the Plan for 2024 and 2023 was \$176,907 and \$168,161, respectively.

(9) Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, related to investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal and First Allmerica, qualified institutions.

(10) Fair Value Measurements

Investment securities recorded at fair value at December 31, 2024 and 2023 consisted of mutual funds, pooled separate accounts, collective investment trust and group annuity contract.

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy under U.S. GAAP are as follows:

Level 1: Unadjusted quoted market prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2: Quoted prices in markets that are not active, or inputs that are observable either directly or indirectly, for substantially the full term of the asset or liability; and

Level 3: Prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable (i.e., supported by little or no market activity).

A financial instrument's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

There have been no changes in valuation methodologies used at December 31, 2024 and 2023. The valuation methodologies used for assets measured at fair value are as follows:

Mutual funds: Mutual Funds are measured based on exchange quoted prices available in active markets.

Pooled separate accounts: These assets are valued at the net asset value ("NAV") as reported by each fund as a practical expedient to estimate fair value of the Plan's interest therein. The Plan's investment in pooled separate accounts can be redeemed daily with one-day notice at the current NAV per share. There were no unfunded commitments as of December 31, 2024 and 2023.

Collective Investment Trust: Measured using quoted prices in markets that is not active, and valued by the net asset value ("NAV") of the units, based on the fair value of the underlying holdings. The Plan's investment in collective investment trust can be redeemed daily at the current NAV per share. There were no unfunded commitments as of year-end.

Group annuity contract: Investment in non-fully benefit responsive group annuity contracts is reported at fair value, using the contract's exit price, which approximates contract value. The value of these investments equal the accumulated cash contributions and interest credited to the individual contracts less, any withdrawals and expenses.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- B. **ELIGIBILITY** - Age 21 with one year of service.

The annual pension is 1.35% of AFC up to Covered Compensation plus 2.0% of AFC over Covered Compensation, all multiplied by years of pension credit up to April 1, 2003 to a maximum of 30 years. AFC is average annual basic compensation received in the 60 consecutive months within the last 120 months, which produces the highest such average. Covered Compensation is the average of maximum earnings subject to Social Security tax based on year of birth. Benefits are frozen as of April 1, 2003.
- D. **EARLY RETIREMENT** - Age 55 and 5 years service. The annual pension is determined as in (C) above but reduced by 3% per year for the first 5 years and 5% thereafter if payments commence before age 65. However, there is no reduction if age 60 and 25 years of service.
- E. **DISABILITY** - Age 55 with 20 years of service. Annual pension benefits continue to accrue during disability.
- F. **TERMINATION** - 100% vested right after 5 years service. The annual pension deferred to age 65 is determined as in D. above or reduced if payments commence after age 55 but before age 65.

G. DEATH BENEFITS

- (i) *Before Retirement:* If the Participant has a vested right but is not eligible for early retirement, the spouse receives pension for life commencing at the participant's 55th birthday equal to one-half the amount the participant would have received if he terminated on his date of death, survived until age 55, and retired at age 55 with the Joint and 50% Survivor Option in effect. If death after eligible for early retirement, spouse receives pension for life equal to 50% of the pension the participant would have received had he retired early on his date of death and elected the Joint and 50% Survivor Option. If death after age 55 with 20 years of service and without spouse, beneficiary receives pension for 120 months (or less if beneficiary dies before 120 payments are made) equal to 50% of pension the participant would have received had he retired early on this date of death with a spouse and elected the Joint and 50% Survivor Option.
- (ii) *After Retirement:* None, except if the participant has a spouse, the standard benefit is automatically converted to a reduced Joint and 50% to Survivor Option unless such conversion rescinded.
