INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Darvin Furniture Employees' 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Darvin Furniture Employees' 401(k) Profit Sharing Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the plan's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

ERISA-Required Supplementary Information

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and is derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the 2024 audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - Darvin Furniture Employees' 401(K) Profit Sharing Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through October 8, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Darvin Furniture & Appliances of Orland Park, Inc. is the plan sponsor, employer and the plan administrator. Capital Bank and Trust Company ("Capital Bank") is the plan trustee that holds custody of the plan's investment assets. Capital Group Retirement Plan Services ("Capital Retirement") engages Empower Retirement, LLC to maintain investment and participant records. The majority of the plan's investments available to plan participants are through American Funds. Capital Bank, Capital Retirement and American Funds are affiliate entities operating under The Capital Group Companies, Inc. and are collectively referred to as "the Capital Group". First American Bank is the third party administrator that maintains plan records and performs various compliance tests as tax counsel. Merrill Lynch is the plan's investment advisor.

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances to these investment options. The net appreciation (depreciation) in fair value of investments bought, sold and held during the years is reflected in the accompanying statements of changes in net assets available for benefits. Participants should refer to the prospectuses and annual reports for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following are descriptions of the valuation methodologies used for investments measured at fair value.

Mutual funds - Valued at the daily published quoted market prices as reported by the funds. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV") and are deemed to be actively traded.

Common/collective trust - The common/collective trust held by the plan is a direct filing entity valued at its NAV. The NAV is used as practical expedients to estimate fair value and is generally based on the fair values of the underlying investments held by the common/collective trust less their liabilities. The practical expedient would not be used if it is determined to be probable that the common/collective trust would sell the investments for amounts different from the reported NAV.

Excess employee contributions payable - Amounts payable to participants for contributions made during the 2024 and 2023 plan years that are in excess of amounts allowed by the Internal Revenue Service are recorded as liabilities. The plan distributed the excess contributions to the applicable participants during the 2025 and 2024 plan years, prior to the required deadline to correct such excess contributions.

2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

General - The plan was established on January 1, 1984 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Substantially all non-union employees of the plan sponsor are eligible to participate in the plan other than those defined as seasonal employees. Employees are eligible to enter the plan once they have completed three months of service. An employee can enter the plan on the first day of the month after meeting the eligibility requirements.

Contributions - Contributions are recorded in the year in which eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). New employees are automatically enrolled in the plan and have 3% of compensation withheld as elective deferral contributions. Such participants have the option to increase, decrease or stop the deferral by completing the necessary documentation. Beginning January 1, 2024, the plan was amended to allow Roth elective deferral contributions.
- b. Rollover contributions are accepted by the plan from other qualified plans. There were no rollover contributions in 2024 and 2023.
- c. Matching contributions may be made equal to a discretionary percentage of the employee's elective deferral contributions as determined by the employer's board of directors. The discretionary percentage was 25% of the first 6% of the employee's compensation contributed to the plan as elective deferral contributions in 2024 and 2023. Employer discretionary matching contributions are made to the plan on a quarterly basis.
- d. Nonelective employer contributions may be made at the discretion of the employer's board of directors. There were no nonelective employer contributions made in 2024 and 2023.

Participant accounts - Earnings, including the fair value appreciation or depreciation, are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant account is credited with the participant's elective deferral contributions, rollover contributions and an allocation of the employer contributions. Participants are allowed to transfer funds between the various investment options and change their deferral percentage at any time.

Vesting - Participants are always 100% vested in their employee elective deferral contributions, rollover contributions and related earnings. Participants become 10% vested in their employer contributions and related earnings upon one full year of service and become 20% vested after two years of service. The participants then vest at the rate of 20% per year thereafter until they are fully vested. Upon death, disability or attainment of normal retirement age (defined as age 60) while employed, participants become 100% vested.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attaining the age of 60. Distributions are generally required to be in the form of a single lump sum, installments or partial withdrawals. In addition, hardship withdrawals are permitted under certain circumstances.

Forfeitures - Forfeited nonvested employer contributions may be used to pay administrative expenses or reduce employer contributions. Forfeitures used to reduce employer contributions were \$4,000 in 2024 and \$8,000 in 2023. For forfeitures used to pay administrative expenses were \$1,000 in 2024. There were no forfeitures used to pay administrative expenses in 2023. Unapplied forfeitures were insignificant as of December 31, 2024 and 2023.

Administrative expenses - Certain fees and expenses of the plan are paid by the plan sponsor. Certain other fees and expenses are paid by the plan using plan assets and recorded as administrative expenses in the accompanying financial statements. Administrative expenses paid by the plan consist of participant directed charges for distribution processing fees and nonparticipant directed charges for certain administrative and advisory services. Nonparticipant directed fees not paid using forfeitures are charged to participants on an account value basis.

Notes receivable from participants - Participant loans are not permitted under the plan.

3. PARTY-IN-INTEREST TRANSACTIONS AND ADMINISTRATIVE EXPENSES

Certain of the plan's investment assets are managed by American Funds. Capital Bank is the plan trustee that holds custody of the plan's investment assets. As discussed at Note 1, American Funds and Capital Bank are affiliate entities operating under the Capital Group. As such, transactions between any entities operating under the Capital Group and the plan qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

The plan entered into an administrative service agreement with the Capital Group in which the Capital Group provides certain administrative services to the plan. Direct fees paid to Capital Group, recorded as a component of administrative expenses in the accompanying financial statements, were \$20,000 in 2024 and \$5,000 in 2023. In addition, the Capital Group receives revenue, in the form of indirect compensation, from mutual fund service providers for services the Capital Group provides to the funds. Under the administrative service agreement, this revenue is used to reduce fees that would otherwise be owed by the plan to the Capital Group for its administrative services.

Direct investment advisory and administrative fees provided by First American Bank and Merrill Lynch, recorded as a component of administrative expenses in the accompanying financial statements, were \$31,000 in 2024 and \$40,000 in 2023.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in employer contributions and related earnings.

5. INCOME TAX STATUS

The plan is operating under a First American Bank Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan ("the First American plan") that received its most recent favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the First American plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan; however, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

6. INFORMATION CERTIFIED BY CAPITAL BANK

Management has obtained certifications from Capital Bank, a qualified institution under the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held and the fair values of such as of December 31, 2024 and 2023;
- b. Interest and dividends from investments and net appreciation (depreciation) in fair values of investments during 2024 and 2023;
- c. Contributions to, withdrawals from, purchases, sales and inter-fund transfers between accounts during 2024 and 2023; and
- d. The report of individual participant accounts as of and for the years ended December 31, 2024 and 2023.

7. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

As discussed in Note 1, the plan follows the accrual method of accounting for financial statement purposes. The 2022 Form 5500 was prepared on a modified cash basis. As a result, the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2023 differs from the 2023 Form 5500.
