Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Pavilion At Queens for Rehab & Nursing 401(k), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Pavilion At Queens for Rehab & Nursing 401(k) and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Pavilion At Queens for Rehab & Nursing 401(k)'s ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules of Schedule H, line 4a – Schedule of Delinquent Participant Contributions for the Year Ended December 31, 2024 and Schedule H, line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Pavilion at Queens for Rehab & Nursing 401(k) (the “Plan”) provides only general information. Participants should refer to the plan document for a more detailed and complete description of the Plan’s provisions.

A. GENERAL

The Plan is a defined contribution plan which became effective January 1, 2015 and covers all eligible employees of Kennedy Pavilion RH LLC, Queens Dialysis at the Pavilion LLC, and Massapequa Center LLC (collectively referred to as the “Employer”). The Plan covers all eligible employees age 21 or older upon completion of three consecutive months of service beginning on the date of hire during which time the employee completes at least 200 hours of service. The Plan does not cover leased employees. Entry dates are the first day of each month of the plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan’s Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Board of Trustees.

B. CONTRIBUTIONS

Each year, participants may contribute up to 100% of their annual eligible compensation, as defined, not to exceed amounts prescribed by the Internal Revenue Service (IRS). All employees who are eligible to make contributions under the Plan and who have attained age 50 before the close of the Plan year are eligible to make catch-up contributions up to amounts prescribed by the IRS. Participants may also contribute amounts representing distributions from other qualified plans as defined. Participants direct the investment of their contributions and the employer contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. The Employer, at its discretion, may elect to make a qualified nonelective contribution to the Plan to satisfy the nondiscrimination rules, which apply to the Plan. The Employer may elect to make discretionary matching contributions to eligible participants who have met the Plan’s eligibility requirements to participate in the Plan. For 2024, the Employer discretionary matching contribution equaled 3% of an eligible participant’s contributions to the Plan. In 2024 the Employer made discretionary matching contributions of \$24,752. Contributions are subject to certain statutory limitations.

C. PARTICIPANT ACCOUNTS

Each participant’s account is credited with the participant’s contributions and allocations of Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

D. VESTING

Participants are immediately vested in their contributions and the Employer's qualified nonelective contributions plus actual earnings thereon.

E. NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 6.25% to 8.50%. The interest rates are determined by the prime rate as published in the Wall Street Journal. Principal and interest is paid ratably through payroll deduction within a maximum term of five years. If the note is used to purchase a primary residence, then a longer repayment term is permitted. A participant may have no more than one note outstanding at any one time.

F. PAYMENT OF BENEFITS

On termination of service, participants will receive the value of the vested interest in their account. Upon termination, participants whose vested account balance is \$1,000 or less will receive the value of the vested interest in their account as a lump-sum payment unless the participant requests to receive partial payments or elects to rollover such amount to an Individual Retirement Account or Annuity ("IRA") or a qualified retirement plan. Participants whose vested account balance exceeds \$1,000 must consent to receive a distribution and may elect to receive an amount equal to the value of the participant's vested interest in their account in either a lump sum amount, partial payment, or as a rollover to an IRA or a qualified retirement plan. However, the plan administrator may choose to immediately distribute account balances whose value exceeds \$1,000 if the participant has terminated service and has reached the later of age 62 or normal retirement age.

Hardship and in-service withdrawals are permitted, as defined in the plan document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. USE OF ESTIMATES

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

C. INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received rather than on an ex-dividend basis and the effect is not material to a fair presentation. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

E. PAYMENTS OF BENEFITS

Benefits are recorded when paid.

F. OPERATING EXPENSES AND ADMINISTRATION

The Employer, at its discretion, may pay all or part of the administrative expenses of the Plan, including audit and legal fees. For 2024, the Employer paid part of the administrative expenses of the Plan and they intend to pay for the cost of the 2024 annual audit of the Plan and therefore excluded these amounts from the financial statements. The Employer may elect in the future not to pay these fees which would affect the financial return to participants. In 2024, the Plan paid administrative expenses of \$12,727 to Ascensus Inc. Investment related expenses are included in net appreciation in fair value of investments.

G. DATE OF MANAGEMENT'S REVIEW OF SUBSEQUENT EVENTS

Subsequent events were evaluated through September 25, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 - CERTIFIED INVESTMENTS

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, as agent for Ascensus Trust Company (the trustee of the Plan).

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

NOTE 6 - TAX STATUS

The Internal Revenue Service (“IRS”) has determined and informed Ascensus Inc. by a letter dated January 1, 2018 that their Prototype Non-Standardized Profit Sharing Plan with CODA (Cash or Deferred Arrangement), was designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan adopted Ascensus Inc’s Prototype Non-Standardized Profit Sharing Plan with CODA. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 - PROHIBITED TRANSACTIONS

As reported on the supplemental Schedule H, line 4a - Schedule of Delinquent Participant Contributions, certain participant contributions and repayments of notes receivable from participants were not remitted to the Plan within the time frame specified by the Department of Labor’s Regulation 29 (CFR 2510.3-102), thus constituting nonexempt transactions between the Plan and the Employer for the years ended December 31, 2024 and 2023. During the audit of the Plan as of and for the year ended December 31, 2024, it was determined that 2024 participant contributions of \$207,952 and notes receivable from participants repayments of \$24,647 were not remitted timely to the Plan. During the audit of the Plan as of and for the year ended December 31, 2023 it was determined that 2023 participant contributions of \$290,817 and notes receivable from participants repayments of \$22,043 were not remitted timely to the Plan. For 2024 and 2023 the Employer remitted lost earnings that were calculated of \$132 and \$260, respectively, to the Plan as a result of the 2024 and 2023 prohibited transactions.
