## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Rule Joy Trammell & Rubio 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Rule Joy Trammell & Rubio 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Basis of Accounting**

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

## **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section,

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 2;
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Rule Joy Trammell & Rubio 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**1. DESCRIPTION OF PLAN**

The following brief description of Rule Joy Trammell & Rubio 401(k) Plan (the "Plan") is provided for general information purposes only. Participants or other interested parties should refer to the Plan Agreement for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan covering all employees of Rule Joy Trammell & Rubio, LLC (the "Company"). The Plan was effective April 1, 2010, and is subject to certain provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan has been amended over the years to comply with tax regulations.

The Company is the Plan administrator and Empower Trust Company, LLC (the "trustee" or "custodian") is the trustee and custodian of the Plan assets. The custodian provides recordkeeping and other retirement services for the Plan. The Company is responsible for the oversight of the Plan, monitoring investment performance and determining the appropriateness of the Plan investment offerings.

B. Eligibility

Employees are eligible to participate in the Plan for purposes of salary deferrals, matching contributions and discretionary contributions after they have attained the age of 21. Eligible employees may enter the Plan the first day of the month after the date that eligibility is attained.

The Plan was amended effective January 1, 2024, to change eligibility requirements, and implement a 3% automatic deferral for new hires. Effective with this amendment, interns are excluded from participation unless they complete at least 1,000 hours of service and all participants must be 21 years of age and have one month of service.

C. Contributions

Participants may contribute up to the applicable limit pursuant to Code Section 402(g) of their pre-tax annual compensation, as defined by the Plan, subject to certain limitations for highly compensated individuals. Participants who attained age 50 before the end of the Plan year may make additional catch-up contributions. The Company makes a safe harbor nonelective contribution to the account of each eligible participant in an amount of 3% of eligible compensation. Additionally, the Company may contribute a discretionary profit-sharing contribution, which is determined annually. Discretionary profit-sharing contributions of \$167,257 were made during the year ended December 31, 2024.

D. Participant Accounts

Participants' accounts are maintained by the trustee and are credited with the participant's contributions, the Company's contributions, and allocations of investment income (loss). Each participant is charged with fees upon receiving distributions, as well as an allocated portion of plan administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

E. Vesting

Participants are immediately vested in their voluntary contributions and the Company's safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contributions plus actual earnings thereon occurs once the participant has completed three years of eligible service.

F. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. The minimum loan amount is \$1,000 and cannot exceed the lesser of 50% of a participant's vested account balance or \$50,000. Repayment of loans must be made at least quarterly and must be repaid within five years unless the loan is related to the purchase of a primary residence. The notes receivable, which are collateralized by the balance in the participant's account, bear interest ranging from 6.5% to 9.5%. Loan balances outstanding to the Plan's participants were \$28,173 and \$48,199, respectively. Principal and interest are paid ratably through monthly payroll deductions.

G. Payments to Participants

Upon termination of service due to retirement, attainment of age 59½, attainment of normal retirement age before severance from employment, termination, financial hardship, death or disability, a participant or representative may elect to receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, upon written request and approval, participants may withdraw some or all of the elective contributions and rollovers in their employee contribution account if the withdrawal is necessary due to hardship.

H. Forfeited Accounts

Amounts forfeited by participants who are terminated from the Plan prior to being fully vested are used to reduce plan administrative costs and employer contributions. For the year ended December 31, 2024, \$2,963 of forfeitures were used to offset plan administrative costs and \$5,279 was used to reduce employer contributions. At December 31, 2024 and 2023, the unused forfeiture balance totaled \$11,035 and \$8,503, respectively.

**2. SUMMARY OF ACCOUNTING POLICIES**

A. Basis of Accounting

The financial statements have been prepared on the modified cash basis of accounting which is an acceptable alternative method of reporting under regulations issued by the Department of Labor. Income on securities is recorded on the accrual basis and investments are recorded at fair value. All other transactions are recorded on a cash basis.

B. Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reported period. Actual results could differ from those estimates. The Plan custodian has provided estimates and assumptions in preparation of the financial statements and schedule of assets held.

C. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income and dividends are recorded on the accrual basis of accounting. Net appreciation (depreciation) in fair value of pooled separate accounts includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

D. Contributions

Contributions from Plan participants and matching contributions from the Employer are recorded in the year in which the employee contributions are received by the trust, under the modified cash basis of accounting.

E. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

F. Payments of Benefits

Benefits are recorded when paid.

G. Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of pooled separate accounts.

H. Subsequent Events

Subsequent events have been evaluated by management through October 3, 2025, the date these financial statements were available to be issued.

**3. FAIR VALUE MEASUREMENTS**

As of December 31, 2024 and 2023, the only assets that are measured at fair value on a recurring basis in periods subsequent to initial recognition are investments. The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued based on the net asset value of the underlying assets as determined by the Plan custodian. The net asset value ("NAV") is not a publicly quoted price in an active market. Currently, all redemptions for the pooled separate accounts are at that day's computed net asset value. Net asset value as a practical expedient is used to estimate fair value.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. INFORMATION PREPARED AND CERTIFIED BY QUALIFIED INSTITUTION**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, the trustee and custodian has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the financial statements and supplemental schedule.

**5. RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by Empower Trust Company, LLC, the trustee; and therefore, these investments and investment transactions qualify as "party in interest" transactions, as defined by ERISA. Additionally, other fees paid to third-party service providers for accounting and other consulting services qualify as party in interest transactions. Total Fees paid by the Plan for these services amounted to \$60,392 for the year ended December 31, 2024. Notes receivable from participants also qualify as exempt party in interest transactions.

**6. PLAN TERMINATION**

Although they have not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, no further contributions will be made to the plan and all amounts credited to participants would become fully vested.

**7. TAX STATUS**

The Plan adopted a pre-approved defined contribution plan designed by Pension Financial Services, Inc. with the most recent opinion from the Internal Revenue Service dated June 30, 2020. The Internal Revenue Service requires that plan documents be restated every six years to incorporate changes in laws and regulations that have taken place since the last restatement. The Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits – Modified Cash Basis.
