## REPORT OF INDEPENDENT AUDITORS

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Purpose Home Health 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## 1. DESCRIPTION OF PLAN

The following description of Purpose Home Health 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan covering all eligible employees of Purpose Home Health ("Company" or "Employer") and any participating employers listed in the plan agreement. Employees are eligible for participation upon completion of two months of service. The Plan was established September 1, 2018 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective August 1, 2024, Queen City Skilled Care was added as a participating employer, and their existing plan, the Queen City Skilled Care 401(k) Plan, was terminated. As a result, the participant account balances previously held in the Queen City Skilled Care 401(k) Plan, were transferred into the Purpose Home Health 401(k) Plan. This asset transfer, which totaled \$1,015,360, is reflected in the accompanying statement of changes in net assets available for benefits as "Transfers in."

### Contributions

Each year, participants may contribute up to a maximum percent of annual compensation as defined in the plan agreement, subject to certain limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employee rollover contributions from other qualified defined contribution plans are also permitted. Participants direct the investment of their contributions into various investment options offered by the Plan. They may change their investment options among those investments provided at any time during the plan year.

The Company may make a discretionary annual matching contribution. For 2024, this discretionary matching contribution was 25 percent of the first 6 percent of participant deferrals.

### Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contributions and the Company's discretionary matching contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are vested immediately in their contributions and Plan safe harbor matching contributions plus actual earnings on these contributions. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is fully vested after four years of credited service.

### Notes Receivable from Participants

A participant may borrow up to 50% from his or her vested account balance with a minimum loan amount of \$500 and a maximum loan amount of \$50,000. Loan repayments made by a participant are credited to the participant's account. All loans are to be repaid within five years except for loans whose proceeds are used to acquire a primary residence. The loans are secured by the participant's vested interest in the plan and bear an interest rate equal to the prime rate plus two percent at the time of the loan. A participant may have one loan outstanding at a time.

### Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive installment payments or a lump sum amount equal to the value of the participant's vested account balance. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In the event of a financial hardship, the Plan may allow the participant to withdraw all or a portion of the employee contribution and rollover portions of their account. In-service distributions are also permitted once the participant attains the age 59 ½.

### Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,809 and \$2,139, respectively. The non-vested portion of former participants' accounts may be used to reduce employer contributions or pay plan administrative expenses. In 2024, employer contributions were reduced by \$2,157 from forfeited non-vested accounts.

### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Should the Plan be terminated at some future time, all participants would become 100% vested in their accounts as of the termination date.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

### Notes Receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Notes receivable are secured by the balance in the applicable participant's account. Delinquent participant loans are recorded as distributions on the basis of the terms of the plan agreement.

### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### Payment of Benefits

Benefit payments are recorded when paid.

### Administrative Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

### Tax Status

The Plan has adopted a pre-approved plan document sponsored by ADP, LLC, which has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the form of the pre-approved plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan Administrator believes the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is October 8, 2025.

### **3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company ("RTC"), the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and in the schedule of assets at December 31, 2024, and the related investment

activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### 5. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. The Plan provides for participant loans, which qualify as party-in-interest transactions. The Plan also pays certain administrative expenses to its service providers. Reliance Trust Company is the trustee of the Plan. ADP is the Plan's recordkeeper. Shepherd Financial provides consulting and third-party administrator services to the Plan. Blue & Co., LLC is the independent auditor of the Plan. Payments for these services are made by the Plan or plan sponsor.

#### 6. SUBSEQUENT EVENTS

Effective January 1, 2025, Michiana Home Care LLC was added as a participating employer. As a result, participant account balances totaling \$300,741, which were previously held in their sponsored plan, Michiana Home Care, transferred into the Plan in 2025.

Effective February 1, 2025, Resilience Home Health Corp was added as a participating employer, and their plan, the Resilience Home Health Corp Retirement Plan, merged into this Plan. As a result, participant account balances totaling \$964,635 were transferred into the Plan in 2025.
