Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Westover Property Management Company LP Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 - Description of Plan

The following description of the Westover Property Management Company LP Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

- A. General - The Plan is a defined contribution plan with an Internal Revenue Code ("IRC") Sec 401(k) provision covering all employees of Westover Property Management Company LP (the "Company" or "Employer") who meet the eligibility requirements of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Trustees is responsible for oversight of the Plan including monitoring of investment performance and determining appropriate investment offerings.
- B. Eligibility Requirements - Each eligible employee is eligible to participate in the Plan as of their date of hire and attained the age of twenty-one.
- C. Employee Contributions - Eligible employees may make salary deferral contributions not to exceed 100% of their pretax annual eligible compensation up to \$23,000 and \$22,500, which is the maximum dollar limit set by law for the years ending December 31, 2024 and 2023, respectively. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation.

Participants who have attained age 50 before the end of the Plan year are eligible to make "catch-up contributions." For the years ended December 31, 2024 and 2023, the maximum catch-up contributions were \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.
- D. Employer Contributions - The Employer may make a discretionary matching contribution of the participants' elective deferral. For the years ended December 31, 2024 and 2023, the Employer elected to match 100% of employee salary deferrals, not to exceed 4% of the participant's annual salary. Additional profit-sharing amounts may be contributed at the option of the Company's Board of Trustees. In 2024 and 2023, the Company elected not to make profit sharing contributions. Each otherwise eligible employee who is employed on the last day of the plan year is eligible for the employer nonelective contributions, if made.
- E. Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of the Employer's contribution, plan earnings, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specified participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

- F. Payment of Benefits - A participant will receive a lump sum amount equal to the value of the individual's vested account upon termination of service due to death, disability, or upon attaining a Normal Retirement age. Withdrawals from the Plan may also be granted based upon circumstances of financial hardship or attaining age 59 ½, in accordance with provisions specified in the Plan document. Participants with vested balances that do not exceed \$1,000 will receive a lump sum payment as soon as administratively feasible following the termination of employment. Participants with vested balances that exceed \$1,000 but do not exceed \$7,000, who do not consent to a lump sum payment will automatically be rolled over into an IRA selected by the Plan Administrator. If the total vested benefits exceed \$7,000, no distribution is made from the Plan without consent of the participant.
- G. Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Participants become fully (100%) vested in the Employer contribution upon the occurrence of death and total or permanent disability.

Other than as stated above, employer contributions vest based upon the following:

A year of vesting service is a vesting service period in which an employee has at least 1,000 hours of service and is based on the plan year.

- H. Income Tax Status - The Plan is structured and follows a prototype non-standardized cash or deferred profit sharing plan, pre-approved by the Internal Revenue Service ("IRS"). The IRS issued an opinion letter dated June 30, 2020, that the prototype non-standardized profit sharing plan is acceptable with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- I. Forfeited Accounts - Any participant who terminates employment without being fully vested (100%) in their Employer contribution account forfeits their unvested portion of the employer contribution. At December 31, 2024 and 2023 forfeited nonvested accounts totaled \$44,330 and \$12,262, respectively. These amounts are held in a cash, noninterest-bearing account and are used to reduce future Employer contributions or administrative expenses. During 2024 and 2023, no forfeitures were used to offset Employer contributions or administrative expenses.

NOTE 2 - Summary of Significant Accounting Policies

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are a representation of the Plan's management, who is responsible for their integrity and objectivity. The accounting policies described below conform to accounting principles generally accepted in the United States of America and have been applied consistently in the preparation of the financial statements.

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to 2023 contributions. The Plan distributed the 2023 excess contributions to the applicable participants.

Payment Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Plan. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of participant's accounts, notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation in fair value of investments.

NOTE 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the Net Asset Value ("NAV") of the units of a pooled separate account held by the Plan at year end, multiplied by the NAV per unit. The underlying investments of pooled separate accounts consist solely of mutual funds. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate account, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

NOTE 6 - Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded when a distributable event occurs. Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. Loan transactions are treated as transfers between the investment fund and the participant loan fund. Loan terms range from one to five years, except for loans for the purchase of a primary residence.

The loans are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 10.50%, which is based on the Prime rate plus 2%. Principal and interest is paid ratably through payroll deductions. Balances outstanding at December 31, 2024 and 2023 were \$291,935 and \$190,397, respectively.

NOTE 7 - Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - Related Party Transactions

John Hancock Life Insurance Company provides administrative services for certain investment alternatives in the Plan. John Hancock Life Insurance Company is a trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid directly by the Plan for the services amounted to \$12,535 and \$5,954 for the years ended December 31, 2024 and 2023, respectively. Certain administrative functions of the Plan are performed by officers or employees of the Company, at no charge to the Plan. Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net assets available for benefits.
