Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Colorado Rockies 401(k) Savings and Investment Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

General

Colorado Rockies 401(k) Savings and Investment Plan (the "Plan") is a defined contribution plan established on July 16, 1993 under the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan's investments are held by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the trustees of the Plan (collectively, the "Trustees"). The Plan is available to substantially all nonunion employees of Colorado Rockies Baseball Club, Ltd. (the "Club") who are age 21 years or older and have completed 60 days of service, as defined by the plan agreement.

Contributions

Participants may make before-tax contributions from 1 to 50 percent of their annual eligible compensation, not to exceed \$23,000 in 2024, as limited by the Internal Revenue Service (IRS), which may be adjusted annually for inflation by the U.S. Secretary of the Treasury. This maximum percentage may be reduced by the plan administrator in certain circumstances. Employees may enter the Plan on the first day of the month coinciding with or following the date the employee has met the eligibility requirements. Additional catch-up contributions, not to exceed \$7,500 in 2024, are available to any participant who is age 50 or older and has made the maximum contributions for the current year. The Plan also permits rollover contributions from other qualified retirement plans. Employee contributions to the Plan are made through semimonthly payroll deductions.

Employees are eligible to contribute on an after-tax basis through regular payroll deductions from 1 to 50 percent of eligible annual compensation as Roth 401(k) deductions. Provided requirements are met, withdrawals of contributions and any earnings are tax free. A participant's combined pretax and Roth 401(k) contributions cannot exceed the maximum annual amount allowed by the IRS or the plan-imposed limit of 50 percent of eligible annual compensation.

The Plan contains an automatic deferral provision where, upon attainment of eligibility, employees become automatically enrolled in the Plan at a deferral rate of 6 percent of eligible annual compensation. Unless otherwise elected, this deferral rate shall increase by 1 percent annually to a maximum of 10 percent.

Employees whose employment commencement dates occurred after February 1, 2018 and employees who elected to leave the Club's Non Uniformed Pension Plan (NUPP) as of the election date will receive a match of 50 percent of elective deferrals up to 6 percent of eligible annual compensation, not subject to vesting provisions, and a nonelective employer contribution equal to 7 percent of eligible annual compensation, subject to vesting provisions. Legacy participants who remain in the NUPP will receive a match of 50 percent of elective deferrals up to 6 percent of eligible annual compensation, not to exceed \$1,500 per employee per calendar year. Effective January 1, 2024, the Club froze and terminated the Non Uniformed Pension Plan and removed the Non Uniformed Pension Plan option for participants of the Plan. Participants previously part of the NUPP are no longer limited to the annual NUPP max match of \$1,500 and are now eligible for the matching employer contributions and the nonelective employer contribution of 7 percent. Minor league players were eligible for a match of 50 percent of elective deferrals up to 6 percent of eligible annual compensation during 2023. In 2024, minor league players were no longer eligible to participate in the Plan.

The Club makes a fixed nonelective 7 percent contribution. Fixed nonelective and matching employer contributions were \$2,820,527 for the year ended December 31, 2024.

Certain participant contributions in 2024 and 2023 were paid after the time frame required by the Department of Labor. The Company remitted the 2024 contributions and related lost earnings to the Plan during 2025 and remitted the 2023 contributions and related lost earnings during 2024.

December 31, 2024 and 2023

Note 1 - Plan Description (Continued)

Participant Accounts

Each participant's account is credited or charged with the participant's contributions, an allocation of the Club's contributions, expenses, and plan earnings or losses. Allocations are based upon plan earnings or losses and account balances, as defined in the plan document. The benefit to which a participant is entitled is the vested portion of the participant's account. Participants direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are vested immediately in employee contributions, expenses, and earnings or losses thereon.

For participants whose employment commencement date was prior to January 1, 2023, participants are vested immediately in employer contributions (exclusive of the Club's nonelective contribution).

The Club's employer contributions for participants whose employment commencement date was after January 1, 2023 and the Club's nonelective contributions to all participants vest according to the following schedule:

Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances and may not have more than one loan from the Plan outstanding at a time. Participants are not permitted to borrow from the portion of their account balances representing Roth 401(k) deferrals. The loans are secured by the balances in the participants' accounts; bear interest at rates ranging from 5.25 to 10.50 percent, which is commensurate with local prevailing rates determined by the plan administrator at loan origination; and mature at various dates through January 2045. Loans have a maximum term of 5 years, unless such loan is for the purchase of the participant's primary residence, in which case the repayment period may not exceed 30 years from the date of the loan origination. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants are recorded in the financial statements at amortized cost (which represents unpaid principal plus accrued interest). Notes receivable from participants who terminate employment prior to the end of the loan term are required to pay off the loan at severance of employment, subject to a grace period. Nonpayment will force a deemed distribution.

Note 1 - Plan Description (Continued)

Payment of Benefits

Upon death, disability, normal retirement (age 65), or termination of service (each a "Distribution Event"), a participant is entitled to receive a distribution of the participant's vested account balance. A participant may have the distribution paid through lump-sum or partial distributions, transferred directly to an individual retirement account established for the participant, or transferred to another retirement plan account that the participant has in another qualified retirement plan. Participant accounts with balances less than \$1,000 may be immediately paid through a lump sum upon a Distribution Event. Account balances of more than \$1,000 but no more than \$5,000 will be rolled over to an individual retirement account if distribution instructions are not received by the participant following communication. The Plan allows for hardship withdrawals if certain criteria are met. Benefits are recorded as distributions to participants when paid.

Plan Termination

Although it has not expressed any intent to do so, the Club has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. If the Plan is terminated for any reason, the plan administrator is to distribute each participant's interest to the participant or the participant's beneficiary. Upon termination of the Plan, participants become 100 percent vested in their account balances, including any nonelective employer contributions.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements are prepared on the accrual basis of accounting. The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities. Actual results could differ significantly from these estimates.

Investment Valuation and Income Recognition

Mutual funds are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan invests in a fully benefit-responsive group annuity contract. This investment is included at contract value in the statement of net assets available for benefits. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments.

The net realized and unrealized investment gain or loss (net appreciation or depreciation in fair value of investments) is reflected in the accompanying statement of changes in net assets available for benefits and is determined as the difference between fair value at the beginning of the year (or date purchased if during the year) and selling price (if sold during the year) or year-end fair value. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are recognized on the ex-dividend date.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

December 31, 2024 and 2023

Note 2 - Summary of Significant Accounting Policies (Continued)

Risks and Uncertainties

The Plan provides for various investments that, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Additionally, some investments held by the Plan are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

Note 3 - Investments

The Trustees have certified in writing to the plan administrator that the fair value and contract value of investments and notes receivable from participants at amortized cost, respectively, as of December 31, 2024 and 2023 and the income earned or lost thereon for the year ended December 31, 2024, as reflected in the accompanying financial statements and the supplemental schedule of assets held at end of year, are complete and accurate.

Note 4 - Fair Value Measurements

Generally accepted accounting principles require disclosure about how fair value is determined and establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets.

Level 2

Inputs to the valuation methodology include quoted prices for similar assets in active markets and inputs that are observable for the asset, either directly or indirectly, for substantially the full term of the financial instrument.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Mutual funds are valued at fair value using published market prices, which represent the net asset value of shares held by the Plan at year end.

There were no changes to the valuation techniques used during the period.

Note 5 - Group Annuity Contract

During 2014, the Plan entered into a fully benefit-responsive guaranteed group annuity contract with Empower Annuity Insurance Company of America (Empower Annuity). Contributions to the contract purchase a contractual or guaranteed amount of future benefits. The guarantees and returns of the contract are backed by the claims-paying ability of Empower Annuity. The contract is included in the financial statements at contract value as of December 31, 2024, as reported to the Plan by the Trustees. Contract value represents contributions made under the contract, plus interest, less participant withdrawals. Within the contract, the Plan holds fully benefit-responsive accounts. Fully benefit-responsive accounts have no liquidity restrictions.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The Plan's average yield and crediting interest rate in the contract was 1.41 percent for the year ended December 31, 2024; the rate is set on a quarterly basis. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions.

December 31, 2024 and 2023

Note 5 - Group Annuity Contract (Continued)

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

Note 6 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

In accordance with guidance on accounting for uncertain tax positions, management evaluates the Plan's tax positions and recognizes a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

Note 7 - Administration of the Plan

The Plan maintains an account funded by participant balances to pay certain record-keeping and advisory fees related to the Plan. During the year ended December 31, 2024, \$70,137 was deposited to the account and \$63,167 was paid from the account for record-keeping, audit, and advisory fees. At December 31, 2024 and 2023, the balance of this account was \$28,346 and \$21,376, respectively, and is included in the accompanying statement of net assets available for benefits in group annuity contract. The Club may cover certain expenses of the Plan, as considered necessary. Plan participants are responsible for certain transaction costs, such as loan origination costs and various mutual fund fees. Additionally, for the year ended December 31, 2024 and 2023, the Plan had \$249,690 and \$51,720, respectively, of forfeitures on withdrawals, which is presented net of total distributions.

Note 8 - Related Party and Party-in-interest Transactions

The Plan provides for notes receivable to participants, who are parties in interest. Additionally, the Plan invests in a group annuity contract, as discussed in Note 5, managed by the Trustees and a mutual fund that is sponsored by the Trustees but managed by a registered investment company; therefore, these transactions qualify as party in interest. These transactions are exempt from the prohibited transaction rules.

Note 9 - Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 1, 2025, which is the date the financial statements were available to be issued.
