Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pembroke Hill School Defined Contribution Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Notes to Financial Statements

Note 1. Plan Description

The following description of Pembroke Hill School Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Pembroke Hill School (the School). The Retirement Plan Advisory Committee is responsible for the oversight of the Plan and determines the appropriateness of the investment offerings and monitors investment performance. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: All nonexcluded employees of the School are eligible to participate in the Plan for employee deferrals on the first day of the month subsequent to their date of hire. Participants are eligible for employer discretionary matching and discretionary nonelective contributions after 30 days of service. Excluded employees are defined by the Plan as students, nonresident aliens, and employees participating in a collective-bargaining contract.

Contributions: Eligible employees may elect to contribute a percentage of their eligible compensation, as defined in the Plan, up to the annual limit allowed by the IRC. Eligible employees are automatically enrolled in the Plan with a 6% deferral rate unless the employee specifically elects not to participate. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. During the year ended December 31, 2024, the School made a discretionary matching employer contribution on behalf of each participant equal to 8% of the employee's eligible compensation for an employee electing to contribute greater than or equal to 6%, or 7% of the eligible compensation for employees electing to make contributions of less than 6%.

The School may also elect to make a discretionary nonelective contribution to participants who are eligible to participate in employer discretionary contributions of the Plan. The School elected not to make a discretionary nonelective contribution during the year ended December 31, 2024.

Participants direct their contributions and the allocations of the employer matching and discretionary contributions to any of the funds managed by Teachers Insurance and Annuity Association (TIAA) and College Retirement Equities Fund (CREF). Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Investment options: Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options daily.

Participant accounts: Each participant's account is credited with the participant's salary deferral contribution, the employer discretionary matching contribution, the employer discretionary nonelective contribution, if any, and allocations of Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Upon entry into the Plan, participants are fully vested in their voluntary contributions and employer contributions, plus actual earnings thereon.

Notes to Financial Statements

Note 1. Plan Description (Continued)

Payment of benefits: Upon retirement, death, disability or termination of service, except for traditional annuity accounts with balances exceeding \$5,000, participants may receive a lump-sum amount equal to the value of the participant's account or choose to invest the account balance in an annuity contract. Traditional annuity accounts with balances exceeding \$5,000 must be distributed over a 10-year period. Participant balances under \$5,000 are automatically rolled over into an individual retirement account in the participant's name, unless another distribution method is selected by the participant. In-service withdrawals are not permitted unless the participant has attained age 59½ or certain hardship conditions are met.

Plan loans: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 45% of their account balance. The loans are made directly by TIAA and secured by the balance in the participant's account. The loans bear interest at rates that range from 5.02% to 5.73%, which are commensurate with local prevailing rates as determined periodically by TIAA. Principal and interest are paid ratably by the participant to TIAA. These loans are not Plan assets. They are merely secured by Plan assets. It is the opinion of the Plan Administrator that such arrangements are exempt transactions. The balances as of December 31, 2024 and 2023, are \$22,060 and \$48,826, respectively, and have various maturity dates through June 2026.

In the event of default, such loans are reportable to Plan participants as taxable income but remain outstanding and continue to accrue interest until repaid by the Plan participant or the participant becomes eligible to receive a distribution under the terms of the Plan. There are no loans in default as of December 31, 2024 and 2023.

Notes receivable from participants: Participants may borrow from their fund accounts at a minimum of \$1,000 and up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The notes receivable are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the time funds are borrowed, as determined quarterly by the Plan Administrator. As of December 31, 2024, the outstanding notes receivable are maturing through October 2029 with interest rates of 5% to 10%. Principal and interest are paid ratably through payroll deductions. Participants can have up to three notes receivable outstanding.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Contributions: Contributions from the Plan participants and the discretionary contributions from the employer are recorded in the year in which the employer contributions are withheld from compensation.

Allowance for credit losses: The measurement of expected credit losses under the current expected credit loss (CECL) methodology is applicable to the financial assets measured at amortized cost, which include employer and participant contribution receivables. An allowance for credit losses under the CECL methodology is determined using the loss-rate approach and measured on a collective (pool) basis when similar risk characteristics exist. Where financial instruments do not share risk characteristics, they are evaluated on an individual basis. The CECL allowance is based on relevant available information, from internal and external sources, related to past events, current conditions and reasonable supportable forecasts. Management recorded no allowance for credit losses as of December 31, 2024 and 2023, as all amounts were determined to be fully collectible.

Note 2. Summary of Significant Accounting Policies (Continued)

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Advisory Committee determines the Plan's valuation policies utilizing information provided by investment issuers and agents for the custodians and insurance companies. See Note 4 for a discussion of fair value measurements.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect participant account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make the scheduled repayments and the Plan Administrator deemed the participant to be in default, the participant's note receivable is reduced, and a benefit payment is recorded based on the terms of the Plan.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Payments of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of the Plan are paid by the School and are not included in the statement of changes in net assets available for benefits. Administrative expenses include fees related to the administration of notes receivable from participants that are charged directly to the participant's account and certain record-keeping fees paid by the Plan. Investment-related expenses are included in net appreciation in fair value of investments.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4. Fair Value Measurements (Continued)

The asset's and liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Variable annuity contracts: Variable annuity contracts are valued using market quotations or prices obtained from independent pricing sources who may employ various pricing methods to value the investments, including matrix pricing.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fixed annuity contracts (nonfully benefit-responsive): Nonfully benefit-responsive fixed annuity contracts are reported at contract value, which approximates fair value. This determination is based on TIAA's credit rating and yield during 2024 and 2023 being comparable to similar alternative investments and the interest rate being comparable to a 10-year Treasury bond.

Pooled separate account: The pooled separate account is valued at the net asset value (NAV) of units held by the Plan in the pooled separate account at year-end. NAV is determined based on market values of underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of observable market data is monitored. Changes in economic conditions or model-based valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investments and size of the transfer relative to total net assets available for benefits.

In estimating fair value of the investments in Level 3, the Retirement Plan Advisory Committee may use third-party pricing sources or appraisers. In substantiating the reasonableness of the pricing data provided by third parties, the Retirement Plan Advisory Committee evaluates a variety of factors, including review of methods and assumptions used by external sources, recently executed transactions, existing contracts, economic conditions, industry and market developments, and overall credit ratings.

Note 5. Investment Contracts With TIAA

The Plan has investment contracts with TIAA. TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because certain fixed annuity contracts and a stable value contract are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to certain fixed annuity contracts and the stable value contract. These contracts are included in the financial statements at contract value, as reported to the Plan by TIAA.

Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable.

The fixed annuity contracts and stable value contract do not permit the insurance company to terminate the agreement prior to 30 days' written notice.

Participants are permitted to transfer funds between their CREF variable annuity and pooled separate accounts and into their TIAA annuity accounts at any time. However, transfers out of the TIAA annuity accounts into any CREF account held by an active participant can only be made through a transfer payout annuity, which provides for the transfer of funds in substantially equal installments over a period of 10 years.

Note 6. Administrative Expenses

Certain administrative functions are performed by officers or employees of the School. No such officer or employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the School.

Note 7. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the IRS dated August 7, 2017, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document. However, the Plan Administrator believes the Plan is designed, and is being operated, in conformity with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the School has the right under the Plan document to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA.

Note 9. Related-Party and Party-in-Interest Transactions

Certain Plan investments are managed by TIAA and CREF, as custodians and agents on behalf of TIAA Trust, N.A., as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid to TIAA and CREF, as custodians and agents on behalf of TIAA Trust, N.A., were \$61,139 for the year ended December 31, 2024.

Note 10. Subsequent Events

Management has evaluated and disclosed subsequent events up to and including September 23, 2025, which is the date the financial statements were available to be issued.
