

## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

### 1. DESCRIPTION OF PLAN

The following brief description of the Alt & Witzig Engineering, Inc. 401(k) Plan (the Plan) provides only general information. Plan participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### GENERAL

The Plan is a defined contribution plan covering all full-time employees of Alt & Witzig Engineering, Inc. (the Company) and related companies, who have three months of service and are age 21 or older. The Plan was established in March of 1979 and amended at various times. Companies related to Alt & Witzig Engineering, Inc. included in the Plan are: Alt & Witzig of Ohio, LLC; A&W Consulting Services, LLC; A&W Engineering, LLC; and Alt & Witzig Professional Services, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### CONTRIBUTIONS

Each year, participants may contribute a percentage of their eligible pretax annual compensation as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may elect to provide a matching contribution based on a discretionary percentage each plan year. The Company matched 50% of the participant's elective contribution up to the maximum of 4% of the participant's eligible compensation for the year ended December 31, 2024. The 2024 Company contributions which totaled \$112,123 were remitted to the Plan in 2025. Additional discretionary profit-sharing contributions may be contributed to the Plan.

#### PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contributions, an allocation of the Company's contribution, and an allocation of the Plan's earnings and administrative expenses. Allocations are based on participant's base earnings as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

#### VESTING

Participants are immediately vested in their contributions and any earnings thereon. Vesting in the Company contribution portion, and any earnings thereon, of their accounts is based on years of service. For employer matching contributions, a participant vests 25% per year of service beginning with year one and is 100% vested after four years of credited service. For employer profit sharing contributions, a participant vests 20% per year beginning after two years of credited service and is 100% vested after six years of credited service.

Upon termination of service due to death, disability, or retirement, a participant is entitled to receive the entire amount credited to his or her account and may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, annual installments, a single-life annuity or a joint and survivor annuity. For termination of service due to other reasons, participants receive the value of the vested interest in their account as a lump-sum distribution.

### NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum of the lesser of \$50,000 or one-half of their vested account balance. The notes receivable are secured by the 100% vested portion of the balance in the participant's account and bear interest based on local prevailing interest rates as determined by the Plan Administrator. Principal and interest is paid ratably through monthly payroll deductions. Outstanding notes receivable from participants totaled \$31,992 and \$25,962 as of December 31, 2024 and 2023, respectively.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

### FORFEITED ACCOUNTS

According to the provisions of the Plan document, nonvested participant account balances forfeited by participants are to be used to reduce future Company contributions and/or to cover administrative costs, if applicable. As of December 31, 2024 and 2023, forfeited nonvested accounts were \$8,698 and \$8,302, respectively. During the year ended December 31, 2024, \$396 of participant nonvested account forfeitures were used to cover administrative costs.

### PLAN TERMINATION

Although the Company has not expressed intent to discontinue participation in the Plan, they may do so at any time upon resolution by the Company's Board of Directors subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their allocation of Company contributions.

## **2. SIGNIFICANT ACCOUNTING POLICIES**

### BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting whereby additions and deductions are recorded in the year in which they are incurred rather than in the year in which they are received or paid.

### ESTIMATES

The Plan Administrator uses estimates and assumptions in preparing financial statements in conformity with the accounting principles generally accepted in the United States of America. Those standards require the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits, the disclosure of contingencies and the reported additions to and deductions from net assets available for benefits. Accordingly, actual results could differ from those estimates.

### INVESTMENT VALUATION AND INCOME RECOGNITION

The assets of the Plan are held by The Standard Insurance Company, Inc. (The Standard). Investments held in the insurance company's general account are reported at contract value. Pooled separate accounts are valued at fair value at the net asset value (NAV) of the pooled accounts as provided by the Custodian. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net appreciation or depreciation of investments is reported in the statement of changes in net assets available for benefits and consists of the realized gains and losses and the unrealized appreciation or depreciation of these investments. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded as received.

### EXPENSES OF THE PLAN

Certain administrative expenses of the Plan, including claim administrative fees, are paid by the Plan as incurred.

## **3. INCOME TAXES**

The Plan uses a prototype plan document sponsored by The Standard Insurance Company, Inc., the Custodian of the Plan. In a letter dated June 30, 2020, the Internal Revenue Service determined that the Plan constitutes a qualified trust under Section 401(a) of the Internal Revenue Code and is thus exempt from federal income taxes. Although the Plan has been amended since the determination letter, the Plan's administrator believes the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan evaluates all significant tax positions as required by generally accepted accounting principles in the United States of America. As of December 31, 2024, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability, nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next 12 months. The Plan's income tax returns are subject to examination by the appropriate regulatory authorities; there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to tax examinations for years prior to 2021.

### 4. PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such a person.

At December 31, 2024 and 2023, certain Plan investments were managed by affiliates of The Standard Insurance Company, the Custodian of the Plan. Agresta, Storms & O'Leary, PC served as the Plan's auditors. Transactions with these parties qualify as exempt party-in-interest transactions. The Company provides certain accounting, administrative and investment management services to the Plan, for which they receive no compensation. Fees paid by the Plan for investment advisory, management fees and administrative services totaled \$27,166 for the year ended December 31, 2024.

### 5. INVESTMENTS

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The Standard Insurance Company, the Custodian, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits and the schedule of assets (held at end of year) as of December 31, 2024 and 2023, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### 6. INVESTMENT IN STABLE VALUE FUND

The Plan had an investment in The Standard Insurance Company Standard Stable Asset A Fund (the Fund) as of December 31, 2024 and 2023. The Fund is a fully benefit-responsive investment fund for the collective investment of qualified plans. Because the investment is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fully benefit-responsive contracts. Such contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawal or transfer all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer(s). Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Fund to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The contract value of the investment in the Fund at December 31, 2024 and 2023 was \$784,691 and \$736,988, respectively.

### 7. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in accordance with ASC 820, *Fair Value Measurement and Disclosures*, in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

ASC 820 defines fair value, establishes a framework for measuring fair value under GAAP and expands disclosures about fair value measurements. ASC 820 also establishes a three-level fair value hierarchy that prioritizes the inputs used to measure fair value. This hierarchy requires that the Plan maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of inputs used to measure fair value are as follows:

Level 1 – Quoted prices in active markets for identical assets or liabilities. The fair value of mutual funds is based on quoted market prices which represent the last sales price on the last business day of the Plan at year end.

Level 2 – Observable inputs other than quoted prices in Level 1, such as quoted prices for similar assets and liabilities in active markets, similar assets and liabilities in markets that are not active or can be corroborated by observable market data.

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets and liabilities. This includes certain pricing models, discounted cash flow methodologies and similar techniques that use significant unobservable inputs.

### 9. RISKS AND UNCERTAINTIES

The Plan invests in certain mutual funds through pooled separate accounts that provide for various investment options in any combination of stocks, bonds, fixed income securities and other investment securities. Investment securities are exposed to various risks, such as interest rate risk, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to the changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect the amounts reported in the Plan's financial statements and could affect participants' account balances.

### 10. SUBSEQUENT EVENTS

In accordance with ASC Topic 855, *Subsequent Events*, the Plan has evaluated events through August 27, 2025, which is the date these financial statements were available to be issued, and has determined that there are no subsequent events that require disclosure in the financial statements.
