

A. Plan Description:

The following description of the DTJ Design, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

General:

The Plan, sponsored by DTJ Design, Inc. (The Company) is a participant-directed defined contribution plan covering all non-bargaining, full-time employees who have attained 2 months of service and are age 18 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. The plan administrator is responsible for the oversight of the Plan. John Hancock Life Insurance Company is the record keeper and custodian of the Plan. TPA Services serves as the third party administrator. Officers of the Company serves as trustees.

Contributions:

Each year, participants may make traditional or Roth contributions up to the maximum of 100 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company makes traditional safe harbor contributions to the Plan by matching 100 percent of the first 3 percent of salary deferrals plus 50 percent of salary deferrals between 3 percent and 5 percent. The Company may make discretionary profit-sharing contributions for eligible participants employed on the last day of the plan year. There were no approved discretionary profit-sharing contributions made for the years ended December 31, 2024 or 2023.

Participant Accounts:

Each participant's account is credited with the participant's contribution, allocation of the Company's contributions and plan earnings and any fees. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options:

Participants direct the investment of their contributions into various pooled separate accounts or the stable value fund option offered by the Plan. Participants may change their investment allocations at any time.

A. Plan Description (Continued):

Vesting:

Participants are immediately vested in their voluntary contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contributions is based on years of continued service. A participant is 100 percent vested after six years of credited service.

Forfeited Accounts:

Nonvested participants' accounts that are forfeited upon termination of service are used to reduce future employer contributions or pay plan expenses. Forfeitures used to pay employer contributions or plan expenses during the years ended December 31, 2024 and 2023 were \$1,287 and \$0, respectively. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,896 and \$5,318, respectively.

Payment of Benefits:

Upon termination of service due to death, disability, retirement, or separation of employment, a participant is eligible for distribution of his or her vested account balance. The Plan also allows for hardship withdrawals within certain limitations and in-service withdrawals for participants who have attained age 59.5. Participants may take a distribution from their rollover account at any time. Terminated participants with vested balances of \$5,000 or less will have their balances distributed upon termination.

Notes Receivable from Participants:

Participants may borrow from their participant accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. All loans are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence which may be approved for an extended repayment period). The loans are secured by the balance in the participant's account and bear interest at a rate comparable to the rates being charged by lending institutions in the same geographical locale as the Company. A loan will carry the same rate of interest throughout its term. Principal and interest is paid ratably through normal payroll deductions.

B. Summary of Accounting Policies and Investments:

Basis of Accounting:

The accompanying financial statements are prepared under the accrual basis of accounting.

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition:

The Plan's investments are reported at fair value, except the stable value fund which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the custodian. See *Note D* for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan's investment in the John Hancock Stable Value Guaranteed Income Fund was determined to be fully benefit responsive and is reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable from Participants:

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits:

Benefits are recorded when paid.

Administrative Expenses:

The Company absorbs administrative and operating costs of the Plan. Fees related to the administration of the Plan or associated with the investment of Plan assets may be paid by the Plan or by the Company at the Company's discretion. Fees related to member requested services are charged directly to the participant's account and are included in administrative expenses.

C. Information Certified by the Plan's Custodian:

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company, the custodian of the Plan, has certified the following information included in the accompanying financial statements and supplemental schedule of assets held at end of year is complete and accurate:

- Investments and notes receivable as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investments and notes receivable as shown in the accompanying supplemental information as of December 31, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

D. Fair Value Measurements:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

D. Fair Value Measurements (Continued):

The three levels of the fair value hierarchy under FASB ASC 820 are:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for identical or similar assets or liabilities in active or inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability or that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at net asset value per share, or its equivalent of the funds, which are based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. The underlying investments are mutual funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

E. Fully Benefit-Responsive Stable Value Fund:

As of December 31, 2024, the Plan offered a fully benefit-responsive investment contract with John Hancock Life Insurance Company (U.S.A.) (“John Hancock”), the John Hancock Stable Value Guaranteed Income Fund (the “SVF”). Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Contributions to the SVF contract become part of John Hancock’s general account. The contract is credited with interest in accordance with the interest crediting rate established and periodically adjusted by the issuer. The contract is charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract is a traditional guaranteed investment contract and is presented in the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by John Hancock, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expense. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. The crediting interest rate is based on a formula determined by the issuer, but it may not be less than 1%. Such interest rates are reviewed on a periodic basis for resetting.

E. Fully Benefit-Responsive Guaranteed Interest Contract (Continued):

The average yield of the investment for the year ended December 31, 2024 was 3.52%. The value of the contract at December 31, 2024 was \$468,094.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) termination of the contract, (2) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (3) plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. No such events occurred as of December 31, 2024.

F. Related Party and Party-In-Interest Transactions:

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan incurred administrative fees of \$81,017 and \$71,476 to the recordkeeper of the Plan during the years ended December 31, 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan. The Plan invests in certain assets that are sponsored by the custodian.

G. Plan Tax Status:

The Plan adopted a non-standardized pre-approved plan document provided by CCH Incorporated DBA FTWILLIAM.COM. The pre-approved plan has obtained a favorable opinion letter, dated June 30, 2020, from the Internal Revenue Service stating that the pre-approved plan constitutes a qualified plan under Section 401 of the Internal Revenue Code and that the related trust was tax-exempt. The Plan has not been amended since receiving the opinion letter and the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements for the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management performs an annual analysis of the Plan's various tax positions, assessing the likelihood of those positions being upheld upon examination by relevant taxing authorities. Management believes the Plan has conducted its operations in accordance with applicable income tax reporting requirements, and has properly maintained its tax-exempt status, and has taken no material uncertain tax positions that qualify for recognition or disclosure in the financial statements.

H. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

I. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

J. Revision of Previously Issued Financials:

During the preparation of the financial statements for the year ended December 31, 2024, management identified an error in the fair value leveling of pooled separate accounts under ASC 820. Specifically, pooled separate accounts were reflected as level 1 investments when they should have been level 2 in the financial statements for the year ended December 31, 2023. This error has been corrected in the accompanying financial statements.

The revision had no impact on the balance sheet or income statement for the year ended December 31, 2023. The revision impacts the presentation of these investments in the fair value hierarchy table in Note D where they have been included as level 2 investments.

K. Subsequent Events:

The Plan did not have any subsequent events through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued, for events requiring recording or disclosure in the financial statements for the year ended December 31, 2024.
