### Note 1 – Description of the Plan

The following description of the Navajo Manufacturing Company, Inc. (the "Company", "Employer", "Plan Administrator", or "Plan Sponsor") 401(k) Retirement Plan (the "Plan") provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan's provisions.

**General.** The Plan is a defined contribution plan, which was established January 1, 1994, that is generally available to all employees of the Company who have obtained age 21 and completed one month of service. The Plan excludes union employees, nonresident aliens, and leased employees. Employees may enter the Plan on the first of the month coincident with or after meeting the Plan's eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Benefits under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation.

**Plan Amendment.** The Plan Sponsor adopted a FIS Capital Markets US LLC Non-Standardized Pre-Approved Profit Sharing Plan, and the Plan document was amended and restated effective January 1, 2024. In connection with the Plan's amendment and restatement the following occurred:

- Modify the definition of "Compensation" to include Deemed §125 compensation;
- Permit Roth Elective Deferral Contributions;
- Adopt In-Plan Roth Rollover and Transfer provisions;
- Modify the eligibility requirements to age 21 and completion of one (1) month of Service;
- Exclude Leased Employees from participation in the Plan;
- Permit Elective Deferral Contributions up to the maximum amount allowed by Section 402(g) of the Internal Revenue Code;
- Modify the Employer Nonelective Profit Sharing Contribution formula to use a cross-tested allocation formula with each Participant in his/her own contribution rate group for compliance testing purposes;
- Modify the Matching Contribution formula to be 50% of deferrals up to 5% of compensation calculated on a per-payroll basis;
- Permit only Active Participants to make Rollover Contributions into the Plan;
- Modify Beneficiary provisions to dictate divorce will automatically revoke designation of Beneficiary to the spouse;
- Exclude amounts in a Participant's Rollover Account when determining whether the value of the Participant's vested account balance exceeds the \$5,000 threshold at which a Participant must consent to a distribution of his/her account;
- Adopt Hardship Distribution provisions, including limiting 1) the source of such distributions to an active Participant's Pre-Tax Elective Deferral Account, 2) the number of such distributions to one per Plan Year, and 3) the minimum amount of such distributions to \$1,000;
- Permit post-severance distributions to only be made as a single lump sum;
- Permit distributions to be made in cash or in property (in-kind transfer) if the funds are invested in a Personal Choice Retirement Account; and
- Permit Loan repayment to be made by check in cases of prepayment only.

**Change in Service Providers.** Effective January 1, 2024, the Plan Sponsor resolved to remove Reliance Trust Company, the trustee of the Plan, and T. Rowe Price, the recordkeeper of the Plan, and appoint Charles Schwab Trust Bank, to the trustee of the Plan, and Jocelyn Pension Consulting, LLC, to the recordkeeper of the Plan. In connection with this change in service providers, the Plan's assets were transferred from Reliance Trust Company to Charles Schwab Trust Bank in May 2024.

**Contributions.** The following types of contributions are allowable under the Plan:

- **Salary Deferral Contributions** – Participants may contribute up to 100% of their pre-tax annual compensation, as defined in the Plan document, subject to limitations. Participants may also contribute a percentage of their after tax compensation and designate it as a Roth deferral contribution. The Plan has an eligible automatic contribution arrangement ("EACA"). Unless an eligible participant makes an affirmative election otherwise after being given appropriate notice, 2% of their compensation will be withheld and contributed to the Plan as an elective deferral contribution. Participants who are auto-enrolled under the EACA can elect a permissible withdrawal within 60 days of their first automatic deferral. A participant's total salary deferral contributions cannot exceed \$23,000 (\$30,500 if 50 or older) in calendar year 2024.
- **Discretionary Employer Matching Contributions** – The Company may contribute a discretionary Employer matching contribution each payroll period to eligible participants equal to a uniform percentage of a participant's salary deferral contributions. For the year ended December 31, 2024, eligible participant's received a discretionary Employer matching contribution equal to 50% of a participant's contribution up to 5% of a participant's eligible compensation each payroll period.
- **Discretionary Employer Nonelective Contributions** – The Employer may make a discretionary Employer nonelective contribution to those eligible participants who are actively employed as of the last day of the Plan year or who have completed more than 500 hours of service during the Plan year. Participants not employed on the last day of the Plan year due to death, disability, or reaching normal retirement age are also eligible to receive a discretionary Employer nonelective contribution. This contribution is allocated to each eligible participant's account in the ratio that each participant's compensation bears to the compensation of all eligible participants. During 2024, the Employer did not make a discretionary nonelective contribution.
- **Rollover Contributions** – Certain amounts distributed to participants from other qualified employee benefit plans may be rolled into the Plan.

All contributions are allocated to the Plan's investment funds at the direction of the participants.

**Participant Accounts.** Each participant's account is credited with the participant's contributions (salary deferrals and rollovers, if any) and an allocation of (a) the Employer's contribution (discretionary matching and discretionary profit sharing, if any), (b) fund earnings or losses, and (c) administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Vesting.** Participants are immediately vested in their salary deferral contributions, rollover contributions, and related earnings thereon. Employer contributions are subject to a six year graded vesting schedule, whereas a participant becomes 100% vested after six years of service. Additionally, participants who incur a severance from employment due to death or disability also become 100% vested in the Employer contribution portion of their accounts.

**Forfeitures.** When certain terminations of Plan participation occur, the non-vested portion represents a forfeiture. Forfeitures are used to pay administrative expenses of the Plan or are used to reduce discretionary Employer contributions. During 2024, no forfeitures were used to reduce discretionary Employer contributions. The balance in the forfeitures account is \$13,290 and \$10,460 as of December 31, 2024 and 2023 respectively.

**Investments.** Participants may direct their investments into various mutual funds and a money market fund.

**Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000. The maximum loan is the lesser of (i) \$50,000 minus the highest loan balance in the previous 12-month period, or (ii) 50% of their vested account balance. Loan terms range up to a maximum of 5 years (a longer term is available if used for the purchase of a principal residence). The loans are secured by the balance in the participant's account and bear a reasonable rate of interest commensurate with local prevailing rates at the date the loan is granted as determined by the Plan administrator. Principal and interest payments are generally paid ratably through payroll deductions.

**Payment of Benefits.** Benefits to participants or beneficiaries generally are payable as a lump sum, installments, or rollover distribution equal to the value of their vested account balance upon retirement, disability, death, or termination of the participant. A terminated employee with a balance of less than a certain dollar threshold, as defined by the Plan document, may be automatically paid out by the Plan upon termination. Additionally, participants may request an in-service withdrawal of their rollover contributions account, for a qualified reservist distribution or a deemed severance of employment, upon attainment of age 59½, or if they incur a financial hardship, as defined, if certain criteria are met.

### Note 2 – Summary of Significant Accounting Policies

**Basis of Accounting and Use of Estimates.** The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition.** The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions.** Participant contributions and the related Employer matching contributions are recognized in the period in which participant contributions are withheld from compensation.

**Benefits Payments.** Benefits are recorded when paid.

**Excess Contributions Payable.** Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Code ("IRC") are recorded as a liability and corresponding expense. The Plan distributes the excess contributions to applicable participants after the Plan's year end.

**Notes Receivable from Participants.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Expenses.** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Also included in administrative expenses are recordkeeping, trustee, distribution, investment management, account maintenance, and other fees. Certain investment related expenses are included in investment income.

### Note 3 – Fair Value Measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

**Level 1.** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2.** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3.** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

- Mutual funds and money market funds are valued at the quoted net asset value ("NAV") of shares / units held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination or partial termination, affected participants will become 100% vested in their accounts.

### Note 6 – Tax Status

The Company has adopted a FIS Capital Markets US LLC Non-Standardized Pre-Approved Profit Sharing Plan ("pre-approved plan"). The pre-approved plan received an opinion letter from the Internal Revenue Service ("IRS") on August 1, 2023, which stated that the pre-approved plan is qualified under the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan and pre-approved plan have been amended since receiving the IRS opinion letter, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified under Section 401(a) of the IRC and the related trust is tax exempt as of December 31, 2024 and 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 8 – Party-In-Interest Transactions

The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

Certain Plan investments are a mutual fund and a money market account offered by Schwab. As Charles Schwab Trust Bank is the trustee of the Plan, these transactions qualify as party-in interest transactions. Certain Plan investments were shares of mutual funds and a money market fund offered by T. Rowe Price. As T. Rowe Price was a service provider to the Plan, these transactions qualify as party-in-interest transactions.

The Plan's trustee, Charles Schwab Trust Bank; the Plan's former trustee, Reliance Trust Company; the Plan's third-party administrator and recordkeeper; the Plan's former recordkeeper, T. Rowe Price; the Plan's investment advisor; the Plan's auditors; the Plan's external legal counsel; the Employer; and Plan participants are all parties-in-interest to the Plan. Additionally, the Plan maintains notes receivable from participants. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

### Note 9 – Nonexempt Prohibited Transactions

During 2024, 2021 and 2020, the Company had nonexempt prohibited transactions related to participant contributions and loan repayments not remitted to the trust in a timely manner as listed in the aggregate on Schedule H, Line 4a: Schedule of Delinquent Participant Contributions. The principal amount of the late contributions and loan repayments have been remitted to the Plan's trust. The Company corrected the 2021 and 2020 late contributions and loan repayments by remitting lost earnings into the Plan's trust in October 2024. The Company intends to correct the 2024 late contributions and loan repayments by remitting lost earnings into the Plan's trust as soon as administratively feasible.

### Note 10 – Concentrations, Risks, and Uncertainties

The Plan provides for various investment options in mutual funds and a money market fund. Investment securities, in general, are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts presented in the statements of net assets available for benefits. As of December 31, 2024 and 2023, there was two and one investment, respectively, which individually represented more than 10% of net assets available for Plan benefits. See supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at December 31, 2024.

Additionally, some investments held by the Plan are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.
