Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Carnegie Corporation of New York Defined Contribution Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 9, the financial statements include an investment representing 22% and 24% of the total assets as of December 31, 2024 and 2023, respectively, whose fair value has been estimated using unobservable inputs in the absence of readily ascertainable fair value. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Notes to Financial Statements

Note 1. Plan Description

The following description of the Carnegie Corporation of New York (the Institution or Plan Sponsor) Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution pension plan intended to qualify under Section 401(a) of the Internal Revenue Code (IRC). As such, the Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was formed on November 17, 1921, and was most recently amended and restated effective on January 1, 2021.

Eligibility: An individual employed by the Institution will begin participation in the Plan as follows:

If hired prior to July 1, 2009:

- i. For periods prior to February 1, 2001, on the plan entry date following the completion of one year of service or age 26, whichever occurs first.
- ii. For periods on and after February 1, 2001, on the plan entry date immediately following his or her Date of Employment (but not before February 2001).

If hired on or after July 1, 2009:

- iii. For employees regularly scheduled to work at least 35 hours of service per week, eligibility occurs on the plan entry date immediately following his or her Date of Employment.
- iv. For employees regularly scheduled to work fewer than 35 hours per week, eligibility occurs on the plan entry date immediately following the date such employee completes a year of service.

Plan administration: The Plan Sponsor is also the Plan Administrator. The Plan Sponsor's Chief Human Resources Officer is responsible for plan administration functions. The Plan's assets are held in a trust created under the terms of the Plan. TIAA and CREF Trust Company, FSB is the custodian and Trustee for the plan and its assets. Pursuant to the Trust Agreement, the Trustee has no discretion or authority with respect to the investment of the trust assets and will only invest as directed by TIAA and CREF.

Contributions: Plan contributions will be made by the Institution on behalf of all participants, subject to limitations as defined in the Plan agreement and by the IRC. Plan contributions are calculated as a percentage of compensation on the portion of compensation within the Social Security Earnings Base (SSEB) and on any compensation above the SSEB up to the IRC limit, as follows:

<u>Plan Contributions as a Percentage of Compensation</u>	<u>By the Institution</u>
On the portion of compensation within the SSEB	15%
On any compensation above the SSEB up to the IRC limit	20%

Participants may direct the investment of the contributions into various investment options offered by the Plan.

Note 1. Plan Description (Continued)

Participants' accounts: Each participant's account is credited with the employer's contributions and the Plan's earnings. Allocations are based upon participants' eligible compensation and account balance.

Vesting: Pursuant to the Plan amendment on December 2, 2020, which was effective January 1, 2021, a participant shall have a fully vested and non-forfeitable interest in his or her pension contribution account. A participant will also become fully vested upon attainment of normal retirement age, upon death, or becoming disabled while an employee. Participants whose employment terminated prior to January 1, 2021, remain subject to the vesting provisions in effect prior to January 1, 2021, as follows:

- (a) Accumulation accounts of participants whose first hour of service was performed prior to July 1, 2009, will at all times be 100% vested and nonforfeitable.
- (b) Accumulation accounts of participants whose first hour of service was performed on or after July 1, 2009, will vest in accordance with the following schedule:

Years of Service	Vested Percentage
Less than 3	0%
3 or more	100%

Forfeitures: Forfeited balances of terminated participants' nonvested accounts are used to reduce future employer contributions. During 2024, \$6,987 was used to reduced employer contributions. At December 31, 2024 and 2023 forfeited balances were \$2 and \$318, respectively.

Payment of benefits: Upon retirement, death or termination of employment, participants or their beneficiaries may elect to receive their vested interest in their account in the form of single life annuities, joint and survivor annuities, cash withdrawals, repurchase of participants' annuities by TIAA and CREF and fixed period annuities.

A participant who has terminated employment may receive a cash withdrawal of 25% (10% prior to February 1, 2001) of his or her accumulation account(s) as permitted by the relevant annuity contracts, mutual funds, or custodial accounts. The Plan amendment on December 2, 2020, which was effective on January 1, 2021, increased the 25% cash withdrawal limitation to 50% of a participant's accumulation account. The remaining amount is not payable as a cash withdrawal, except for the amount permitted through the Retirement Transition Benefit. This allows a participant to elect to receive a one-time lump-sum payment of up to 10% of the participant's accumulation account balance in TIAA and CREF at the time annuity income begins, provided the one-time payment from each TIAA contract and/or CREF account does not exceed 10% of the respective accumulation accounts being converted to retirement income.

Participant loans are not allowed by the Plan.

Note 2. Summary of Significant Accounting Policies

The Plan's significant accounting policies are as follows:

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Payment of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Administrative expenses include certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator and management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

Valuation of investments and income recognition: The Plan's investments are reported at fair value except for its non-benefit-responsive investment contracts, which are reported at contract value, which approximates fair value (see Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's fair value measurements are described in Note 5.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by TIAA and CREF

The Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule were prepared by or derived from, the information provided by TIAA and CREF as the issuer for certain investments and recordkeeper and TIAA and CREF Trust Company, FSB, as custodian of certain other investments (collectively, TIAA and CREF) and furnished to the Plan Administrator.

The Plan Administrator has obtained certifications from TIAA and CREF that the information provided to the Plan Administrator that the investments reported at fair value on December 31, 2024 and 2023 in the amount of \$95,492,210 and \$85,612,378, respectively, is complete and accurate. TIAA and CREF also certified the completeness and accuracy of \$8,756,653 of net appreciation in fair value of investments, \$1,305,324 of interest and dividends and \$79,576 of other income for the year ended December 31, 2024. Accordingly, as permitted by 29 CFR 2520.103-8, of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the certified information that appears throughout the financial statements and ERISA-required supplemental schedule.

Note 4. Investment Contract with TIAA

The Plan holds a Retirement Annuity contract with TIAA Traditional Annuity, which is non-benefit-responsive. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Each premium allocated to the fixed annuity investment contract buys a guaranteed minimum amount of lifetime income based on the rate schedule in effect at the time the premium is credited. This contract does not allow lump-sum cash withdrawals from the TIAA Traditional Annuity and transfers must be spread out in 10 annual installments. The interest crediting rates for the year ended December 31, 2024, were 5.50% (January 2024 to June 2024) and 5.25% (July 2024 to December 2024).

For investment contracts that are non-benefit-responsive, fair value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. These contracts are included in the financial statements at contract value, which approximates fair value, as reported to the Plan by TIAA. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 3%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or a merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 5. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets

Note 5. Fair Value Measurements (Continued)

- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There were no transfers between Level 2 and Level 3 during the year.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023.

TIAA traditional annuity: This is a fixed rate annuity contract that is fully and unconditionally guaranteed and backed by TIAA's claims-paying ability and is reported at contract value, which approximates fair value. This investment is classified as Level 3.

Mutual funds: These funds invest principally in equity securities, fixed income instruments, other mutual funds and short-term instruments in accordance with each fund's investment objectives. Fund holdings are generally valued using market quotations or prices obtained from independent pricing services, except those held by the TIAA and CREF Money Market Fund, whose holdings are valued at amortized cost. Each fund determines its share price or net asset value daily. These funds are classified as Level 1.

CREF accounts: The accounts invest principally in equity securities, fixed-income instruments, and short-term investments in accordance with each portfolio's investment objectives. Account investments are primarily valued using market quotations or prices obtained from independent pricing sources that employ various pricing methods to value the investments including matrix pricing. CREF Money Market Account holding is generally valued at amortized cost. Each account calculates and publishes its unit value daily. These accounts are classified as Level 1.

TIAA real estate account: This TIAA Real Estate Account (REA) generally invests in real estate properties and real estate-related investments. The REA's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The REA sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. Unit values are calculated and published daily. This account is classified as Level 1.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

At December 31, 2024 and 2023, the TIAA traditional annuity with a fair value of \$21,309,131 and \$20,926,973, respectively, was valued using discounted cash flows at risk-adjusted discount rates of 4.61% and 4.24%, respectively, and theoretical transfer (exit price).

Note 6. Related Party Transactions

Certain Plan investments are managed by TIAA and CREF. TIAA and CREF is the recordkeeper, as defined by the Plan and, therefore, the transactions qualify as party-in-interest transactions. Transactions with TIAA and CREF are not considered prohibited transactions in accordance with appropriate ERISA exceptions.

Excess revenue generated by the Plan, as established in the recordkeeping services agreement with TIAA and CREF, is deposited into the Plan's revenue credit account. This revenue may be utilized to offset reasonable and necessary plan expenses. For the year ended December 31, 2024, the Plan received approximately \$21,000 from this revenue-sharing agreement, along with \$58,000 in plan servicing credits, which were used to offset approximately \$19,000 in plan service fees. Both the excess revenue and the plan servicing credits are reported as other income on the statement of changes in net assets available for benefits. The balance of the excess revenue and service credits is allocated to plan participants after reasonable and necessary plan expenses are paid.

Note 7. Tax Status

The Plan has not received a determination letter from the Internal Revenue Service stating that the Plan is qualified under Section 401(a) of the IRC. However, as permitted by Revenue Procedure 2016-6, the Institution has elected to rely on the favorable advisory letter issued on September 30, 2014, to the volume submitter plan provider, The Angell Pension Group, Inc. In addition, the Plan Administrator believes that the Plan is qualified and, therefore, the related trust is exempt from taxation.

The Plan Sponsor's management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and has taken no uncertain tax positions that require adjustments to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Institution has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities that are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan holds \$21,309,131 and \$20,926,973 as of December 31, 2024 and 2023, respectively, in TIAA Traditional Annuity which represents a concentration of credit risk with TIAA.

Generally accepted accounting principles require the financial statements to present the fair value of investments. TIAA indicates that contract value approximates fair value for the traditional annuities on December 31, 2024 and 2023, as TIAA's credit rating of AAA and yield during 2024 and 2023, is comparable to similar alternative investments, and the interest rate, which resets annually, is comparable to a 10-year treasury bond.

In subsequent periods, if market conditions change, such as the insurance credit rating or interest rate environment, the difference between contract value and fair value could become significant.
