Responsibilities of Management for the Financial Statements

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Fort Healthcare, Inc. Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Fort HealthCare, Inc. and Fort Medical Group, Inc. (collectively the "Sponsor") who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may elect to defer between 1% and 100% of total compensation, as defined by the Plan, subject to limitations allowed by the Internal Revenue Service (IRS). Eligible participants are automatically enrolled in the Plan with a deferral rate of 6% of compensation, unless the participant opts out. The automatic deferral rate increases 1% annually, up to a maximum of 12%. The Sponsor matches 100% of participant contributions, up to 4% of participant's compensation, to the Plan. Participants may also contribute amounts representing distributions from other qualified retirement plans ("rollovers"). Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's and Sponsor's contribution, an allocation of Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their contributions and the Sponsor's contributions, plus actual earnings (losses) thereon.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant or a designated beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested account balance or receive the benefits in installments through the purchase of an annuity. Purchased annuities are not included as part of the Plan's assets. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Under certain circumstances, participants may qualify to receive a hardship distribution prior to death, disability, retirement, or other termination (less applicable income taxes and penalties) from their account balance. The Plan also allows for in-service distributions upon attaining age 59 ½.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that directly affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

The Sponsor has elected to pay substantially all professional services provided to the Plan. Expenses that relate to the general administration of the Plan are shown separately, and are paid equally by each participant based on a percentage of a participant's account.

Subsequent Events

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Fair value is estimated using the NAV per unit provided by the investment issuer. The NAV is used as a practical expedient to estimating fair value. The NAV is based on the fair value of the underlying investments held by the pooled separate account.

Common collective trust: Fair value is estimated using the NAV per unit provided by the investment issuer. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the common collective trust. They include conventional contracts with insurance companies, synthetic investment contracts, short-term fixed income securities, and debt securities. Conventional contracts use a discounted cash flow model, applying contracted cash flows to prevailing yield curves. Synthetic investment contracts are valued at quoted market prices. Short-term securities and debt securities are valued based on pricing models using yields currently available on comparable securities of issuers with similar credit ratings.

The preceding methods above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All investments of the Plan can transact continuously, have no funding commitments, and no redemption notice periods.

Note 4: Information Prepared and Certified by Custodian

Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the custodian of the Plan.

Note 5: Plan Termination

Although it has not expressed any intention to do so, the Sponsor has the right under the plan document to terminate or partially terminate the Plan subject to the provisions of ERISA.

Note 6: Tax Status

The IRS has determined and informed the Plan by a letter dated June 30, 2020, that the Plan and related trust were designed in accordance with applicable sections of the Internal Revenue Code.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8: Party-In-Interest Transactions

Certain Plan investments are managed by Principal Financial Group, an affiliate of Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. These transactions are not considered prohibited under ERISA.
