We have performed audits of the accompanying financial statements of Las Vegas Properties 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS
FOR THE YEAR ENDED DECEMBER 31, 2024

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Las Vegas Properties 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Las Vegas Residential Properties LLC (the “Company”). The Plan is sponsored by the Company, and became effective on February 1, 2018. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following types of contributions may be made under this plan:

- Employee salary deferrals
- Employee rollover contributions
- Employer matching contributions
- Employer nonelective contributions

Eligibility

All employees who have three months of service and are age 21 or older are eligible to participate in the Plan. Employees become eligible to participate on the first day of the month following satisfaction of the eligibility requirements.

Contributions

Each year, participants may contribute up to 75% of pretax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other retirement plans and certain IRAs (rollover).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated target date fund until changed by the participant. The deferral rate increases 1 percent per year up to a maximum of 6 percent of eligible compensation unless changed by the participant.

The Company makes a matching contribution of 50 percent of the of the first 3 of base compensation that a participant contributes to the Plan, not to exceed \$1,800 per year on behalf of any participant. During the year ended December 31, 2024, the Company made matching contributions to the Plan of \$49,727.

Additional nonelective contributions may be made by the Company. During the year ended December 31, 2024, the Company did not make any nonelective contributions to the Plan.

Participants direct the investment of the contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Employer contribution and an allocation of Plan earnings. Each participant's account is credited with investment gain or loss as of each valuation date. The valuation date occurs daily. Earnings and losses are allocated to each participant's account using a weighted average of participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective contributions, plus or minus earnings or losses. Vesting in Employer contributions is based on years of continuous service according to the following schedule:

<u>Years</u>	<u>Percent Vested</u>
0-2	0%
3 or more	100%

Participants are considered fully vested upon attainment of retirement age, retirement due to disability, death, and upon termination of the Plan.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. Participants may have only one loan outstanding at any time. Principal and interest is paid ratably through payroll deductions each pay period.

Benefit Payments

On termination of service or retirement, the funds remain in the Plan until the separated participants submit a request for payment. Participant accounts with a balance of \$5,000 or less may be cashed out at the direction of the Plan Sponsor. There were no amounts allocated to withdrawing participants for the benefit claims that have been processed and approved for payment prior to December 31, 2024, but not yet paid as of that date.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,027 and \$66,755, respectively. These accounts may be used to reduce future employer contributions and/or pay plan expenses.

During the year ended December 31, 2024, \$6,250 of forfeitures was used to pay plan expenses and \$88,777 was used to reduce employer match contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The Plan financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with the accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefits are recorded when paid.

Costs and Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – Inputs to the valuation methodology include

- quoted market prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds – These investments are public investment vehicles using the Net Asset Value (“NAV”) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities and then divided by the number of shares outstanding. The NAV is quoted in an active market and classified within Level 1 of the valuation hierarchy.

Group Annuity Contract – The Empower Investment Fixed Account Series VI allows participating plan sponsors to invest in a guaranteed investment contract which provides a fixed interest rate to participants. The interest rate is reset each quarter as determined by Empower Annuity Insurance Company of America (EAICA). The contributions are invested in a portfolio of financial instruments and the fixed interest rate is guaranteed to the participants by EAICA. This investment is reported at fair value, which is equal to contract value as reported to the Plan by EAICA.

NOTE 4 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE 5 – TAX STATUS

The Plan uses a non-standardized 401(k) prototype plan agreement prepared by Empower Retirement LLC. The prototype plan received a favorable determination letter from the Internal Revenue Service on November 14, 2022 with respect to the qualified tax status of the Plan under applicable sections of the Internal Revenue Code.

NOTE 6 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is a least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company (the trustee of the Plan).
