December 31, 2024 and 2023

1. Description of the Plan

The following description of R1 RCM Holdco Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. Copies of the plan document are available from the Human Resources Department of R1 RCM Holdco, Inc. (the Employer, the Company, or the Plan Sponsor).

General

The Plan was established on September 1, 2005, and is a contributory, defined contribution plan covering all eligible employees of the Plan Sponsor. The Plan switched to a safe harbor 401(k) plan, effective January 1, 2023. The minimum age for an employee to become eligible to participate in the Plan is 18. There is no service requirement to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan Mergers

On January 1, 2024, the TriNet 401(k) Plan for Tonic employees was merged into the Plan and, on January 2, 2024, net assets of \$190,559 were transferred into the Plan. The net assets transferred to the Plan are reflected on the statement of changes in net assets available for benefits as a transfer from other qualified plans in 2024.

On January 17, 2024, the Plan Sponsor completed the acquisition of the revenue cycle management business (Acclara) of Providence Health & Services – Washington and certain of its affiliates. Effective July 1, 2024, former Acclara employees became eligible to participate in the Plan. On December 31, 2024, net assets of \$2,567,191 from the Acclara 401(k) Plan were transferred into the Plan. The net assets transferred to the Plan are reflected on the statement of changes in net assets available for benefits as a transfer from other qualified plans in 2024.

Contributions

The Plan allows eligible participants to elect to defer a portion of their compensation, as defined, on a pretax or a Roth after-tax basis. This amount may not exceed the limit imposed each year by the Internal Revenue Service (the IRS). Participants may also contribute amounts representing distributions from other qualified plans, as defined in the plan document. Participants age 50 and over may make catch-up contributions. The Plan provides an option to participants to enroll in an annual increase program when starting their deferrals. Under the program, participants may elect to establish regular annual increases to their contribution amount.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

The Employer may make discretionary matching contributions. Effective January 1, 2023, the Company's matching contribution is 100% on the first 3% and 50% on the next 2% deferred by participants. In addition, annual discretionary contributions may be made in an amount determined by the Plan Sponsor. No such contributions were made for the 2024 or 2023 plan years.

Participants direct their elective contributions into various investment options offered by the Plan, including a self-directed brokerage feature, and can change their investment options on a daily basis. The Company's contributions are allocated in the same manner as that of the participant's elective contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's discretionary matching contributions and discretionary contributions, if any, and (b) the Plan's earnings and losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All amounts in participant accounts are participant directed.

Vesting and Payment of Benefits

A participant is always fully vested in participant contributions and earnings thereon. Participants hired prior to July 1, 2017 are always fully vested in their employer contributions and earnings thereon. Participants hired after July 1, 2017 are subject to a three-year cliff vesting on employer contributions and earnings thereon for matching contributions made prior to January 1, 2023. For participants who previously participated in the Intermedix Staffing 401(k) Plan, employer contributions made prior to January 1, 2023 are subject to a two-year cliff vesting, regardless of whether the contribution was made to their Intermedix Staffing 401(k) or plan account. For participants who previously participated in the VisitPay 401(k) Plan and were employed with the sponsoring employer on November 15, 2021, employer contributions made prior to January 1, 2023 are subject to a three-year graded vesting. For participants who previously participated in the VisitPay 401(k) Plan and terminated employment before November 15, 2021, non-safe harbor contributions merged from the VisitPay 401(k) Plan into the Plan were vested according to four-year graded vesting under the legacy VisitPay 401(k). For participants who previously participated in the Cloudmed Solutions 401(k) Plan, employer contributions made prior to January 1, 2023 are subject to a three-year graded vesting. For participants who previously participated in the Cloudmed Solutions 401(k) Plan with a balance in the prior NAVEOS PS source, balances

subsequently transferred to this Plan are fully vested. For participants who merged from the Triage Consulting Group Retirement Plan into the Cloudmed Solutions 401(k) Plan on January 1, 2021, and were subsequently transferred to this Plan, discretionary match contributions are fully vested. Any employer matching contributions made after January 1, 2023 vest 100% immediately. Forfeitures resulting from employee terminations are used to offset future employer contributions and pay administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$289,355 and \$592,823, respectively.

On termination of service due to disability, retirement, or termination of employment, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum or installment payments. In-service and hardship withdrawals are permitted under certain circumstances.

Participant Loans

Generally, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loan terms range up to five years or up to ten years if it is for the purchase of a primary residence (after July 1, 2022). The loans are secured by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest are paid ratably through payroll deductions or paid directly to the record-keeper after termination.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Plan Sponsor, as provided by the Plan's provisions. Administrative expenses paid by Plan include record-keeping and trustee fees. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. Loan fees are paid by affected participants. All other administrative expenses of the Plan are paid by the Plan Sponsor and are excluded from these financial statements.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of the Plan's termination or partial termination, the account of each affected participant shall become fully vested.

2. Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Excess Contribution Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions on the statements of net assets available for benefits to the applicable participants prior to April 15 of the subsequent year.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion of fair value measurements.

2. Significant Accounting Policies (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

3. Investments

Certain investment information disclosed in the accompanying financial statements and supplemental schedules, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, dividend and interest income, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the trustee of the Plan for the 2024 and 2023 plan years.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable, either directly or indirectly, for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in markets that are not active
 - Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level of input that is significant to the fair value measurement in its entirety.

Descriptions of the valuation techniques and inputs used for each general type of asset measured at fair value by the Plan are as follows:

Mutual funds: Valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end.

Money market cash account: Valued at \$1.00 par, which represents the NAV of shares held by the Plan at year-end.

Self-directed brokerage accounts: Accounts primarily consist of registered investment companies, interest-bearing cash, and common stock. Registered investment companies are valued at quoted market prices, which represent the NAV of shares held by the Plan at year-end. Common stock is valued at the closing price reported in the active market in which the individual securities are traded.

5. Income Tax Status

The underlying preapproved plan has received an opinion letter from the IRS, dated June 30, 2020, stating that the written form of the underlying preapproved document is qualified under Section 401 of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Related-Party and Party-in-Interest Transactions

Certain plan investments are mutual funds and money market accounts managed by the trustee of the Plan for the 2024 and 2023 plan years. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

8. Subsequent Events

Management evaluated subsequent events for the Plan through October 9, 2025, the date the accompanying financial statements were available to be issued. Other than the following, there were no subsequent events that have occurred which would require adjustments to or disclosure in the Plan's financial statements.

Plan Merger

The remaining net assets from the Acclara 401(k) Plan of \$56,031,217 were transferred into the Plan on January 2, 2025.

9. Reconciliation of Financial Statements to Form 5500

For purposes of the Form 5500 filing, the transfer of the remaining net assets from the Acclara 401(k) Plan of \$56,031,217 was treated as if it occurred at the end of the 2024 plan year.
