Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Johnstone Supply Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE I – DESCRIPTION OF PLAN

The following description of the Johnstone Supply Savings Plan (the “Plan”) is provided for general information purposes only. More complete information regarding the Plan’s provisions may be found in the Plan document which can be obtained from the Plan Administrator.

General

KIPO, L.L.C. (the “Company”) is the Plan sponsor. The Plan was established effective January 1, 1998 and has since been amended, the latest amendment being January 1, 2024. The Plan is a defined contribution plan covering substantially all employees of the Company and the related companies of The Petit Group, L.L.C., Petit and Associates, L.L.C. and PAA104, L.L.C. (collectively the “Companies”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Eligible employees, as defined by the Plan, become participants upon obtaining age 21 and 1 year of service. The Plan entry date is the first day of the month following a participant’s one year anniversary.

On October 1, 2025, substantially all of the Companies’ assets were sold to Johnstone NOLA, LLC, a Delaware LLC. See Note II – Subsequent Events.

Contributions

Under the terms of the Plan, participants may make contributions by electing to defer the maximum amount of their salary allowed by law, including catch-up contributions for participants 50 years old or older. Participants may suspend contributions at any time. Effective January 1, 2022, the Companies amended the Plan to allow for participants to elect to contribute after-tax basis Roth contributions.

The Plan has matching contributions from the Companies and participants may receive profit sharing contributions at the employers’ discretion. Effective January 1, 2022, the Companies amended the Plan to include safe harbor matching contributions. The Companies will contribute a safe harbor matching contribution equal to 100% of employee contributions that are not in excess of 3% of employee plan defined compensation plus 50% of the employee contributions that exceed 3% of employee plan defined compensation but do not exceed 5% of employee plan defined compensation. For the years ended December 31, 2024 and 2023, there was no profit-sharing contribution made.

Participant Accounts

Individual accounts are maintained for each of the Plan’s participants to reflect the participant’s share of the Plan’s income including the participant’s contributions and employer’s contributions. Allocations are based on participant account balances, as defined.

NOTE 1 – DESCRIPTION OF PLAN – (Continued)

Vesting

Effective January 1, 2022, participants are immediately vested in their elective contributions and employer contributions.

Payment of Benefits

Participant withdrawals from elective contribution accounts are subject to certain hardship rules provided by the Plan. The Plan, as amended, allows for non-hardship withdrawals once a participant reaches normal retirement age. All vested Companies' contributions may be fully withdrawn upon termination of employment. Benefits are generally payable upon termination of service as a lump-sum payment.

Forfeitures

Upon termination of service as defined by the Plan, any portion of the balance in a participant's account which is not vested is forfeited and applied against employer contributions or administrative fees for the Plan year. Forfeitures pending utilization based upon the requirements of the Plan totaled \$0 at December 31, 2024 and 2023, respectively. During the years ended December 31, 2024 and 2023, forfeitures were used to reduce employer contributions by \$0 and \$301 and were used to reduce administrative expenses by \$0 and \$1, respectively.

Participant Loans

Loans are not permitted in the Plan.

Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate risk, credit risk and overall market risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – (Continued)

Valuation of Investments

The Plan's investments, except for the Transamerica Stable Value Focus Option Fund, are stated at fair value as determined by the custodian based on the quoted market value of the underlying assets. The Transamerica Stable Value Focus Option Fund is stated at contract value as determined by the issuer based on the cost of the underlying investments plus accrued interest income less amounts withdrawn to pay benefits.

Benefit Payments

Benefits are recorded when paid.

Amounts allocated to withdrawing participants that have terminated the Plan as of December 31, 2024 and 2023, but have not been paid as of year-end amounted to \$2,715 and \$0 respectively.

Administrative Expenses

Expenses related to the record-keeper and custodian services provided by Transamerica Retirement Solutions, LLC and Reliance Trust Company are paid by the Plan. Certain administrative expenses including record-keeper and third-party administrative fees incurred are charged to the applicable participant. Administrative expenses totaled \$67,211 and \$57,144 for the years ended December 31, 2024 and 2023, respectively, with \$0 and \$1 from the forfeiture account used to reduce administrative expenses. The costs of the audit of the Plan are paid by the Plan Sponsor.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities. Actual results may differ from these estimates.

NOTE 3 – INVESTMENTS (UNAUDITED)

Reliance Trust Company is the custodian of the Plan, held the Plan's investments, and executed Plan transactions in 2024 and 2023. Participants are permitted to invest all amounts (participant contributions) in any of the investment alternatives available under the Plan. Participants may change their elected salary deferral rate at any time. Participants are required to pay all asset expense charges.

The Plan holds investments in a stable value fund, which consists of deposit liabilities of Transamerica, wrapped by fully benefit-responsive investment contracts. The fully benefit-responsive investment contracts enable the fund to realize a specific known value for the assets if it needs to liquidate them for benefit payments. The fully benefit-responsive investment contracts are issued by banks and insurance companies and serve to preserve the value of the fund's investments by mitigating fluctuations in the market value of the associated underlying investments. These investment contracts are fully benefit-responsive in that they allow for participant withdrawals at contract value for benefit-responsive requirements. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of these contracts was \$428,777 and \$333,802 as of December 31, 2024 and 2023, respectively.

During 2024 and 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$865,951 for 2024 and \$1,208,337 for 2023.

NOTE 4 – INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN (UNAUDITED)

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's financial statements and supplemental schedule include unaudited information that was prepared by the Plan custodian, Reliance Trust Company. The custodian has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, as shown in the Statements of Net Assets Available for Benefits, as of December 31, 2024 and 2023.
- Net appreciation in value of investments, dividends, and capital gain distributions as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Information contained in the Schedule of Assets (Held at End of Year) at December 31, 2024, as shown on Schedule H.

NOTE 5 – TAX STATUS

The Plan adopted a Volume Submitter Profit Sharing Plan which received an opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's Form 5500 for the years ended December 31, 2021, 2022 and 2023 remain subject to examination by the taxing authorities. The 2024 Form 5500 has not yet been filed.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are fully vested in their accounts, including any income earned, and would be distributed their full account balances.

NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of Transamerica funds managed by affiliates of Reliance Trust Company. Reliance Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

NOTE 8 – FAIR VALUE MEASUREMENTS

The Financial Accounting Standard Board ("FASB"), authoritative guidance for fair value measurements, defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The guidance also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The standard describes three levels of inputs that may be used to measure fair value:

Level I: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. The funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be activity traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 9 – GUARANTEED INVESTMENT CONTRACT

The Transamerica Stable Value Focus Option (Fund) is a group annuity contract that offers a full guarantee on principal and interest by the Transamerica Financial Life Insurance Company (Issuer). The contracts are fully benefit-responsive. The Fund qualifies as a fully benefit-responsive investment contract because it meets all of the following criteria:

1. The investment contract is effected directly between the Fund and the Issuer and prohibits the Fund from assigning or selling the contract or its proceeds to another party without the consent of the Issuer.
2. The contract Issuer is obligated to (i) repay principal and interest, or (ii) apply prospective crediting rate adjustments with an assurance the crediting rate will not be less than zero.
3. The terms of the investment contract require all permitted participant-initiated transactions with the Fund to occur at contract value with no conditions, limits or restrictions. Permitted participant-initiated transactions are those transactions allowed by the underlying defined-contribution plan, such as withdrawals for benefits, loans or transfers to other funds within the Plan.
4. An event that limits the ability of the Fund to transact at contract value with the Issuer (for example, premature termination of the contracts by the Fund, plant closings, Plan termination, bankruptcy, mergers and early retirement incentives) and that also limits the ability of the Fund to transact at contract value with the participants in the Fund must be probable of not occurring.
5. The Fund itself must allow participants reasonable access to their funds.

Investment contracts held in the Fund are recorded at their contract value. The Plan owns a promise to pay interest at crediting rates which are announced in advance and guaranteed for a specified period of time as outlined in the group annuity contract. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spinoffs, divestitures, layoffs, corporate relocation, partial or total Plan termination, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or withdrawal restrictions may apply. The Plan Sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.

The Issuer may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause, including the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, layoffs, Plan disqualification or failure to adopt the Plan in a reasonable period of time. Upon termination by the Issuer, a market value adjustment or withdrawal restrictions may apply. The Plan Sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected. The Plan Sponsor was not aware of any events that would have limited the Plan to transact at contract value as of December 31, 2024 and 2023 and through the date of this filing.

NOTE 10 – REGULATORY MATTERS

On December 29, 2022 the SECURE 2.0 Act of 2022 was signed into law. The legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. As permitted by the SECURE 2.0 Act, the Plan opted in to implement certain provisions. Plans could voluntarily adopt provisions by placing them in operation without amending the Plan, as long as Plan management makes the required amendments to Plan documents before the deadlines (various dates in 2025 and 2026). The Plan has not yet amended the Plan documents as of December 31, 2024 with respect to the SECURE 2.0 Act.

NOTE 11 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through the date that the financial statements were available to be issued which corresponds with the date of the independent auditors' report. No material subsequent events have occurred since December 31, 2024 that required recognition or disclosure in these financial statements, except as noted below.

On October 1, 2025, substantially all of the Companies' assets were sold to Johnstone NOLA, LLC, a Delaware LLC, an unrelated third party. Management has not made any plans as of our report date to terminate the Plan, but may consider this option in the future if it is determined to be in the best interest of the Plan participants and Company management.
