Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Allard Nazarian Group, Inc. 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Allard Nazarian Group, Inc. 401(k) Savings Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Note 1 – Description of Plan

The following description of The Allard Nazarian Group, Inc. 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

General – The Plan is a defined contribution plan covering all employees of The Allard Nazarian Group, Inc. (the “Company” or “Employer”) who have completed 60 days of eligible service, except non-resident aliens who receive no compensation from the Company which constitutes U.S. source income. The Plan is subject to the provisions of ERISA, as amended.

Notes Receivable from Participants – Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes must be fully repaid within five years, or within thirty years for the purchase of a primary residence. Interest rates on the notes are between 3.25% and 8.50%. The loans are secured by the balance in the participant’s account. Principal and interest are paid ratably through payroll deductions.

Employee Contributions – Contributions to the Plan are made by both the Company and participants. Participants may elect to defer up to 100% of their compensation, as defined in the Plan, subject to Internal Revenue Service (“IRS”) limitations. Participants may also elect to make Roth deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers one guaranteed interest account and several pooled separate accounts.

Employer Contributions – The Company contributes to the Plan on behalf of its covered employees in an amount equal to 50% of a participant’s elective contributions, not to exceed 4% of compensation. The Company may also make matching contributions in such amounts as it may determine at its sole discretion. Employer contributions are subject to certain limitations.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution, if any, and, (b) plan earnings or losses, and (c) charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, deferrals, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company’s contribution portion of their account, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after five years of credited service in their portion of the basic matching contribution and the optional profit-sharing contribution in accordance with the following schedule:

Less than two years	20%
At least two years but less than three years	40%
At least three years but less than four years	60%
At least four years but less than five years	80%
Five years or more	100%

Payment of Benefits – Benefits under the Plan are distributed to participants upon retirement, death, disability, or termination of employment in an amount equal to the value of the participant’s vested interest in his or her account or to receive a number of equal annual installment payments.

Forfeited Accounts – Forfeitures of the non-vested portion of withdrawing participants’ accounts are used to reduce future employer matching contributions and pay plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$29,109 and \$32,357, respectively.

Note 2 – Summary of Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the modified cash basis of accounting, which is the cash basis of accounting except for investments, which are adjusted to fair value (except Guaranteed Investment Contracts (“GICs”), which are at contract value), and notes receivable from participants.

Use of Estimates – The preparation of financial statements in accordance with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value (except GICs which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Investment Committee determines the Plan’s valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a cash basis. Interest income and dividends are recorded on a cash basis. Net appreciation or depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Investment contracts held by a defined contribution plan are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attribute to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowances for credit losses have been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Note 2 – Summary of Accounting Policies – Continued

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

Subsequent Events – Subsequent events were evaluated through September 17, 2025, which is the date the financial statements were available to be issued.

Note 3 – Certified Investments

Plan investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, notes receivable from participants, interest income on notes receivable from participants, and investment transactions for the years ended December 31, 2024 and 2023, were certified as complete and accurate by Empower Annuity Insurance Company of America (“Empower”). Therefore, in accordance with the request of the plan administrator and as permitted by ERISA Section 103(a)(3)(C) pursuant to Section 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure, this information was not subjected to standard auditing procedures by the independent auditors.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4 – Fair Value Measurements – Continued

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Pooled separate accounts: Separate accounts are stated at fair value based on the quoted market prices of the underlying mutual funds (level 1), or various securities such as bonds and/or foreign stock (level 2). The unit value of the separate account is calculated by dividing the total value of the assets of the separate account by the number of units in the separate account. For separate accounts that invest exclusively in mutual funds, the total value of the assets of the separate account is based on the net asset value (“NAV”), or price per share, of the underlying mutual fund. The mutual fund calculates its NAV by dividing the mutual fund’s net assets by the mutual fund’s outstanding number of shares. Other pooled separate accounts are measured based on pricing data provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities.

Note 5 – Fully Benefit Responsive Investment Contract

The Plan’s guaranteed investment contract is a fully benefit responsive investment contract with Empower. Empower maintains the contributions in a separate account used solely to satisfy the claims of the contract holder. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The guaranteed investment contract is included in the financial statements (modified cash basis) at contract value as reported to the Plan by Empower. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average credit interest rate is set quarterly. The crediting interest rate is based on an agreed-upon formula with the issuer, but could not be less than 3% at December 31, 2024 and 2023.

Certain events limit the ability of the Plan to transact at contract value with Empower. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other events (for example, divestitures, or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan’s ability to transact contract value with the plan participants have a probability of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 6 – Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by Empower. Empower is also the record keeper for the Plan, and therefore, these transactions qualify as party-in-interest transactions. Investment expenses paid by the plan are included in net appreciation in fair value of investments. Notes receivable from participants also qualify as party-in-interest transactions.

The Plan made direct payments of \$55,794 and \$52,604, to Empower for administrative expenses for the years ended December 31, 2024 and 2023, respectively. The Company pays, directly, any other fees related to the Plan's operations, which are excluded from these financial statements (modified cash basis).

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 8 – Tax Status

The IRS has determined and informed the Company by a letter dated November 14, 2022, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since the date of the determination letter, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).
