Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter

Supplemental Schedule Required by ERISA

1. Description of the Plan

The following description of the Vericast Corp. 401(k) Plan (the Plan) provides only general information. Vericast Corp. (the Company) is the plan sponsor. Participants should refer to the plan agreement for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General

The Plan is a defined-contribution plan that covers employees of the Company on the 30th day of employment with the Company. The Plan covers any employee of the Company, or a participating affiliate of the Company, who is not a leased employee under federal regulations, a nonresident alien, or a member of a collective bargaining unit for which participation in this Plan has not been agreed to by the affiliate employing the employee.

The Administration Committee is responsible for the general administration of the Plan, and the Investment Committee is responsible for oversight of the investments of the Plan. Bank of America, N.A. is the trustee, as defined by the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Employees are automatically enrolled as participants in the Plan unless the employees elect otherwise. The auto-enrollment deferral percentage for participants is 3% of compensation that is contributed to the Plan on a pretax basis. Each employee who participates in the Plan can contribute on a pretax basis, as Roth contributions, or as non-Roth after-tax contributions to the Plan through payroll deductions ranging from 1% to 75%, in 1% increments of eligible compensation, subject to Internal Revenue Code (IRC) limits. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified plans. Participants can elect to make a rollover within the Plan of eligible assets to Roth assets (known as an in-plan Roth conversion). Participants direct the investment of their contributions into various investment options offered by the Plan.

Vericast Corp. 401(k) Plan

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

The Company contributes a matching contribution on behalf of each participant of 100% of pretax, Roth, and non-Roth after-tax contributions, up to 1% of a participant's eligible compensation, and 50% of pretax, Roth, and non-Roth after-tax contributions in excess of 1%, but not in excess of 2% of a participant's eligible compensation. Additionally, the Company can make a discretionary profit-sharing contribution to the Plan. For the year ended December 31, 2024, the Company made no discretionary profit-sharing contributions to the Plan. Contributions are subject to certain limitations of the IRC.

As of July 19, 2024, the Company divested of a portion of its operations and amended the Plan to remove the divested business from its affiliates participating in the Plan. The Plan generally does not require divested participants to withdraw from the Plan. However, as a result of the divestiture, the Plan experienced an increase in benefits paid to participants and a corresponding decrease in investments at fair value due to the divested participants who elected to withdraw or roll over their account balances.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, discretionary profit-sharing contribution, if any, and allocations of plan earnings and charged for withdrawals and allocations of plan losses and applicable expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their elective contributions, Company matching contributions, discretionary profit-sharing contributions, if any, and actual earnings thereon.

Participant Loans

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 minus the highest outstanding loan balance in the last 12 months or 50% of their vested account balances. The loans are secured by the balance in the participant's account and bear interest at a rate set by the Company, which is typically the prime rate plus 1% at the time of the loan. Principal and interest are generally paid through payroll deductions. If a participant terminates employment with the Company, they may continue to make loan payments by signing

up for automated recurring payments on the Benefits OnLine website. If the loan is not repaid, it will automatically be treated as a distribution to the participant at the end of the calendar quarter following the calendar quarter in which the payment was missed.

Payment of Benefits

The account of a participant who has died, become totally and permanently disabled, retired, or has terminated employment will be paid to the participant, or in the case of death, to the participant's beneficiary in a lump sum or in installment payments, as elected by the participant or participant's beneficiary, unless the vested account balance is less than \$1,000, in which case a lump-sum payment will be made. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS), and a participant must exhaust all available distributions prior to requesting a hardship withdrawal. Qualified birth or adoption distributions are allowed by participants as defined by the Plan.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided in the plan agreement. Administrative expenses paid by the Plan include, but are not limited to, recordkeeping, trustee, and related legal fees. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. Fees not paid by the Plan are paid by the Company and are excluded from these financial statements.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates that affect the amounts reported in the financial statements, accompanying notes, and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Shares of registered investment companies (mutual funds) are reported at fair value based on the quoted market price per share of the fund on the last business day of the year. Shares held in common/collective trust funds are reported at fair value based on the net asset value (NAV) per share, as a practical expedient, reported by the fund manager.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as investments held during the year.

2. Summary of Significant Accounting Policies (continued)

Subsequent Events

The Plan has evaluated subsequent events through June 27, 2025, the date the accompanying financial statements were available to be issued.

The Company amended the Plan effective on the first payroll period beginning on or after March 30, 2025, to implement matching contributions equal to 100% of pre-tax, Roth, and non-Roth after-tax contributions to the extent that they do not exceed 3% of a participant's eligible compensation. Except as noted, there were no other subsequent events requiring recognition or disclosure in the accompanying financial statements.

3. Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments at fair value, and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Bank of America, N.A., the trustee of the Plan.

4. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below.

- Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets or liabilities.
- Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable, either directly or indirectly, for substantially the full term of the asset or liability. Level 2 inputs include the following:
 - Quoted prices for similar assets and liabilities in active markets

- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs, other than quoted prices, that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data, by correlation or other means

No Level 2 assets are held by the Plan

- Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk). No Level 3 assets are held by the Plan.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level of input that is significant to the fair value measurement in its entirety. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Includes target-date retirement trust funds that invest in underlying diversified portfolios representing various asset classes and sectors. Each trust's allocation between stocks and bonds will change over time in relation to its target retirement date, becoming more conservative as the target date approaches. Redemptions require no notice for withdrawal of assets from the fund.

Includes collective trusts that invest in a variety of asset types, including large, mid, and small cap U.S. equities, treasury inflation-protected securities (TIPS), global real estate investments, and/or international equities. Generally, the investments maintain price and yield performance in line with market indices and, in some cases, emphasize quality companies with low-risk premiums. Redemptions generally do not require notice, except for larger transactions (i.e., greater than \$1 million) with a maximum five-day advance notice, and may be limited at the discretion of the Trustee.

5. Related-Party and Party-in-Interest Transactions

The Plan has a number of service providers that are parties in interest under ERISA; however, they are exempt from the prohibited transaction rules under ERISA. Additionally, Vanguard Fiduciary Trust Company, Great Gray Trust, N.A., Principal Global Investors Trust Company, and SEI Trust Company separately manage certain plan investments that are shares of common/collective trust funds. Therefore, these investments qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA. Fees for these investment and management services are reflected as a reduction of investment return for such investment.

6. Tax Status

The Plan has received a determination letter from the IRS dated January 18, 2018, stating that the Plan is qualified under Section 401(a) of the IRC; therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. Subsequent to this determination by the IRS, the Plan was amended and restated. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan, as amended and restated, is qualified and the related trust is tax-exempt.

U.S. GAAP requires the Plan's management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.
