## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of HC Services LLC 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of HC Services LLC 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of HC Services LLC 401(K) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. ### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about HC Services LLC 401(K) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1: DESCRIPTION OF THE PLAN

General

The HI-Crush Service LLC 401(k) Plan (the "Plan"), as amended and restated January 1, 2022, was adopted effective April 10, 2015 as a defined contribution plan covering all of the eligible employees of HI-Crush Service LLC. The Plan is a qualified plan as defined by Section 401(a) of the Internal Revenue Code and contains a provision for salary reduction contributions under Section 401(k) of the Internal Revenue Code. The Plan is also subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The following description provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Effective July 1, 2024, the plan sponsor changed their name from HI-Crush Service, LLC to HC Services LLC (the "Company", or "Plan Sponsor") and the plan name from Hi-Crush Service, LLC 401(k) Plan to HC Services LLC 401(k) Plan.

Eligibility

Employees who have reached the age of 18 are eligible to participate in the Plan. There are no minimum service requirements. Upon eligibility, employees are automatically enrolled into the plan at two percent on the first day of each quarter. Entry dates are January 1, April 1, July 1, and October 1.

Contributions

The Company automatically enrolls eligible participants into the plan at a pre-tax deferral contribution of 2% of the participant's eligible compensation if the employee does not specifically elect an alternative deferral amount which includes opting out. Employees may elect to contribute up to 80% of their eligible compensation to the Plan and may direct their contributions to various investment alternatives. Contributions for employees are limited in any calendar year to an amount which is adjusted annually by the Internal Revenue Service. For 2024, the maximum contribution allowed for any employee was \$23,000. Additionally, participants who attain age 50 during the plan year may make "catch up" contributions of up to \$7,500 for 2024. Participants may also contribute amounts representing distributions transferred from other qualified plans.

The Plan Sponsor matches 100% of the first 2% employee contributions and 50% of employee contributions between 2% to 6%, creating a maximum 4% employer match.

The Company, at the discretion of its Board of Directors, may also make a profit-sharing contribution to the Plan during the year. No discretionary contributions were made by the Company for the year ended December 31, 2024.

Notes Receivable from Participants

In accordance with the Plan document, participants may borrow the vested balance of their account, subject to a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable bear interest at reasonable interest rates and are secured by the participant's vested account balance. Participants may not have more than one loan outstanding at a time.

Forfeitures

Forfeitures of terminated, nonvested participant accounts may first be used to pay plan expenses, then may be used to reduce current or future Company discretionary contributions or reallocated to participant accounts as an additional Company contribution. At December 31, 2024 and 2023, the Plan retained \$56,884 and \$79,677, respectively, in forfeitures. In 2024, employer contributions were reduced by \$82,476 from forfeited nonvested accounts.

Participant Accounts

Each participant's account is credited with the participant's contribution and (a) the Company's contribution and (b) investment gain(loss), net of expenses. Income for each of the investment directives is allocated to the participant's accounts on a daily basis and is based on the relative units of participation. Benefits paid to participants under the Plan are limited to the vested balance in each participant's account.

Vesting and Payment of Benefits

All participant contributions vest immediately. Company contributions vest according to the following schedule:

Years of Service	Percentage Vested
Less than 1	0%
1 but less than 2	25%
2 but less than 3	50%
3 but less than 4	75%
4 or more	100%

The normal retirement age under the Plan is 65, however, benefits may be distributed during employment under hardship provisions. Additionally, participants who have attained the age of 59 ½ may receive distributions during employment. If death or disability occurs during employment, an employee's entire account becomes fully vested. Participants generally receive distributions in a lump sum. Installments are required for employees over 70 ½ to meet the minimum distribution requirements of Internal Revenue Code regulations. Separating participants may elect to rollover their account into another plan, as permitted by Internal Revenue Service regulations.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Preparation

The accompanying financial statements of the Plan are presented in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported changes in net assets during the reporting period. Actual results could differ from those estimates.

Investments

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, all investment information disclosed in the accompanying financial statements and supplementary schedules, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income for the year ended December 31, 2024 were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Lincoln Financial Group Trust Company, Inc. ("LFG"), the custodian of the Plan.

Investments are reported at fair value with the exception of the fully benefit responsive investment contract, which is at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade date basis.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued and unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative fees when incurred. As of December 31, 2024 and December 31, 2023, no allowance was considered necessary by management. Delinquent notes receivable from participants are reclassified as benefit payments based upon the terms of the Plan document.

Administrative fees

Certain expenses of maintaining the Plan are paid directly by the Company and are therefore excluded from these financial statements. Fees related to notes receivable, withdrawals, and certain investment transaction fees are charged directly to the participant's account and are included in administrative fees. Other investment related expenses are included in net appreciation/depreciation in fair value of investments.

Benefit Payments

Benefits are recorded when paid.

NOTE 3: INCOME TAX STATUS

The Internal Revenue Service (“IRS”) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

NOTE 4: PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, each participant's account balance becomes 100% vested.

NOTE 5: RISKS AND UNCERTAINTIES

Plan participants make choices regarding their investments and are exposed to risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that reduction in value can occur in the near term and that such changes could materially affect participant account balances reported in the statement of net assets available for benefits.

NOTE 6: ADMINISTRATION AND INVESTMENTS

Administration

The Plan has entered into a trustee arrangement with LFG. Among other duties, LFG receives contributions, invests and reinvests the Plan’s assets, collects income and makes distributions from the Plan’s assets as directed by the Administrative Committee for the Plan. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The Plan does not compensate the Plan Sponsor for its internal costs related to the administration of the Plan.

As permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, LFG certified that the accompanying investment balances as of December 31, 2024 and 2023 and income information for the year ended December 31, 2024 was complete and accurate. Accordingly, the Plan’s independent auditors did not perform any procedures with respect to this information, except comparing and reconciling such information to the financial statements.

NOTE 6: ADMINISTRATION AND INVESTMENTS (*Continued*)

Investments

The Lincoln Stable Value Account - LNTPA ("Stable Value Fund") is included in these statements at contract value, which represents contributions plus applicable investment earnings. The Stable Value Fund provides for a minimum guaranteed interest rate which is declared periodically and may incur surrender charges and market adjustments in the event of withdrawal. The Stable Value Fund yield at the years ended December 31, 2024 and 2023 was approximately 3.00%, respectively.

NOTE 7: FAIR VALUE MEASUREMENTS

ASC 820-10 provides standards and disclosures for assets and liabilities that are measured and reported at fair value. As defined in ASC 820-10, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). ASC 820-10 requires disclosure that establishes a framework for measuring fair value and expands disclosure about fair value measurements. The statement requires fair value measurements be classified and disclosed in one of the following categories:

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities. An active market for the asset or liability is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

Level 2: Measured based upon inputs that are observable, either directly or indirectly, for the asset or liability other than quoted market prices included in Level 1. These inputs include: a) quoted prices for similar asset or liabilities in active markets b) quoted prices for identical or similar assets or liabilities in markets that are not active c) inputs other than quoted market prices that are observable and d) inputs that are derived primarily from or corroborated by observable market data by correlation or other means.

Level 3: Measured based on unobservable inputs for the asset or liability for which there is little, if any, market activity for the asset or liability at the measurement date. This input includes management's own assumptions about the assumptions that market participants would use in pricing the asset or liability. The inputs are developed based on the best information available in the circumstances, which might include management's own data.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the net asset value (NAV) of shares held by the Plan at year end.

As required by ASC 820-10, financial assets and liabilities are classified based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of the fair value of assets and liabilities and their placement within the fair value hierarchy levels.

NOTE 8: RELATED PARTY TRANSACTIONS

The Plan invests in mutual funds that are managed by LFG, who is also the custodian for the Plan. During the year ended December 31, 2024, the Plan paid LFG \$96,579, in administration fees that are included in administrative expenses. The Plan believes the fees charged by LFG mutual funds and its administrative fees are no different than those that would be charged by other companies engaged in managing pension assets.

NOTE 9: GUARANTEED INVESTMENT CONTRACT

The Plan is invested in a fully benefit-responsive guaranteed investment contract with LFG. LFG maintains the contributions in a general account which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by LFG, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$230,687 and \$334,689, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than three percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

NOTE 10: INCOME TAXES

The Plan did not have any unrecognized tax benefits as of December 31, 2024 and 2023, and expects no significant change over the next 12 months. The Plan will recognize interest and penalties accrued on any unrecognized tax benefits as a component of income tax expense. As of December 31, 2024 and 2023, the Plan has not accrued interest or penalties related to uncertain tax positions.

NOTE 11: SUBSEQUENT EVENTS

Subsequent events were evaluated by management through the date the financial statements were available to be issued.

On August 11, 2025, Iron Oak Energy Solutions LLC acquired the Northern White assets of HC Minerals, Inc. HC Minerals, Inc. ("HC Minerals") spun out from Hi-Crush Inc. in March 2024 in conjunction with Hi-Crush's sale to Atlas Energy Solutions. Due to the acquisition, the plan sponsor and plan itself will fall under Iron Oak Energy Solutions at the start of the company's new plan year beginning January 1, 2026. The Plan noted no additional significant subsequent events.
